

Official Notice of Zor 2014 Annual Meeting and Election of Officers

The official Notice of Zor's 2014 Annual Meeting and Election of Officers Zor Temple's Annual Meeting and election will be held Saturday, January 11, 2014 at the Zor Shriners Center in Madison. A total of 7 Zor officials will be elected and six members of the Appointive Divan named to posts during the election and post-election meeting and installation ceremony. This is the official notice required by Imperial Council:

Election and Installation at Zor Temple on January 11, 2014

Notice is hereby given that the Annual Meeting for Zor Shrine will be held at the Zor Center on Saturday, January 11, 2014, beginning at 1 p.m. at which time annual reports will be presented, officers and representatives elected for the coming year, and such other business transacted as may properly come before the meeting.

ARTICLE 25, Section 325.4 to 325.6 of the Imperial Code reads as follows:

Each Temple must elect its officers and representatives by separate written ballot and by a majority vote of those present and voting. A blanket ballot is prohibited. Said election shall take place at the Temple's annual meeting in January of each year. Nominations must commence not later than 9 p.m. for an evening meeting or 3 p.m. for an afternoon meeting of the day on which the election is held, and when

that hour arrives, all other business must immediately cease and not may be transacted until the election is concluded.

ARTICLE 25, Section 325.10(a) The printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets or other devices, by a Noble suggesting, recommending, opposing or containing the names of proposed candidates for office in the Temple, is prohibited (b) for any violation of section (a), the Imperial Potentate may suspend any offending Noble and he may declare the election of said officers void and order a new election

AWARD OF MERIT RULES

This award is presented for dedicated and exemplary voluntary service to Zor Shriners and to the Shriner's philanthropy, the Shriners Hospitals for Children®, over a minimum of five years

Recognition for outstanding service to Shrine Clubs or Units solely shall be the responsibility of those bodies and the nominee shall not be eligible for the Award of Merit recognition as they do not meet the guidelines.

The Award shall preferably be presented to Nobles not otherwise recognized as

serving on the Divan or by appointment to prominent positions. No member of the Zor Divan or past member of the Divan will be eligible for consideration until at least five years following his being on the Divan. Then only for Voluntary Service that is within Zor's sphere of influence.

To nominate your candidate, please provide a nomination letter describing why you feel this Noble is deserving of this award, i.e., what activities he has participated in, what offices has he held with the club/unit, how has he contributed to the shrine philanthropy,

how has he been involved with helping children, etc. Your nomination letter should be forwarded to the Zor Shriners office **NO LATER** THAN Saturday, November 1, 2013.

SEPTEMBER 14 - MILLADORE, WI Jim Stelsel, Sr, Recorder

Potentate B. Gorsuch called the meeting to order at 11:00 A. M. with 21 Nobles present.

K. Gant gave the opening prayer and all present joined in the Pledge of Allegiance.

Potentate B. Gorsuch asked for a motion to approve the minutes of the Quarterly Meeting of April 27, 2013 as printed in the Zephyr. W. Trouten moved approval of the minutes and seconded by G. Cuskey. Motion Carried.

<u>**Treasurers Report:**</u> D. Olson, Treasurer, read the abbreviated financial report as of August 31, 2013 that shows Total Revenues YTD \$296,651, Total Expenses \$235,372 for a net gain of \$61,279, with unrealized gain of \$51,567. Net Operational income less Depr. Net Operational income less Depr. \$112,846 less Depreciation of (\$41,195), for a net surplus of \$71,651. Month end Cash Balances: Checking Accounts \$105,196, Membership \$36,313, less bills to be paid in 30 days \$8,722. Cash Reserves: Hospital Patient Transportation Account \$176,384, HTF Tampa \$250,285, Improvement Building Accounts \$442,160, Long Term Investment Accounts \$1,005,371 and Perpetual Membership \$30,521. L. Hanson moved the report be accepted and seconded by B. Giesler. Motion Carried.

Membership Report: B. Calverley reported that as of September 11, 2013 our total membership is 1613 members, which includes 14 associates. We have 95 Nobles who have not paid their 2013 dues.

Departed Nobles: J. Stelsel, Recorder, read the names of 11 departed Nobles that were reported in the third quarter. K. Gant gave a prayer for the departed Nobles.

R Twin Cities Hospital Report: Rommel submitted a written report that stated Zor would be hosting a screening clinic in Eau Claire on October 5, 2013. Chairman Maxwell with the Imperial Executive Team visited TCH on September 7th to review the Hospitals Strategic Plan, discuss goals objectives, targets and timelines and to initiate formulation of a plan to integrate these into the hospitals plan. As of mid-August 19, e-consults have taken place as well as several "Ask Mayo Expert" Services. Dr. Peter Diaz has been named as out hospital liaison for the coming year replacing Gary Dunwoody. Our operating budget is aimed to be \$15,326,000 in 2104, which is unchanged form 2013 or 2012. Dr. Michael Bensimon continues to work on his testing of visa application process and is expected to begin employment in October.

<u>Variety Shows:</u> S. Peterson PP reported the third year of Variety/Magic Shows was a success for both Zor Shriners and the 13 Clubs & Units that sponsored the shows in 15 communities. The net profit for the Clubs & Units was \$11,635.50 and the net profit for Zor was \$16,283.18 for a grand total income was \$27,918.68. This is the second largest fundraiser for Zor. G. Cuskey moved acceptance of the report and seconded by W. Trouten. Motion Carried.

Communication from the Grand Master: Potentate B. Gorsuch read a communication dated July 29, 2013 from Daniel L. Slavik, Grand Master of Masons in Wisconsin addressed to all Constituent Wisconsin Lodges, Tripoli Shrine, Zor Shrine and Beja Shrine to be read at their next Stated Communication. RE: Grand Lodge of Arkansas and Shriners International.

The Grand Lodge of Wisconsin has had and continues to have a positive and constructive relationship with the three Shrine Temples in the state and those nearby that accept Wisconsin Masons as members. We realize that by working together, we can strengthen both organizations and promote an image that is attractive to the public. Every Wisconsin Shriner is first a Master Mason. In order to stay within due bounds

with the Wisconsin Masonic Code and Shriners International Law, the following rules must be observed.

* No Arkansas Shriner can sit in a Tiled Shrine Meeting unless he holds a valid dues card from a Grand Lodge recognized by the Wisconsin Grand Lodge other than Arkansas.

No Arkansas Shriner can sit in a Titled Wisconsin Masonic Lodge meeting unless he holds a valid dues card from a Grand Lodge recognized be the Wisconsin Grand Lodge Other than Arkansas. * No Arkansas Mason can sit in a Tiled

Shrine meeting in the state of Wisconsin.

* As a sojourner in the state of Arkansas, Wisconsin Masons are bound by the decisions of the Grand Master of Arkansas, and thereby, are not allowed to sit in a Tiled Shrine meeting in the state of Arkansas.

I urge caution when attending any type of Masonic meeting in Arkansas.

We look forward to continuing our good relationship between the Grand Lodge of Wisconsin and Shriners International.

Shrine/Masonic Golf Outing: B. Gorsuch reported the profit from the outing was split between the Madison Children's Dyslexia Center and Zor's Patient Transportation Fund, each receiving \$709.00.

Update on Alaska Trip: Potentate B. Gorsuch reported the trip was great with 150 attending from 7 Midwest Shrines with 34 attending from Zor.

K. Gant gave the closing prayer and the meeting was adjourned at 11:30 A. M.

Welcome Here – A Patient's Story

Emily (age 15) has been a patient for over 2 years and has had one surgery at Shriners Hospitals for Children - Twin Cities. After being told by her local physician that there was nothing that could be done for the 60° curve in her spine caused by scoliosis, her mother decided to seek out a second opinion. She started searching the internet for a hospital that treats children with scoliosis and Shriners Hospitals for Children came up. This triggered her memory that her grandmother was treated at the Twin Cities Hospital shortly after it opened in 1923. In addition to this connection, the Twin Cities Hospital was holding a new patient screening in Rapid City, South Dakota 2 days later.

All signs pointed to Shriners Hospitals for Children being the right fit for their family, even with the hospital being a 10 hour drive each way. In June of 2012, Emily had surgery to correct her scoliosis and she is happy to report that the curvature of her spine is now down to 22° . The following is a poem that Emily wrote to help fellow patients when they are anxious about surgery:




