



QUARTERLY MEETING MINUTES JULY 10 - MADISON

Potentate L. Riemenschneider called the meeting to order at 4:25 P. M. with 25 Nobles present.

K. Gant gave the opening prayer. Potentate L. Riemenschneider asked for a motion to approve the minutes of the Quarterly meeting of April 28, 2012 as printed in the Zephyr. T. Nelson PP. moved approval of the minutes and seconded by M. Severson PP. Motion Carried.

Treasurers Report: D. Anderson read the abbreviated financial report as of June 30, 2012 that shows Total Revenues YTD \$250,884, Total Expenses \$168,065 for a gain of \$82,819, with unrealized Wells Fargo gain of \$31,161. Net Operational income less Depreciation \$113,980 less Depreciation of (\$30,896), ATC Payment \$392,799 leaving net surplus of \$475,883. As of June 30, 2012 end of the month balances show Checking Accounts \$122,058, Membership Account \$39,694, less bills to be paid in 30, days \$9,943. Cash Reserves, Hospital Patient Transportation Account \$156,087, Hospital Transportation Account Tampa \$224,137, Building Improvement Account \$464,709, Long Term Investment Accounts \$931,980 and Perpetual Membership \$26,118. D. Anderson moved the report be accepted and seconded by M. Severson PP. Motion Carried.

Membership Report: B. Calverley reported as of June 30, 2012 in the month of June we had 17 Creations and 1 Death for a net gain of 16 members leaving our total member ship at 1715 members. B. Calverley moved the report be accepted and seconded by T. Nelson PP. Motion Carried.

Departed Nobles: J. Stelsel, Recorder, read the names of 8 of our departed Nobles that were reported in the second quarter. K. Gant gave a prayer for the departed Nobles.

Circus Report: M. Severson PP. Moved permission to hold the 59th annual Madison Circus, February 15 to 17, 2013 at the Alliant Energy Center and Telemarketing by Bob Sands Promotions starting August 20, 2012 and seconded by T. Nelson PP. Motion Carried.

Trustees Report: T. Schmidt, Chairman of the Trustees, reported the men's bathroom damage has been competed by Findorff. They issued a \$2,500 credit from the total bill. A new floor and vanity were installed. The next major project will be the front lobby update and a communication system.

Chicago Hospital Report: G. P. Wiemer reported on the Imperials new Love to the Rescue ad campaign for donations to the hospitals are appearing on the major networks during prime tine at a total cost of \$970,000. During the first month of this campaign \$500,000 has been received in donations.

Twin Cities Hospital Report: Riemenschneider read the Twin Cities Hospital report for R. Rommel member of the TCH board. Dr. Guidera TCH Chief of Staff has been appointed as Chief Medical Officer for the Shrine Hospital System. Since April 2012 a number of specialists coming from Mayo has increased from 3 to 8 physicians, representing our largest single service relationship for the TCH. Mayo is also beginning to provide needed services to SHC patients in Rochester. The Loved to Rescue Kickoff is a promotional campaign has begun on various cable networks. Camp Splash took place the week of June 11 for 25 SHC patients with the Foss Swim Academy. Camp Achieve for limb deficient patients ages 5-8 was held in June with the Zuhrah Horsemen providing riding lessons as part of this year's camp. Wireless Services are provided to enable public WI-FI services inside the hospital building. Medicaid Provider Status from South Dakota has been approved and is now certified in all states except North Dakota. Patients, 48 applications and 48 approved in May. YTD 287 applications approved compared to 274 last year. Surgeries performed through April are 289 compared to 285 last year.

Variety Shows: S. Peterson PP. reported the 14 Variety Shows netted \$31,213.80 with Zor receiving \$19,026.30 and the Clubs \$12,187.50. S. Peterson PP. moved the report be accepted and seconded by T. Nelson PP. Motion Carried.

Wisconsin Shrine Bowl: L. Riemenschneider read a report received from Dennis Korth WSB, Inc, President from its June 26, 2012 board meeting which voted to disband and forward the remaining fund approximately \$9,850.00 to the three Shriners Hospitals for Children our temples support, Chicago, Twin Cities and Cincinnati. This closes down 29 year tradition that the Nobles from Zor, Tripoli and Beja Shriners spent long hours working on and for our Philanthropy.

OLD BUSINESS:

MSA Information: L. Hanson reported the bus will be going to

NEW BUSINESS:

Imperial Session Report: M. Steiber reported there were 22 items on the call of which some were tabled, withdrawn, passed or failed. Call # 3 Passed. The per capita tax for the current year will be neither collected from candidates initiated in November or December or remitted to the Imperial Treasurer. Call #11 Passed. No dues will be collected from candidates initiated in November or December for the current year. Call #12 Passed. A hospital levy will be neither collected from candidates initiated in November or December for the then current year or remitted to the Imperial Treasurer, Call #14 Passed. Members of the immediate family of the Noble may be passengers only in vehicles with 4 wheels and non-performing will be permitted to participate in civic exhibitions, including parades, with the approval of the Potentate. Call #18 Passed. A charter was granted to Agila Shriners in the Philippines the 195th Temple. Call #22 Passed. The acceptance of patients to Shriners Hospitals for Children would be based on the

individual merits of the medical condition of the patient as provided in the Hospital Regulations rather than the patients being admitted based upon the merits of the application and the order in which the application was filed. In section 509.3, the legislation makes it clear that the Noble is sponsoring a patient, not an application. Elections of Officers are as follows: Jim McConnell was elected Imperial Treasurer, Bill Bailey was elected Imperial Outer Guard, Doug Maxwell was reelected as Chairman of the Board of Trustees, & Brent Bede was reelected to the Board of Trustees. The Imperial Membership Training Seminar in Tampa will be October 11 -14, 2012.

Announcements: L. Riemenschneider presented an 80 year certificate of appreciation to the members of the Madison Shrine Club.

The Wild West Days on August 25th at Roger Amdall's has been cancelled due to ill health.

The October Fest at Chuck Miller's in Milladore will be changed to the August 25th from the September 29th date.

The meeting was adjourned at 4:55 P. M.

During the 2012 Imperial Session, held in Charlotte, N.C., July 1-5, Alan W. Madsen of Cornelius, N.C., was elected imperial Potentate of Shriners International, making him the highest-ranking Shriner in the world. In this role, he serves as President of the Board of Directors for Shriners International and Chairman of the Board of Directors for Shriners Hospitals for Children®.

After graduating from Central Michigan University in Mount Pleasant, Mich., where he received a bachelor's degree in business with a minor in psychology and journalism, he worked for Cummins Engine Company in Fostoria, Ohio, Mobile Oil Corporation in Cleveland, Ohio and Midrex Corporation in Charlotte, N.C.

In 1975, he and his wife, Jan, established Corporate Personnel Consultants, Inc., in Charlotte. They owned the company until selling the firm in 1998 to the Personnel Group of America (PGA), at which time they both took an early retirement.

Raised a Master Mason in Excelsior Lodge #261 in Charlotte, N.C., Madsen is also a member of the Charlotte York Rite and Scottish Rite bodies. He joined Oasis Shriners in 1981, was appointed to the Oasis Divan in 1992, and served as the Potentate in 2000. Madsen is a member of the Oasis Marching Patrol, the Royal Order of Jesters

and the Order of Quetzalcoatl. He also has served as Captain of the Patrol Color Guard, Chairman of the Paper and Plaque Sales Project, Editor of "Desert Dust," Chairman of the Publicity Committee for the Oasis Centennial, and Chairman of Advertising and Promotions for the Oasis Shrine Circus. In 2007 he became the Past Director of the Royal Order of Jesters Court #109 in Charlotte.

A Certified Personnel Consultant, Madsen serves on the Advisory Board for Branch Bank & Trust Corporation, and is a former member of the Development Board at Central Michigan University. He served for three years on the Grand Lodge of North Carolina's Committee for Finance. Madsen is a former member of the Advisory Boards of United Carolina Bank and the Charlotte Chamber of Commerce, and he has been a member of several professional and civic organizations.

He currently serves as Chairman of the Revenue Cycle Committee for Third Party Pay, and also serves on the Research, East-West Shrine Game, Investments, Information Services, and Special Projects/Fund Raising Committees. In addition, he has served as the Liaison to Shriners Hospitals for Children at Salt Lake City, Portland, Lexington, Tampa and Shreveport.

Madsen has also served on the Budget, Planning, Salary Personnel & Retirement, and Strategic Planning for Shriners Hospitals for Children, Insurance and Information Services Committees. He has served as the Chairman of Educational Seminars, Fraternal Strategic Planning, Salaried Personnel and Retirement, and the Shrine Futures Study (2005-2006).

Madsen has been very active in his church, serving on the church council and building committee. He is a certified open-water diver and life-member of Alpha Kappa Psi, a national business fraternity.

The Potentate gets the last word: "Great game. Beautiful field. Glad to be here. It was great throwing out the first pitch."






