With a new year comes a new Potentate and new members of the Divan. We'll introduce the new guys but first let's meet the next Zor Shrine Potentate for the ensuing year: Steve Peterson. Steve is a native of Wisconsin and is originally from Viroqua in the La Crosse area. He went to college at UW-Stout, which is where he met his Lady, Mary Ellen. After college, he enlisted in the Air Force and was stationed at Whitman Air Base in Missouri. Following Air Force service, Steve worked for Wickes Lumber as a retail store manager (1976-1981) and Hoffer Glass Co. in Green Bay where he serviced outside commercial sale accounts, estimated commercial cost for glass projects, and managed installation crew for glass products (1981-1984). for the Wesley United Methodist Church in 1993, 1996, and 2003 and has been a youth leader for more than 20 years with the United Methodist Church in Green Bay and Wausau, heading work camps in Milwaukee, Chicago, and Jamaica.

Since 1996, Steve has been active in Mosinee Lodge #318 and the Scottish Rite Bodies in the Valley of Eau Claire. He joined Zor Shrine in 1999 and the Wausau Indians the next year. Steve was President of Wausau Indians from 2004 to 2010 and is also active in the Timber Shine Club. He also joined the Wausau Elks Lodge and the American Legion Post in 2001.

Steve is blessed to be Grand Pa to two girls - Isabella (3 yrs old) and Eva (5 months old) by his daughter Nicole and son-in-law T.J. Rice that live in Eagan, MN. His son Joshua and wife live in Seattle, Washington, which Steve and Mary Ellen have found is a great place to visit.

## ZOR SHRINERS ANNUAL MEETING

JANUARY 15, 2011 • MADISON WI

Potentate J. Thompson called the meeting to order at 1:10 P. M.

Zor Shriners Annual Meeting was opened in full form by the Divan presenting the Salaam for the Potentate. 65 Nobles were in attendance. Chaplain K. Gant gave the opening prayer. All members joined in the Pledge of Allegiance to the Flag.

Potentate J. Thompson welcomed all present and stated we will proceed to cover the full agenda.

A Candle Lighting Memorial Service was conducted for those Nobles lost to the Black Camel in the Fourth Quarter of 2010. Recorder J. Stelsel read the names of 36 Zor Nobles and Past Imperial Potentate F.T. "Hogan" H'Doubler Jr. M. D. Chaplain K. Gant offered a prayer for

the departed Nobles.

Potentate J. Thompson asked for a motion for approval of the minutes of the last Annual Meeting, January 10, 2010, as printed in the Zephyr. A motion was made by B. Gorsuch for approval and to dispense with the reading of the minutes and seconded by M. Severson PP. Motion Carried.

The following Committee Reports were presented:

**Circuses:** J. Thorstad PP. reported the 56th annual Madison Circus was held on Feb. 19 -21 and had a net profit of \$145,000 which was \$15,000 over budget. Total attendance for the 6 shows was 32,224. Participation included 13 clubs and units as well as the Divan, Past Potentates and Ladies. Program Sales increased by 10% because of the

additional prizes that were given away at each show which included 3 bicycles, Red Lobster gift card and a Mallards Baseball family pass. Newly added was a \$50 savings bond for the coloring contest and a free 2011 family pass for the drawing from the Questionnaires. The La Crosse Circus was held at the Convention Center on March 2 & 3 for 3 shows. Total attendance was 7300 and Zor's profit was \$3,500. Summer Circuses, 10 out of 12 circuses not including Eau Claire or Menomonie received a flat guarantee of \$7,500 plus 20% on concessions. The total payout of \$26,647 to the clubs and units. Zor received \$4,987 from Eau Claire. Contract for the Alliant Energy Center has been extended to 2020, Robert Sands promotions contract is for 3 years. George Carden contract for

Madison and La Crosse are for 4 years and Eau Claire and Menominee are for 3 years. J. Thorstad moved the report be accepted and seconded by R. Amdall PP. Motion Carried.

**Trustees Report:** D. Jones PP. Chairman of the Trustees reported the 9 Trustees have 3 major areas of responsibility. 1. The investment of Temple surplus funds. 2. Oversee the maintenance and upkeep of the building, building equipment, grounds, furniture & fixtures, except office equipment. 3. Oversee usage of the Shrine Center and supporting services.

**INVESTMENTS:** As of December 31, 2010 the Temple had a total of \$993,809 in Surplus Restricted and Unrestricted Funds. This compares to \$1,006,552 on December 31, 2009. This excludes the Hospital Transportation Funds and current operation funds. Temple by-laws allow funds to be invested in a variety of investment vehicles. They require that the greater of \$400,000 or 50% of unrestricted funds be invested in CD's and the balance could be invested in Mutual funds having an investment ratio of no more than 60% in balance 60/40 mutual funds and up to 40% in all equity mutual funds. The investment of these funds in 2010 are in compliance with the By-Laws. At year end we had \$502,000 invested in CD's compared to \$563,000 at the end of 2009. We cashed in \$61,000 to pay for a portion of the new parking lot which are unrestricted funds. The CD's that came due in 2010 were reinvested yielding 1 to 2%. We have 3 CD's that are coming due in 2011 that are yielding 3.00 To 4.94%. Our philosophy on CD's are for short terms hoping rates will improve.

At the beginning of 2010 Zor's mutual fund account managed by Wells Fargo had a balance of \$443,000. As of December 31, 2010 the fund had a balance of \$490,000 for a gain of \$47,000 which is about 10.6% increase for 2010.



**MAINTENANCE & UP KEEP:**

In 2010 capital improvement budget included 3 major items, replacement of the parking lot, adding the cooling controls to the computerized HVAC system and refurbishing Hankwitz Hall with painting, new bar top and window blinds. We did a temporary fix to the roof in 2009 to avoid a major expense in 2010, however we are budgeting 2011 funds to replace the roof in 2011 if replacement if necessary. Operating expenses incurred in 2010 for utilities, equipment and building maintenance & repair, lawn care and snow removal, insurance & licenses were about \$64,000. We had budgeted about \$74,000 for these expenses.

**FACILITY USAGE:** During 2010 the Shrine Center was rented out 36 times when a rental fee was charged. This does not include other Shrine meetings, practices, steak fry's on other Zor events. Total rental fees were \$8,880 up from \$7,300 in 2009. Queen Anne's Catering is the exclusive cater. Their 3 year contract extends through 2013. During 2010 they served 3,250 meals totaling \$44,200. In 2009 they served 2,900 meals totaling \$38,600. Zor receives 20% commission on all food sales for a total of \$8,850. Zor holds the liquor license and hires Queen Anne's to operate the bar. Gross bar sales in 2010 was \$25,150 compared to \$22,800 in 2009. After deducting all costs the bar income was \$11,000 which is about a 44% margin. The total rental fees, food & bar net income for 2010 was \$28,780 compared to \$26,473 for 2009.

**INTRODUCTION:** The Board of Trustees was thanked for their time and expertise. Those present were introduced. G. Jordon has resigned whose term expires in 2012 and D. Forkner, GP Wiemer and R. Winter terms will expire today. T.



Schmidt was elected as Chairman for 2011. T. Schmidt was then called to the podium who asked all members to pass on information that our facility is available for rental. D. Jones PP. moved the report be accepted and seconded by M. Severson PP. Motion Carried.

**Membership Report:** B. Calverley, Membership Chairman, reported as of December 31, 2009 we had 1873 members. In 2010 we had 46 Creations, 6 Affiliations, 17 Restorations, 18 Demits, 3 Associates dropped, 81 Deaths, and 61 Suspensions for a net loss of 94 Nobles. Total membership as of December 31, 2010 is 1779 members. B. Calverley moved the report be accepted and seconded by J. Thorstad PP. Motion Carried.

**Treasurers Annual Financial Report:** Treasurer D. Anderson reported as of December 31, 2010 YTD Total Revenues \$423,794 and Total Expenses \$399,044 for a Net Gain of \$24,750. D.

Anderson moved the report be accepted and seconded by M. Severson PP. Motion Carried.

**Chicago Hospital Report:** E. Buehler PP. Member Chicago Hospital Board of Governors reported Chicago continues to provide life changing services to children with an amazing staff and great volunteers. Challenges this year: the Chief of Staff resigned in October and was replaced by Dr. Jeffery Askwan, surgeon on the Chicago Staff. Administrator resigned in November and we are currently recruiting to fill this position. Both persons were there over 5 years and both left to advance their careers. The budget has been cut for another year and Tampa continues to try to match income and expenses. For 2011 budgeted income \$568 million, operating expenses \$754 Million. Deficit: \$186 million. The big question being asked is can we continue to operate with 22 Hospitals in the present form. The good news is new revenue sources from insurance and government has raised questions about how we treat our

patients and family. Shriners Hospitals has now received a Favorable Opinion from the Office of Inspector General... for any child we serve, that is covered by Government Health care programs. We can continue our historic practice of not seeking or accepting payment from families. In addition we received OIG approval of the Shriners Hospitals practiced of providing transportation of our Needy Children to the hospitals and continue to provide parents guest rooms at the hospitals. We are seeing more info from Imperial on the Funsters Trailer Program. This is great for fundraising and great PR. I have been elected Treasurer of the Board and appreciate the opportunity to serve our patients and represent Zor. E. Buehler PP. moved the report be accepted and seconded by J. Soderholm. Motion Carried.

**Twin Cities Hospital Report:** J. Stelsel, Recorder read the Twin Cities report for Rod Rommel, member of the

TCH Board of Governors. "On November 17, 2010 the TCH Board of Directors meeting the following resolution was passed unanimously. BE IT RESOLVED. That for the past several years, Fairview Health Services, Shriners Hospitals for Children TC, University of Minnesota Physicians and the University of Minnesota facility and that as the parties worked through the details of the proposed model, which required sharing clinical and support services including surgery. It was determined that the plan to create a hospital within a hospital to advanced our shared goals in not currently achievable.

NOW, THEREFORE, The Board of Governors of Shriners Hospitals for Children - Twin Cities does unanimously vote to discontinue negotiations for the relocation of its inpatient unit and surgery department to University of Minnesota Amplatz Children's Hospital. The Board does further encourage and authorize hospital leadership under the direction of the Board of Governors, to continue pursuit of alternative strategies that advance our stated goals. The hospital in light of the Amplatz decision has started discussions with other area Twin Cities Hospitals. The Imperial has approved the 2011 hospital budget. Zor's 2010 goal was 95 patients and as of November 30th we have been credited with 74 new patients. I wish to thank all the drivers of Zor who have taken the time and put on the miles to transport patients to the TCH. Thank you for your support of the TCH and if you need any further information please contact me at rodrommel@comcast.net or call 715-425-2726." J. Stelsel moved the report be accepted and seconded by L. Riemenschneider. Motion Carried.

**Insurance:** K. Johnson, Chairman of the Insurance Committee, L. Myers and J. Olson make up Zor's Insurance Committee. The committee had a very busy year reviewing coverage and setting goals for coverage we felt needed by Zor. These included but were not limited to: complete drivers lists with full driver information, increased umbrella limits and underlying coverage needed to include workers compensation, review of property coverage and work on club and unit reports and proper coverage for circuses. A review did find Zor currently meets the minimum required by Imperial in all lines. Claims have been minimal and the members should be proud of the safety records the Units and Hospital Van Drivers. We again recommend the Trustees do an annual review of the property values of the Zor building and contents. Club and Units need more work on making sure they get the coverage for equipment they think they are getting. Possibly Insurance Committee needs to meet with the Divan reps and cover these items they then can take back to the units. The committee wishes to extend a special thank you to Elgi Toman and Badger Insurance Specialists for their past service and acknowledge the fact our 2011 agent will be Tony Arneson of the Nickerman Insurance Services of Madison. K. Johnson PP. moved the report be accepted and seconded by R. Amdall. Motion Carried.

**Hospital Transportation:** L. Saunders reported in 2010 we put approximately 106,424 miles on the 9 vans that transport our patients to the hospitals. Out total paid out of our Hospital Patient Transportation Account for 2010: Meals \$5,946.34, Fuel/Tolls \$17,895.78, Lodging \$4,120.67, Cabfare, \$371.00, Maintenance \$5,667.84 and Airfare \$14,338.42 for a total of \$48,340.05. The HPTF is not a budgeted fund. It is fueled only by donations. Please remember to keep this fund in your thoughts as you send in donations for memorials. This account is operated by Zor, and therefore Zor patients directly

**Budget Request for 2011:** S. Peterson presented his 2011 budget and asked if there are any questions and none were asked. S. Peterson move approval of the 2011 budget as presented and seconded by B. Gorsuch. Motion Carried.

Approval by the membership of the 2011 Auditor: S. Peterson moved that SVA be approved as Auditor and seconded by R. Amdall PP. Motion Carried.

Approval for the 2011 Summer Circus; La Crosse, Eau Claire and Menominee. Football Games at La Crosse, River Falls and Whitewater and the Summer Magic Shows: S. Peterson moved for approval and seconded by N. Allen PP. Motion Carried.

Request of L. Riemenschneider to plan a Potentate Trip in 2012: L. Riemenschneider moved approval to plan his Potentates Trip during 2012 and seconded by B. Gorsuch. Motion Carried.


