Inaugural Training Update

In late August, 16 additional persons attended the Wildlife Fire Training Course. The August training sessions were led by Jordan Pollock and Kyle Dodd, professional wild land firefighters and accredited trainers (Kyle's bio provided at end of communication).

Between the July and August training sessions, 32 Islanders have gone through the Wildland Fire Training Course that provided firefighting theory and techniques based on industry standards. Combined, we achieved 144+ person hours of training, all within the COVID-19 health restrictions. This is a significant step forward in preparation and a key foundation from which to build.
