## HOLIDAY HORSE BACK RIDING CAMP

Come learn about horses with Long Creek Equestrian Centre! Campers should be between the ages 6 and 16. If you know a lot about horses or nothing at all, it is still a lot of fun! We do riding each day, arts and crafts, the campers get a plethora of knowledge, and the camp is very hands on! We also have a petting zoo on the premises where the kids can interact with different animals...

- The camps are from 8:30 AM – 2:00 PM!
- Ages 6 - 16 years.
- We provide lunch daily.
- The first session, please arrive at 8:15 AM to fill out a release form.
- If campers need or want additional drinks, bug spray, or snacks – Please make sure to bring these items.
- Each participant **MUST** wear pants, sturdy lace up shoes, sleeves on shirts ex: t-shirts (no strapless or spaghetti straps) ~ they can not participate in riding, if they do not dress appropriately. Please dress appropriate for the weather each day (jackets, gloves, rain coats, sun screen, etc).
- All camps are held at our facilities; rain or shine... we have a covered arena!

### Camp Dates:

- Camp #1 ~ December 20 & 23 TWO DAYS (Fri & Mon) \$ 125
- Camp # 2 ~ December 30 & 31 TWO DAYS (Mon & Tues) \$125
- Camp #3 ~ January 02 & 03, 2020 TWO Days (Thurs & Fri) \$125
- Camp option #4 ~ Daily \$ 75/day
- Camp option #5 ~ Dec 30, 31, Jan 2 & 3 (Four days) \$240

Please remember: Camps must be **pre registered** to assure the proper numbers! There is a \$50 *non-refundable* deposit. This money does apply to your camp session. The price for camp is listed above for the session. *We do have to have 4 kids to hold each camp session, if your first choice doesn't fill you can join the second session ...*



RIDING & CAMP LESSONS, PETTING ZOO, PONY RIDE & FARM RELEASE

The following information is used to guide the rider in learning how to "Take Lessons":

It is understood that we recommend the rider have on long pants or capris. They must be at least four years of age (eight for trail lessons) and cannot weigh more than 250 pounds. All riders are required to wear a helmet. You MUST have a helmet on while jumping regardless of age. Under no circumstances can you ride if you do not have a sturdy lace up shoe or some boot.

PETTING ZOO WAIVER OF LIABILITY Warning: By signing this agreement, you give up the right to sue for any injury or damages howsoever caused, Long Creek Equestrian Centre'/Lil' Buddies Learning Zoo/LCEC, Inc., (hereinafter referred to collectively as "The Farm.") and owners, employees, representatives, officers, and agents (hereinafter referred to collectively as "Employees"). 4. I fully understand the risks and dangers associated with my child's (or my personal representative, heirs or assigns) participation, in The Event, and accept same entirely at my own risk.
5. I hereby waive any and all claims, which I may have against The Farm, and/or its Employees, and release The Farm and its Employees from all liability for injury, death, property damage, or any other loss sustained by me or my child (or the child I am representing) as a result of my/their participation in the Event, due to any cause whatsoever including, without limitation, negligence on the part of The Farm or its Employees, for any and all legal fees (on a solicitor and his own client basis) or costs, which may be incurred in defending any lawsuit or claim I may bring against them.
6. I appreciate that This Agreement applies whether The Farm is at fault or not and it limits the liability of The Employees to the same extent as it limits the liability of The Farm even though The Employees are not formal parties to This Agreement.
