



Basic Eligibility Requirements

- Have a physical location in Deming City Limits (headquartered in NM)
- Employ 50 people or less (2 part time= 1 full time)
- Annual Revenues of \$2 Million or less
- Business Start Date no later than March 1, 2019
- Business must have been mandated to close or had severely curtailed business operations as a result of mandated closure orders due to COVID-19 Pandemic





By January 31, all 1099-Gs will be mailed out to individuals who had claimed Unemployment Insurance (UI) benefits in the previous ca in the mail, in January you will be able to log into the UI Tax & Claims System and view your 1099G. You can also print additional copies

Once logged in to the <u>New Mexico Workforce Connection Online System</u>, you can log in to the UI Tax & Claims System by clicking on "Unemployment Insurance" on the left-hand side of the screen under the "Quick Menu." After logging in to the UI Tax & Claims Syster can view your 1099-G by clicking on "View Correspondence" on the menu on the left-hand side of the screen.

- Temporary structures to mitigate the spread of COVID-19
