DEPOSIT & SECURING YOUR BOOKING:

A **£50.00 refundable deposit** is required to secure your booking, with the full balance of your stay due one week prior to check-in.

PRIOR TO YOUR BOOKING:

Once full payment has been received, we will send you the studio address, parking instructions, and arrange a convenient time to meet for a brief tour and key handover.

RETURNING GUESTS:

For returning guests, a meet and greet is not required. We are happy to offer self check-in, and detailed instructions will be sent 24 hours prior to your booking.

DAYTIME BOOKINGS DISCLAIMER:

Bookings of **under 6 hours** will incur an additional **£25 fee** if you wish to use the bed during your session.

More than 72 hours' notice: Full refund applies

Within 72 hours: We will do our very best to offer an alternative suitable date

Within 48 hours: The full studio hire fee will apply

Deposit Refund Policy

This document outlines the specific conditions under which a security deposit for Stag Studio may be partially or fully withheld. We pride ourselves on providing a premium , discreet and pristine environment but maintaining these standards requires a mutual respect for the space and its equipment.

The following scenarios result in additional labour and specialised cleaning that exceed our standard turnover protocol and will result in a deduction from your deposit.

Primary Reasons for Deposit Forfeiture

1. Excessive Lubricant Residue

Excessive lubricant is expected but it must be managed responsibly. If lubricant is found spread across surfaces (furniture, floors , walls and or equipment) with no visible attempt to clean or contain it a fee will be deducted.

2. Improper disposal of biohazardous waste

For the safety of our staff and the hygiene of the studio all personal items must be disposed of correctly. Deposits will be impacted if the following are found scattered or left in “open” areas:

*used condoms or soiled tissues/ paper towels.

*Requirement: All such items must be bagged in the provided nappy sacks and placed in the provided waste bins. Leaving these items around the space is a health hazard and a violation of our hygiene policy.

3. Toy hygiene & Organisation

We provide high quality equipment for your enjoyment , but they must be returned to their designated location in our provided toy bin in a sanitary state.

*Condition: Toys found with used condoms still attached or significant residue left behind will incur a sanitisation fee.

*Organisation: Used toys found misplaced or scattered across the studio (rather than being returned to the designated toy bin) will result in a deduction. This ensures our team can inventory and deep - clean the equipment efficiently.

4. Food Waste in Main Areas

Food waste creates significant odours and hygiene risks. Any food items or food packaging found disposed of incorrectly or left out) in the bedroom , play room will result in an additional cleaning fee.

*Requirement: Please use the lounge & kitchen area when consuming food and beverage. All food-related disposal should be disposed of in the designated kitchen waste area .

5. Theft of Studio Property & Amenities

All items provided within the studio- including electronics, decor and high end toiletries - are for use during your session only.

. Electronics and Appliances: Theft of hair dryers, straighteners, speakers or other electrical appliances will result in an immediate forfeiture of the full deposit and potential further billing for replacement costs.

. Toiletries & consumables: while we provide premium toiletries for your comfort the removal of full sized bottles, dispensers or decor items from the studio is prohibited.

Summary of expected “Check- Out” Etiquette

To ensure your full deposit is returned, please perform a quick sweep of the space before departing:

- **Note: our cleaning team documents the state of the studio immediately following every session. In the event of a deduction, photographic evidence will be kept on file for your review upon request**

Action Item	Expectation
Toy Care	Remove condoms; wipe off residue; return all items to the designated toy bin.
Waste Disposal	All condoms and tissues must be bagged and placed in waste bins
Surface Care	Please wipe down excessive spills or lubricant “puddles”
Food & Beverage	Ensure no food waste/ packaging is left in the bedroom or play area.
Inventory	Ensure all hair appliances, electronics and full sized toiletries remain in the studio.
