Note that a strike-thru designates removal and underline designates an addition in the document. Note that there will be a separate vote specifically for the removal of the fire sprinkler system restriction within the Declarations. We will utilize Zoom Polling in the meeting to cast votes of the members. To approve the amendments to the Bylaws and Declaration of Covenants, Conditions, and Restrictions, 2/3 of the voting entities must cast ballots in person or by proxy, in favor of the changes. It is very important that every land/homeowner attend and have their vote cast.
