## 2026 Mowing Season Contract

This agreement and understanding for lawn services between the Village of Dresden (hereafter referred to as "Customer or Village") and \_\_\_\_\_(hereafter referred to as "Contractor"). The Village Council will open and discuss bids and award the same date \_\_\_\_\_in a Special Council meeting.

Pursuant to the forgoing the parties agree as follows:

Properties for mowing to include:

**Dresden Cemetery**  
**Dresden Senior Center**  
**Dresden Swim Center**

### **SPECIFICATIONS/TERMS REQUIRED of CONTRACTOR:**

1. Contractor shall have proof of liability insurance and workers compensation and provide proof of the same to the Village Fiscal Officer prior to performing any services.
2. Grass must be cut within 48 hours' notice for last minute/ emergency cuts from an authorized village representative, who shall be the Mayor or the President Pro Tern.
3. Pricing to include trimming walkways, driveways, trees, poles, fenced areas and tomb stones.
4. Except for inclement weather, all mowing must be completed on same day.
5. Contractor to remove all debris (i.e. trash, tree limbs, etc.) found during mowing.
6. Walkways, patios and driveways must have all clippings removed.
7. Mowing of Cemetery may not start until dew is off grass. Grass should not be cut when raining or grass is wet.
8. Weed eating of cemetery to be done every other cut.
9. Special care to be taken in the cemetery as to not damage or leave clippings on stones. Clippings to be blown off stones.
10. If wind rows are created, need to disperse excess trimmings until eliminated.
11. Extreme judgement should be used as not to cut when is not needed.
12. Mowing at the pool should be completed before 11:00 a.m., after 7:00 p.m. or Mondays which will be closed cleaning days. Clippings bagged within fenced area of the pool.

13. Contractor will begin performing regular 3.5 inch-high lawn maintenance beginning 04 / 08 / 2026 through 10 / 07 / 2026 maximum 26 cuttings. Thereafter, regular lawn maintenance will be performed on an as needed basis directed by the Mayor or President Pro Tern.

**Compensation to Contractor**

For each completed mow, the Village shall pay Contractor the sum of\$ \_\_\_\_ for mowing the Cemetery and \$\_\_\_\_ for mowing the Village Swim and Senior Centers, for a total compensation of\$ \_\_\_\_\_for each completed mow. Contractor shall provide written invoices for services provided, the date of each service and the total requested compensation. The Village shall have 30 days to pay any received and approved invoice.

**Additional Provisions:**

The initial term of the agreement, shall be for the 2026 Mowing Season as set forth above. The Village reserves the right to extend this Mowing Contract for up to 2 additional 1-year terms, subject to mutual agreement between the Village and Contractor.

This Contract shall not be assignable by Contractor and may be terminated at anytime by the Village for cause or otherwise upon written notice to Contractor.

This contract shall only be modified by mutual written agreement by the parties.
