Camps: ALL all-star athletes are required to attend the two-day DTE in house fundamentals camp, This camp will teach advanced level skills in jumps, tumbling and stunts, and we will also do strength and conditioning training. The other mandatory camp is choreography camp where the athletes learn their competition routine for the season. DTE will be providing lunch for both camps.

# Gym Policies & Procedures

- Any athlete with a fever over 100.4 or is displaying symptoms will not be allowed to enter the facility. Athletes may re-enter when free of symptoms and fever for 48 hours.
- Dream Team Elite Cheer Company, LLC is not responsible for any theft of damage to personal property of items brought into the facility.
- Privacy is important to Dream Team Elite. Recording videos of classes, team practices, and or competition routine is prohibited.
- Only Dream Team Elite staff and athletes are allowed to enter the gym. Parents are not allowed to enter the cheer floor for any reason unless invited by a Dream Team Elite Cheer Staff.
- No Food and/or Drinks are allowed on the cheer floor. All food and/or drinks must remain in the gym lobby.

## Discipline Policy

Dream Team Elite Cheer company has zero tolerance for the following behaviors including but not limited to those listed below. DTE will enforce a strict discipline policy that could result in immediate removal of the athlete.

- Bullying
- Use of profanity
- Physical altercation
- Vandalism of Gym property or equipment
- Verbal altercation (at administrative staff discretion)
- Theft

- Penalties that include additional conditioning In house gym chores

# Discounts & Fee Policy

---

**Sibling Discount-** There is a 20% discount on the 2nd sibling, and 30% on every sibling following. This applies to athletes on the current teams only.

## **Fee Policy**

We understand life happens and as a result, our athletes might have to cancel their membership and participation with DTE. We have implemented the below process to ensure an easy and effective cancellation process.

\* 30- day notice- please submit a 30-day written notice to [dreamteamelitecheer@gmail.com](mailto:dreamteamelitecheer@gmail.com) requesting cancellation before the 6th of the month to avoid being charged for next month's tuition. Be sure to include the effective date, and the last day the athlete will be in attendance.

\*Final monthly tuition payment will be required to cancel in good standings with DTE.

\*There will be no refunds or repayment for cancellations. Any account with a pending balance due after the 7th day of each month will be charged a late fee of \$25.00. The account will need to be up to date before the next 30-day payment cycle. Failure to update account within will result in a 30 cycle will result in a suspension period for the associated athlete(s).

\* Credit Card on file must be up to date and has not expired. Any credit card or ACH payment that is declined will incur a \$10.00 re-processing fee and late fees if unresolved by the 7th day of the payment cycle.

\* Dream Team Elite Cheer does NOT process refunds of any kind to accounts.

\* If an athlete is removed or drops (exclusions apply-at the discretion of the board) the Dream Team Elite Program for any reason, you are still financially obligated to pay the monthly fee from July 2024 through April 2024.

# Skill Level Criteria

ATHLETE PLACEMENT Athletes are divided into teams based on two factors: age and skill level. Please see the level requirements below.

SKILL LEVEL BREAKDOWN: Athletes are evaluated based on their execution of tumbling, jumps and stunts. All skills are significant and will be taken into consideration when putting together successful teams. All skills must be maintained to remain on any given level/team. DTE reserves the right to move an athlete from one team to another at any point in the season (up OR down) based on performance, ability, necessity or for any other reason.

TEAMS	BIRTH YEAR	CHEER CATEGORIES
Sparklettes	2019-2020	Sparklettes are composed of new athletes under a certain age. Sparklettes will be trained to progress, and develop to grow to Dreamer level.
Dreamers	2015-2018	Dreamers are composed of first/second year All-Star athletes. Dreamers are trained to progress and develop skills individually, and as a team. This team will be put together based on USASF age grid.
Cloud 9	2012-2017	Cloud 9 is composed of new and experienced athletes. This team is selected based on age, skill level, and experience. This team is highly necessary to grow your athlete to the next level.
Majetics	2009-2016	Majestic's is composed of athletes with at least two season's of all-star experience, and/ or prior experience in cheer or tumbling. Athletes are expected to adapt to high intensity training, and coaching.

\*These criteria are subject to change according to USASF. NOTE: THESE SKILLS DO NOT 100% DETERMINE AN ATHLETE'S LEVEL. THIS CHART IS DESIGNED TO GIVE AN IDEA OF THE LEVEL THE ATHLETE IS AIMING FOR.

# Dream Team Elite Cheer Attendance Policy

Cheerleading is a team sport which requires every cheerleader to know their responsibilities and perform as part of a TEAM. We are unlike any other sport in that we do not have substitute members if someone is absent. Attendance is essential to the success of each season. Attendance will be taken at the beginning at each practice. Each athlete's 100% commitment is required as each position on the squad is dependent on the other. When one athlete is absent, it places hardship on the entire squad and can become a safety issue. It is for these reasons the athlete and the parents must be advised of the importance of compliance to the attendance policy. We understand things may come up throughout the season. For that reason, we have defined our attendance policy below.

Attendance Policy is as follows

1. All practices and competitions are MANDATORY.
2. Athletes are expected to be on time (on time is at least 5 minutes early to practice dressed and ready to begin on time!) so they may participate in stretching, warm up, etc....
3. Athletes must turn in an Absence Request Form (ARF) at least a week in advance of the requested date to be considered as an excused absence.
4. Any missed practices will only be excused if a family emergency occurs, or a special circumstance, as these are crucial to getting ready for competition.
5. Athletes cannot miss any practices during the blackout period leading up to competition, no exceptions.

Head Coaches and the cheer committee will make final decisions on each absence status. Excessive absences/tardies will be taken into consideration in competition choreography.

Examples of excused absences:

- Athlete is sick but returns with a doctor's note
- Serious illness or death in the family
- Mandatory school event
- Planned vacation prior to September 1, provided the coach has been notified.

When an athlete or parent knows that he/she is going to be absent or late, he/she has the responsibility to notify their coach in advance via Band App, otherwise it will be treated as an unexcused absence. Also, Coaches understand that occasional school conflicts arise, and we prioritize academics first. However, we also expect cheerleaders to use good time management skills to complete schoolwork and practice.

Examples of unexcused absences:

- No notification of absence
- Conflict with other sport/activities (special circumstances apply to sports known ahead of time)
- Non-Life-threatening illness
- Lack of transportation



---

Dream Team Elite Cheer is expected to be a priority commitment during the season. When a team is missing cheerleaders, it diminishes the cheerleaders' opportunity, both individually and as a group, to safely learn and practice their skills. A single miss affects the entire squad and impacts those cheerleaders who have committed to be at all practices.

After three excused absences, the fourth absence will result in an automatic unexcused absence.

TARDINESS/LEAVING EARLY: 3 times unexcused tardy, leaving early, and any combination of the two is considered 1 UNEXCUSED absence.

### Consequences for Unexcused Absences

1st unexcused absence: A warning is issued to the athlete and parent.

2nd unexcused absence: Extra reps of a physical conditioning exercise (cheer jacks, squats, push-ups etc.) or an extra lap of running at the end of practice to make up for what was missed. Age-appropriate activity will be determined by her head coach.

**3rd unexcused absence:** Removal from one competition.

### **Excessive Absences:**

**If the amount of excused and unexcused absences exceeds 10, this results in the removal of the athlete.**

**Parents WILL NOT be reimbursed any fees, or tuition of any amount.**

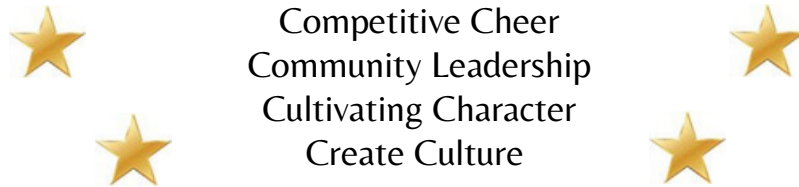
