## Additional Rules

1. Owners and owners' agents are responsible for any errors on entry forms, for entering the same dog twice, or for entering a dog in a class for which it is not eligible. Entry fees will not be refunded in the event of errors or cancellations received after the close of entries, nor in the event that a dog is absent, disqualified, excused by the judge or barred from competition by the action of the committee. Telephone, Telegraph, Fax and unsigned entries cannot be accepted.
2. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the Show, no refund of entry fee(s) will be made.
3. This show will be unbench. Exhibitors should bring their dogs to the show grounds one hour before the scheduled time of judging and may be excused after their class is judged, if they are not needed for further judging. Dogs MUST compete in every class in which they are entered or for which they become eligible.
4. Dogs must be ready for judging. Owners or owners' agents are solely responsible for the presence of their dogs in the judging ring at the proper time. The Club and/or the Show Secretary will not be responsible for and are not obligated to provide a service for notifying exhibitors of breed or class judging. Judges will not wait for dogs holding up their rings.
5. The management will not be responsible for the loss or damage to any dogs, on or off the show grounds, whether the result of accident or any other cause. It is to be distinctly understood by all exhibitors that their dogs are to always be in their custody and care.
6. The Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.
7. All grooming must be done in areas specified by the club and **exhibitors are required to keep their areas clean.**
8. Trophies and other Prizes will be awarded in the judging rings unless otherwise specified by the club. All claims for Trophies and other prizes must be made in the judging ring before completion of judging by the person handling the dog; such person shall be considered as the owner or owner's agent. The Secretary Office is to be notified at once in the event of any discrepancies. No trophies will be mailed.
9. Only dogs that are eligible to be shown under The American Kennel Club rules shall be allowed within the show precincts [AKC Rules Applying to Dog Shows: Ch. 11, Sec. 11.] **PLEASE NO UNDERAGE PUPPIES. There are no provisions for dogs not entered.**
10. A recording fee of 50 cents will be required for each dog at any licensed or member club show, obedience trial or tracking test and \$3.00 AKC Event Service Fee. This recording fee and Event Service Fee is to be collected by the show-giving club and paid to the AKC. If a dog is entered in more than one class at a show, the recording fee is to be collected on the first entry only. AKC Rule, Ch. 11, Section 2.
11. The Show Giving Club, Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage, or by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to any children.
12. Show Giving Club requires that "Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations and have proof of rabies vaccination.

## Notice to Exhibitors

American Kennel Club Rules Applying To Dog Shows, Chapter 11, Section 6: "No entry may be changed or canceled unless notice of the change or cancellation is received in writing or by telegram by the Secretary or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another at a show prior to the judging, and except that dogs which according to their owner's records have completed the requirements for a championship after the closing of entries for a show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Secretary or Show Secretary at least one half hour prior to the scheduled start of any regular conformation judging at the show."

### Notice To Exhibitors

The AKC has stated that NO ENTRIES are to be accepted WITHOUT SIGNATURES. Please be sure to sign your entry form and provide correct information.

All Entry Payments are to be made to **Carolyn I Ritacco**, not the individual club. Make sure your check is filled out correctly and your amounts are correct. Feel free to call if you need help determining what amount to send!

Please provide your e-mail address (PRINTED CLEARLY), you will receive your acknowledgement and Judging Schedule via e-mail. This is an attempt to keep costs down for our clubs which, in turn, keeps the cost of your entries down. Please verify all information on your acknowledgement for accuracy of spelling as well as of dates and registration numbers.

Please take care of the building by keeping your area clean and picked up. Outside areas need to be picked up and grooming products are not allowed left on pavement or grass.

### **Best of Variety**

**BEST OF VARIETY COMPETITION** - The following categories of dogs may be entered and shown in Best of Variety/Breed Competition: Dogs that are Champions of record, which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championship is unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If, at the end of the 90 days period, the championship of a dog has not been confirmed by The American Kennel Club, no further entries of the dog for Best of Breed Competition are to be made until its championship has been confirmed by the AKC.

### **Non-Regular Classes Involving Single Dog Entries**

AKC".\*Chapter 11, Section 8 of the Dog Show Rules provides that "Neutered dogs and spayed bitches would be allowed to compete in the Veteran Classes only at independent specialties and/or all-breed shows which do not offer any competitive classes beyond Best of Breed.

### **Best Veteran: - Show #1 & #2**

The Pacific Northwest Collie Club, Inc. will offer the Best of Variety/ Breed judging the following competition for Best Veteran in Show. The dogs/bitches placing first (7 yrs & under 9 and 9 yrs or older) in the class from Rough/Smooth judging will compete for Best Veteran.

### **Best Bred By Exhibitor: - Show #1 & #2**

The Pacific Northwest Collie Club, Inc. will offer after the Best of Variety/Breed judging the following competition for Best Bred By Exhibitor in Show. The dogs/bitches placing first in the class (Bred By Exhibitor Puppy & Bred By Exhibitor Adult) from Rough/Smooth judging will compete for Best Bred By Exhibitor.

### **Non-Regular Classes Involving Multiple Dog Entries- Show #1**

**Stud Dog Class** - For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class. No dogs or bitches will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

**Brood Bitch Class** - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. No dogs or bitches will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

**Brace Class:** Effective January 1, 2005. A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competitions must have at least one common owner. Under additional class on premium mark Brace Class

## **AKC NATIONAL OWNER-HANDLED SERIES OFFERED AT EACH SHOW**

**AKC NATIONAL OWNER-HANDLED SERIES** The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Professional handlers, \* household members and current assistants to professional handlers\*\* may not exhibit. Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Variety/Breed) competition.

Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition (Group and Best in Show).

Any person may exhibit the dog in the regular Group and Best in Show competitions. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring. The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

### **Junior Showmanship**

#### **Novice Class:**

For boys and girls at least 9 and under 18 years of age on the day of the show who at the time entries close, they have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

#### **Open Class:**

For boys and girls at least 9 and under 18 years of age on the day of the show who at the time entries close, they have won three (3) first place awards, with competition present, in the Novice Class.

#### **Master Class:**

For boys and girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) first place wins in an Open Class, with competition, to be eligible to enter the Limited Class Competition.

The calendar for this class will be November 1-October 31 of the following year. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year. Best Junior Handler: Winners from each class will compete for Best Junior Handler.

**NOTICE:** Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. (PLEASE MAKE SURE YOU ARE ENTERING UNDER THE CORRECT CLASS FOR YOUR AGE AND EXPERIENCE.) You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on the front and back of the entry form.

The Sweepstake Classes will be judged separately from the Regular Classes. The Sweepstake Classes are divided as follows:

I (we) waive any and all claims, causes of action. I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, Secretary's or show secretary and the owner or lesser of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of the club or any or the parties aforementioned, or by the negligence of any other person, or any other cause or causes.
