Instructions

BEFORE YOU START

RISK OF WATER DAMAGE: ALL CRYSTAL WATER PRODUCTS (CWP) SHOULD ONLY BE INSTALLED BY A CERTIFIED PROFESSIONAL TO AVOID ANY DAMAGE TO PRODUCTS AND/OR PROPERTY. Do NOT OVERTIGHTEN OR DAMAGE MAY OCCUR CAUSING A WATER LEAK.

INSTALLATION

- CWP'S INLINE MAGNETIC WATER CONDITIONER COMES WITH 3/4" FEMALE IPS THREADED CONNECTIONS. WRAP PTFE TAPE AROUND MALE THREADED CONNECTIONS, THEN HAND TIGHTEN THE UNIT ONLY. WATER CAN FLOW EITHER DIRECTION THROUGH UNIT, SO INSTALL CAN BE SIMPLE AND CLEAN.

OPERATION

- ONCE INSTALLED THERE IS NO MAINTENANCE REQUIRED
- ONCE IN USE EXISTING SCALE MAY BEGIN TO BREAK DOWN. A PRE FILTER MAY BE REQUIRED UPSTREAM OF THE UNIT. A FILTER OF 50 MICRONS WILL PREVENT LARGE PARTICLES FROM ENTERING THE SYSTEM.

LIMITED WARRANTY

Crystal Water Products warrants, to its initial purchaser only, that its Inline Magnetic Water Conditioner product which are delivered to the initial purchaser will be the kind described in the order or price list and will be free from defects in workmanship or material for a period of twelve (12) years from the date of delivery to you, our initial purchaser. Should any failure to conform to this warranty appear within twelve (12) years after the date of the initial delivery to our initial purchaser, Crystal Water Products will, upon written notification thereof and substantiation that the goods have been stored, installed, maintained and operated in accordance with Crystal Water Products recommendation and standard industry practice, correct such defects by suitable repair or replacement at Crystal Water Products own expense. If any Inline Magnetic Conditioner system alleged to be defective, is returned to our factory at Riverside, CA, it will be examined and, if found to be defective under the warranty, it will be replaced at no charge. Professional Installation required for valid warranty.
