2025-2028 (Contract Terms) Teamsters Southern California Master Labor Agreement for the Construction Industry, 2025-2028 Allocations.

JAVIER FRANCO Trustee

- Three-year contract, allocations for 2025-2026
 - Three dollars and thirty-five cents (\$3.35) per hour allocation for July 1, 2025.
- Breakdown:
 - Two dollars (\$2.00) per hour for all wage classifications.
 - One dollar and thirty-five cents (\$1.35) to Construction
 - Vacation/ Holiday/ Sick fund
 - Add President Day as a Holiday
- Allocations for 2026-2027 Three dollars and Twenty cents (\$3.20) To be allocated by the Union
- Allocations for 2027-2028 Three dollars (\$3.00) To be allocated by the Union.
- Please incorporate the increases into the prevailing wage determination as appropriate.
- The Wage and Fringe allocations effective July 1, 2025, are as follows: Effective on July 1, 2025, an increase of two dollars (\$2.00) shall be allocated and paid to the hourly wage rate for all classifications in ARTICLE XVIII as well as the sub journeymen, DAS Apprenticeship Prevailing rate work sheets.
- Effective July 1, 2025, an increase in the hourly contribution of one dollar and thirty-five cents (\$1.35) to Construction Vacations/Holiday/Sick fund
- Effective July 1, 2025, add President Day to Article VIII Holidays
- RIVERSIDE & SAN BERNARDINO COUNTIES IN THEIR ENTIRETY, CA
- AFFILIATED WITH INTERNATIONAL BROTHERHOOD OF TEAMSTERS

DECLARATION OF ROBERT STANLEY

Robert Stanley declares as follows:

- 1. I am the Vice President of Teamsters Local 166 affiliated with the International Brotherhood of Teamsters. I am also an Executive Board member of Teamsters Joint Council No. 42.
- 2. The enclosed copy of the 2025-2028 Southern California Master Labor Agreement (2025 wage and fringe benefit allocations) is fully executed by the various parties and in effect.
- 3. The Master Labor Agreement covers the Counties of Los Angeles, Inyo, Mono, Orange, Riverside, San Bernardino, Imperial, Ventura, Santa Barbara, San Luis Obispo, Kern, and Richardson Rock, Santa Cruz Island, San Miguel Island, Santa Barbara Island, San Clemente Island, Santa Rosa Island, Anacapa Island, including the Channel Islands Monument.
- 4. The Master Labor Agreement is between Teamsters Joint Council No. 42 and Teamsters Local Union No. 87, and individual contractors performing Teamsters work.
- 5. Approximately 1300 workers are employed under the Master Labor Agreement in the geographical area covered by the Master Labor Agreement and have been employed in the last 12 months.

I declare under the penalty of perjury and the laws of the State of California, that the foregoing is true and correct. Executed on June 30, 2025, in Bloomington, California.

ARTICLE XVIII Wage Scales

1801. **Overtime:** Time and one-half (1½), except Sundays, Holidays and after twelve (12) hours worked per day, which are double time (2X).

Effective July 1, 2025 / \$3.35 Per Hour Increase allocated as follows:

- \$1.35 to Construction Vacation / Holiday / Sick Fund
- \$2.00 wages to all classifications

Effective July 1, 2026 / \$3.20 per hour increase to be allocated by the Union Effective July 1, 2027 /\$ 3.00 per hour increase to be allocated by the Union

The Union may elect, at its option, upon at least sixty (60) days written notice to allocate the increase to (1) Hourly Wage Rate; (2) Health & Welfare; (3) Vacation; (4) Training; (5) Supplemental Dues; (6) Pension; (7) Contract Administration Fund; (8) State Certified Apprenticeship Program; (9) Joint Labor Management Contract Compliance; (10) any combination thereof.

MILITARY BASES

For all jobs bid on or after 9/1/00, the differential for work at Vandenberg AFB, Point Arguello, Point Conception, China Lake, Camp Roberts, Edwards AFB, Nebo Marine Ballistic Base (Yermo), Mountain Warfare Training Center, Bridgeport, Fort Irwin, George AFB, Naval Air Facility, El Centro, 29 Palms Marine Base will be three dollars (\$3.00) per hour in lieu of subsistence.

1802. Hazardous Material Handling: A one dollar (\$2.00) per hour premium shall be paid to all employees handling and or hauling class A or B hazardous materials.
