Concessionaire General Requirements

- I. Please submit your application by mail (**NO EXCEPTIONS**)
- II. Stands must be staffed at all times during the following hours: 5:00 pm to conclusion of rodeo performance.
- III. Health Inspections will be randomly conducted throughout the 2019 Navajo Treaty Days Rodeo – Kayenta.
- IV. All concessionaires need to have a valid food handler's permit and sanitation permit.
- V. You will be only allowed four (4) free passes. Anyone else will need to pay the general admission. (**NO EXCEPTIONS**)
- VI. You will need to provide your own potable water for sanitation purposes.
- VII. You will need to follow the Navajo Nation Office of Environment requirements to operate your concession.
- VIII. Each Concession will be responsible for its own trash and must clean up before and after each performance.
- IX. Your concession stand will need to be presentable and all cooking ware will need to be out of customer's sight.
- X. Blue tarps are **not** to be used as part of display, only for protective covering at night.
- XI. All decorative material **must** be flame resistant. All decorative and display materials must be professional and appropriate for the theme and venue.
- XII. Cardboard boxes, stock, and trash must be kept out of view of public.
- XIII. No loudspeaker, amplified or other sound device can be used in the space
