# Wildwood Bluff Estates Association Annual Meeting 12/3/2022

- 1) Meeting called to order by G. Weinert, 12/3/2022 at 10:04 AM at Anchor at Lakeside Restaurant.
- 2) Motion to approve meeting agenda by A. Johnston, 2<sup>nd</sup> by D. Grossheim, motion carried.
- 3) Review of 12/4/2021 Annual Meeting minutes. *Motion to approve 12/4/2021 WWBEA Annual Meeting minutes by A. Johnston, 2<sup>nd</sup> by A. Templin, motion carried.*
- 4) Committee Reports:
  - a. CIVIC:
    - i. Annual \$200 donation to the Poynette Fire Department.
    - ii. Poynette Food Pantry donation in conjunction with the Halloween event Jane Lombardo coordinated.
      - Suggestion for a food donation drive during the spring Easter Egg Hunt event.

#### b. <u>PIER</u>:

- Water aerator: an asset because it circulates stagnant water from the corner of the bay. It needs to be kept free of debris to prevent damage. Expensive repair in 2022 was paid by the Pier Committee funds.
- ii. Pier fees currently at \$125/spot, review and discussion.
  - 1. Motion to increase annual pier fee from \$125 to \$200 per season by C. Franz, 2<sup>nd</sup> by W. Glowac, motion carried unanimously.
- iii. General discussion regarding feasibility of dredging in our bay. WWBEA member M. Niebuhr is member of a township committee that is discussing dredging near Town of Dekorra shoreline. G. Weinert will continue to review and make inquiries (dredging project would cost \$800K to \$1 Million).
- iv. P. Graeve would like to coordinate removal of all boat lifts at one time by the same vendor.

### c. PARK:

 P. Graeve has been mowing the park property. The former vendor could no longer continue his contract. P. Graeve agreed to continue to mow WWBEA common properties on an "as needed" basis.

## d. SOCIAL:

- i. Easter Egg Hunt held on 4/9/2022, coordinated by T. Franz was a wee-attended event. Thank you, Tessa!
- ii. End of summer camp fire at the park on 8/29/2022, coordinated by Kaitlyn & Dan Grossheim. Great time was had by all! Thank you Kaitlyn and Dan for putting this event together!

iii. Halloween Trick or Treat and food drive on 10/29/2022. Thanks to all the kids and parents for giving us a super spooky day! Thank you Jane Lombardo for coordinating the food drive donation to the Poynette Food Bank.

- a. Neighborhood Watch Program is now handled via the WWBEA Facebook page. Any concern can be announced quickly within the membership group. Thank you to Chris Franz for continued administration of this page.
- b. The home currently being advertised as an Airbnb rental is for sale and we hope it sells quickly. The property is NOT in compliance with the WWBEA rules (short term rental is NOT allowed). We have had continued complaints about problems regarding these short term renters.

- a. Brief review of the revised DCCRE= Declaration of Conditions, Covenants, Restrictions, and Easements adopted by the Wildwood Bluff Estates Association, Inc. to respond to the property being rented as an Airbnb short term rental.
- b. Spectrum salesman Alan, reported to L Clark on 10/10/22 that he looked into the Wildwood Bluff neighborhood with Spectrum and found we are in the "red zone" meaning, Spectrum has no interest in adding our neighborhood to their service area.

    - i. Expenses for pier repairs paid for by the pier funds (not general funds).
  - b. Review of the 2023 proposed budget.
  - c. Motion to increase Legal Fee budget to \$250 and Tax Preparation fee to \$750 = \$1,000 by D. Grossheim, 2<sup>nd</sup> by P. Graeve, motion carried.
  - d. Review: Extra expenditures from the general fund for legal work in 2022 to update the DCCRE. Board may need to discuss dues increase for 2024 to cover proposed budget shortfall.
  - e. Financial report copies are available at the annual meeting or upon request from WWBEA Treasurer, Wayne Clark.
  - f. Motion to approve the treasurer's report and 2023 amended budget by G. Weinert, 2<sup>nd</sup> by L. Clark, motion carried.
