UPON PAYMENT of the sum of \$ \_\_\_\_\_ paid by Buyer to Seller (the "Purchase Price"), receipt of which is at this moment acknowledged, Seller grants, sells, conveys, and transfers ownership of the following kitten (the "Cat") to Buyer.

## BUYER AGREES to ALL the following:

1. Under no circumstances will this kitten/cat ever be sold or given away to wholesalers, or retailers, donated to a raffle, or placed in a shelter or refuge-type facility. If the buyer becomes unable to keep this kitten/cat for any reason, the buyer agrees to return said kitten/cat to the Seller to be placed in a selective home.
2. This kitten/cat shall NOT be allowed to roam freely at any time.
3. This Kitten/cat has been transferred as a companion quality and if show or breeder rights are granted, it has been gratuitously and with no potential guarantees of any kind, due to many factors involved in rearing and caring for this kitten/cat are beyond the control of seller.
4. All kittens will be registered with T.I.C.A by the Seller.
5. The buyer agrees that this kitten/cat must be spayed/ or neutered by 6 months of age if sold as a companion pet.

6. The buyer agrees to provide immediate veterinary attention to the kitten/cat upon signs of illness or distress. The seller will not pay any veterinary bills unless agreed in advance and in writing.
7. The buyer has examined this kitten/cat and found it to be in good health and free of parasites.
8. We (the seller) do reserve the right to refuse to sell our kitten/cat to anyone that we do not feel will provide an appropriate home for the kitten/cat.
9. If this kitten/cat is purchased as a Pet and not spayed or neutered at 6 months of age, the buyer agrees to pay the seller an additional sum of the full breeder price balance of the kitten/cat within 90 days of the 6-month expired agreement. Proof from the veterinarian must be provided otherwise Seller will take legal action against Buyer for the breeder price balance.  
All legal fees and court fees will be the buyer's responsibility.
