- 3. **Minutes:** Approve 2.19.25 minutes
- 4. **Balance** and Reimbursements: 5,094.40. LFS Tax Group free tax preparation, **Open** item: to be filed
- 5. **ADAPT:** ADAPT (after-school) intends to end this school year 2024/2025. ADAPT said that if funded it could continue to run for at least next year. Asking if PTO is the right audience go through for some funding to assist. The PTO board agreed it is in parents and student's benefit to support if possible (a purpose ID'd in the PTO by=laws). Up to the PTO to vote. Potential future goal for tuition for a kid in future is a possibility. Vote to authorize funds by June or July and notify approval in the next 2 weeks. **PTO voted and approved 4:0** in favor of funding \$1,500 and up \$2,000 for ADAPT funding for the 2025/26 school year.

Motion to approve up to \$2k but will start at an offer \$1,500 and if needed can move up to \$2k - Approved

- 7. **Bylaws:** Added meeting section to discuss community attendance. Please see bylaws. - 8. **School Board Meeting Childcare:** Debrief, 20 children attended. Thank you for our volunteers of adults and 8<sup>th</sup> graders.
- 9. Fundraiser Committee Updates:
  - Calendar- Debrief decreased amount raised this year compared to last. Maybe needing to find ways to promote outside of social media channels. In person distribution of calendars, more open advertisement within the school, class competition of who sells more and gift to be paid for by PTO.
  - **PTO** membership How to get more parents involved, how to make teachers more known to the community to the PTO. Ideas about what to engage with next year.
  - Flower Fundraiser- Wentworth greenhouses, best price even with delivery fee. PTO agreed to stay with Wentworth. Same as last year. Sending forms home with kids. Orders due by April 25<sup>th</sup>, Drop off May 10<sup>th</sup> at 0900 at the school (Sat before Mother's Day) 10-12 for pick-up (Youngs said they can help with pick up distribution).
- 10. **Child Care PTO Meeting:** Vivica Duffield will be hosting childcare at the library for children 5yo and older. She will be doing a reading and craft from 5:30-6:30p. Potential for increased attendance to hold a childcare raffle (each kid gets a ticket and PTO selects a ticket at the end of the meeting) PTO pays for prize (\$5 GC or something small).

- 11. **PTO** to make a large email list with reach out from the **PTO**. Use for distribution of information for outreach. Introduce outreach to new administration for ways to improve connection to the teachers and staff.
