AS OF JUNE 22, 2015 YOU WILL NOT BE ISSUED A STICKER FOR VEHICLES WITH TEMPORARY TAGS AND MUST USE YOUR WALLET CARD UNTIL YOU GET YOUR NEW REGISTRATION AND PLATES. ALSO, A MAX OF 6 VEHICLE STICKERS PER PROPERTY (GOLF CARTS EXCLUDED).

WATERCRAFT: LIST EACH WATERCRAFT REGISTERED IN PROPERTY OWNER'S/TENANT'S NAME. PLEASE SEND A COPY OF NEW OR UPDATED BOAT REGISTRATION OR TITLE IF DIFFERENT FROM LAST YEAR - OTHERWISE STICKERS WILL NOT BE ISSUED. ALL REQUIRED MOTOR-POWERED WATERCRAFT MUST PASS LAKENGRN INSPECTION BEFORE A STICKER WILL BE ISSUED.

PERSONS BORN ON OR AFTER JANUARY 1, 1982 MUST PROVIDE PROOF OF COMPLETION OF THE BOATING SAFETY COURSE REQUIRED BY OHIO LAW.

I DO DECLARE I CARRY LIABILITY INSURANCE ON ALL VEHICLES & WATERCRAFT AS REQUIRED BY STATE LAW. FURTHERMORE, IT IS MY UNDERSTANDING THAT IF ANY FALSIFICATION IS MADE ON ANY VEHICLE OR WATERCRAFT REGISTRATION THAT THE STICKER(S) MAY BE CONFISCATED BY THE LPOA SECURITY OR MANAGER.
