Custom Pricing Statement:

As a seasoned dog trainer, I know that not all dogs are made the same. For certain breeds of dogs, including but not limited to hunting/sporting breeds, additional charges may be added. A household with two shih tzu's will not need quite the amount of exercise and stimulation as a household with two golden retrievers would, for example.

Walks & Adventures Statement:

I get requests for pet sitting where owners tell me, "You don't have to walk my dog, just love them and keep them company." Let me just say that not only does your dog deserve those daily walks but what kind of dog (mentally and emotionally speaking) are you leaving in my care with restrictions like that? No pet sitter glorifies watching a dog with pent-up energy and tons of opportunity for undesirable behaviors and mischief to unfold. As a professional in the industry for over 15 years, I can tell you that I've figured out the "recipe" for success and a thriving pet care experience. That's why by hiring The Pet Advocate, you are signing off on daily walks, trail hikes, stroller, backpack, or car ride experiences for your pets. When your pets are fulfilled and enriched, they are content and confident in your absence, which makes for the best pet care experience for your pets and their care provider!

Client Consultation \$25

A meet & greet must be conducted prior to locking in your pet care dates. Please have proof of current Rabies for all pets in the home + a set of 2 house keys to keep on file or secured in a lockbox on your property. If an established client moves to a new home, an additional consultation is required.

Constant Care House sitting

For a total of 17 hours in your home per every 24 hours, your trainer will leave the home 1 or 2 times per day, for 7 hours away. Your trainer moves in the day you leave between 8 - 9 am, and checks out the next day between 8-9 am. If services are needed before/after these time frames, services will be prorated or additional visits can be scheduled. **Additional dog, add \$30. For cats/critters, add \$10.**

Drop-in Visit

This 40-minute visit can be scheduled as an enrichment walk or a pet care visit. I believe that cats and critters should [also] get out of their home environment to be enriched, so stroller walks are included in the care visit. Also offered is feeding, water refresh, waste clean up, medication administration (for an extra fee), and a light bedding/cage cleaning. On enrichment walks, your pup will work on training cues while they move their body. **Additional dogs, cats, or critters, add +\$5 for each.**

The Pet Advocate considers bookings for many parts of the state, however, fee(s) can apply to clients outside of the Fairplay area to account for drive time & mileage.

Medication Administration

For pill or liquid administration, + **\$3/day.**

For needle administration, + **\$10/day.**
