DPRI EPIC is a SharePoint based site that provides the USMC DPRI community with a single location to interact. The change of concept for the utilization of SharePoint from previous approach of static collection of content across multiple sites and subsites is in direct support of PL(P)'s new role as required by the MCO.

DPRI EPIC is a stakeholder based with emphasis on transparency, and focus on information flow to enhance PL(P)'s ability for oversight.

The home page is comprised of six (6) main sections where access to all historical and current information related to the DPRI Enterprise Program can be found.


Navigate to the top of the page and utilize any of the section links to access the content.
