**Show Committee:**

**Big Sky Classic:** Tyrell reported at the June 14, 2022 emergency meeting, that the Board approved cancelling the Big Sky Classic for 2022 due to the flood issue at the Cottonwood Arena. Discussion about changing dates to the second week in June to not conflict with the VRH World Show. Laura has been in contact with AQHA for the VRH World Show dates. As soon as the dates are available, Laura will contact the Board in order to complete the AQHA paperwork. Tentatively June 6-11, 2023 were the dates considered. Tabled for July meeting. Discussion regarding paying Big Sky Classic Show Secretary for her work to date. Kendra made a motion to reimburse Bonnie DeVerniero \$303 for her expenses and time to date. Second to the motion by Britt. Motion carried. The Show Committee will present a proposal for a 6-day/6-judge destination show. 2022 AQHA fees were discussed. Cathy made a motion to roll over the 2022 fees for 2023. Josh seconded the motion. Motion carried.

**Nile:** Laura reported via Marilyn that all the 2021 sponsors have been contacted and majority are re-sponsoring for 2022. All sponsors have been invoiced. Marilyn has donated the hi-point sheets for the 2022 Nile/VRH.

**Awards:** Michele reported the two replacement awards have been delivered and Michele will be embroidering when she returns from the World Show. Suzanne Sherick has agreed to audit the Year-End results.

**Amateur:** Cathy reported the Sparks Some Fun is ready to go. Judge has broken her leg, but felt she could still judge the show. She will be doing a final walk-through with the facility later in the work. Some awards have been received. Any remaining will be mailed to the recipients. Incentive fund paperwork has been printed as well as MQHA membership applications.

**Youth:** Kendra reported the raffle tickets are still for sale. Any silent auction items designated for the Big Sky Classic will be taken to the Convention.

**Marketing/Membership Services:** Laura reported the annual renewals are at 80 with 31 Lifetime and 24 Youth members.
