Understanding Pastoral Care for the Sick (Part 4)

Who can receive the Sacrament of Anointing of the Sick?

In the past couple of weeks, save this past week, we have been looking at the Pastoral Care the church makes available to the sick, particularly one that involves the anointing of a sick person and those who come under the burden of old age.

So far, we have considered the biblical and historical bases of pastoral care to the sick, drawing on specific Bible passages and Church documents or statements. This week, I want to look at those who can receive the sacrament of anointing, which constitutes the major aspect of care for the sick.

Admittedly, bringing communion to those who are homebound or temporarily sick can be done anytime and by the minister of the Eucharist. However, care for the sick involving anointing only pertains to the duties of a priest.

Anointing with the oil of the sick, whether it takes place in the church during communal worship or privately in the church, home, or an institution of care, should be received by anyone who is seriously ill, preparing for a major procedure or after the procedure, or an elderly person who is burdened with the general challenges of old age.

Therefore, anointing with the oil of the sick is not to be received at will by anyone, not in the abovementioned category. In other words, don't receive it without major health concerns even during communal anointing in the Church where the temptation is high to receive it without any immediate issue at stake.

I hope these weeks of discussions on the pastoral care of the sick help us to approach well as the Church would want us to do.
