# **Pastor Speaks**

## Observance of the Feast of Immaculate Conception and other Holy Days of Obligation

Dear Parishioners,

Please take note of the content of this article. I am sharing with you the content of USCCB memo regarding the observance of the Immaculate Conception of the Blessed Virgin Mary as a holy day of obligation. It was sent by The Most Reverend Thomas John Paprocki, the Chairman of the Committee on Canonical Affairs and Church Governance, to the archbishops and bishops in the U.S.

"This year, December 8th is the Second Sunday of Advent. As a result, the observance of the Solemnity of the Immaculate Conception of the Blessed Virgin Mary, the Patronal Feast Day of the United States of America, will be transferred to Monday, December 9th. In previous years when December 8th has fallen on a Sunday, it was the practice in our country to indicate that the obligation to attend Mass does not transfer with the liturgical observance.

Earlier this year, in my capacity as Chairman of the Committee on Canonical Affairs and Church Governance, I wrote to the Dicastery for Legislative Texts to seek clarification on this matter. The question arose, in part, from the fact that December 8th is not included in the USCCB's complementary norm to canon 1246 CIC, which abrogates the precept to attend Mass when other holy days observed in the United States fall on a Saturday or Monday.

In response to my inquiry, I received the attached response (Prot. N. 18329/2024) Signed by His Excellency Filippo Iannone, O.Carm., Prefect of the Dicastery for Legislative Texts, and His Excellency Juan Ignacio Arrieta, Secretary. ....their response states that the feast 'must be observed as a day of obligation on the day to which it is transferred.' At the same time, the Officials rightly recall canonical principles that can be applied when attendance at Mass on the day of obligation is impossible for a legitimate reason.

I would be grateful if you would share this information with your presbyterate. Since the Dicastery's response will effect a change in our usual practice, sufficient time will be needed to provide appropriate explanations to the Catholic faithful."

We will be having an All Soul's candle memorial service at Mass on November 3rd. If you wish to participate in this service, you may buy a candle that will be lit and brought forward in memory of a deceased member/members of your family. After Mass, you may take your candle home or leave it to be lit throughout the year. Candles are \$5.00 each sign up sheets and boxes for candle fees are located in the hallway.

Thank you to those who decorated the church inside and out for the fall season. We are blessed to have family members who are willing and able to do this.

We could use a few volunteers to clean up leaves in the front of the church. This could be done weekly.

The Table of Plenty was a success and raised \$148 to add to our fundraising goal. We will have this the first Sunday of each month.
