Manufactured Housing/Mobile Home: land and mobile home must be in the person's name who is seeking fund. Mobile homes must be built in 1999 from a purchase date or newer. Cannot be more than 25 years old to apply for funds.

Home Repair Programs:

South Carolina State Housing Finance and Development Authority: Housing Trust Fund Programs: Funding Source

Williamsburg Enterprise Community Commission, Inc., has been re-certified to participate in State Critical and Home Repair Programs for 2024-2026.

Applicant must meet income guidelines with total income of everyone living in the home, lived in the house for two years; own land and home; home value guidelines according to tax accessor's value. Provide three months bank statement; ID of everyone over 18; deed; (W'2'-if working) and mortgage statement.

Critical Home Repair Program. Homeowner can receive up to \$15,000.00 in grant and up to 40,000.00 in forgivable loan with a restrictive covenant.

Manufactured housing/Mobile Homes built more than 25 years are not qualified. Must have deed to home and land as proof of ownership.

Eligible Critical Repairs: sewer/septic systems; water wells; roof replacement; facial and soffits; gutters; exterior façade, siding; windows; exterior doors/storm doors; accessibility ramps; HVAC unit and electrical upgrades to complete the HVAC system; attic insulation; water heater; primary entrance-porches/decks; crawl space access doors; smoke and carbon monoxide detectors.

Home Repair Program: Homeowner can receive up to \$75,000.00 in forgivable loan for major repairs. These funds include any remediation of hazardous material in homes built before 1978. These funds require a 20-year restrictive covenant.

Guidelines are requirements are the same as in the Critical Home Repair Program.
