# b. Beautification Committee:

- 1. Stephen Orlando reported that Community Clean Up Day was cancelled due to inclement weather.
- 2. Stephen presented a proposed Children's Garden illustration and motioned to use the Beautification Committee Budget to pay Ultimate Hardscapes \$5,700.00 for constructing the garden area. Theresa seconded the motion, and the vote passed with four in favor and one opposed.

- c. Social Activities Committee: Ruthann Gray Grabowski reported the following upcoming social events:

### VIII. UNFINISHED BUSINESS:

- a. CH Pool Valves and Manifolds Repair: David reported that the item has been repaired/closed.
- b. Purchase of Tennis and Pickleball Court Nets: Gary motioned, and David seconded, the purchase of two nets from Tennis Courts Inc. for \$1,721. The motion was approved unanimously.
- c. Lake and Fountain Management Service Agreement:
  - 1. Gary motioned, with Stephen seconding, to approve Solitude Lake Management for an annual contract covering all lakes from May 1, 2025, to April 30, 2026, for \$6,948. This was unanimously approved.
  - 2. Gary motioned for, and Ruthann seconded, the approval of up to \$5,000 for a bathymetric study of Parrish Lake by Solitude Lake Management, which was unanimously approved.

#### IX. NEW BUSINESS

- a. Cleaning CH and HL Pickleball and Tennis Courts: completed/closed
- b. Porta Potty at Harvest Lake Recreation Area: removed due to lack of service and will not be replaced.
- c. Board Training will be held on Monday, April 21st, at 6 p.m. All homeowners are welcome to observe.
- d. Fix the common area lights behind Hamlet Court: Gary made a motion, seconded by Ruthann, to approve Price Electric for \$3,976.71 to repair the Hamlet Court lights, retrofit the common area, and address subassociation light issues. The motion was unanimously approved.
- e. The sign stating "No Fishing" from the bridge in the Smithy Glen area was completed for \$186.37 and is now closed.

- f. Increase the court key fee from \$4.00 to \$5.00 to cover the cost. Gary made the motion, which Ruthann seconded, and it was unanimously approved.
- g. Remove leaning tree in common area behind 269 Belmont: Motion by Gary, seconded by David, to approve emergency removal for \$1,000 by Rusty Tree Service, unanimously approved.
- h. Ad Prices for Coventry Newsletter: Ruthann proposed a reduced fee of \$10 for business card-sized ads in the July-September newsletter. Ruthann approved the motion, which was seconded by Gary and received unanimous approval.
- i. Hampton, Virginia Current Swim Team Proposal to Rent HL Pool: Gary motioned, and Theresa seconded a request for the year-round swim team to use the pool from June 3 to August 4 for \$450—the motion passed by a vote of 3 to 2.
