Using a leash and picking up after your dog are not only CHOA mandates, but also important steps in being a good neighbor. <u>Picking up after</u> your pet helps keep our community clean and enjoyable for all. It's important to remember that our actions impact those around us, and it's our responsibility to be considerate of our neighbors who walk the paths and the children who run and play in the grassy common areas.



Leashing your dog is the best way to ensure the safety and well-being of your beloved pet. By using a leash, you can prevent your dog from running off into dangerous situations or getting into conflicts with other animals. It also shows respect for your neighbors and their property because you are in close proximity when your dog requires you to pick up remains. Demonstrate your love and care for your furry companion, while also being a considerate member of the community, by adhering to the Community Rule and keep your pets and neighborhoods safe by always using a leash.

Smithy Glen governing document titled "Design Document Smithy Glen HOA Sub", Use restrictions, para G, page 8, Animals, states:

No animals, livestock, or poultry of any kind shall be raised, bred, or kept upon any Lot or within any townhouse thereon or in the Common Area, except such dogs, cats, or other household pets as may be permitted by the rules and regulations adopted by the Association. Homeowners are restricted to two four legged Pets. *The document also clearly states that* No animals should be allowed to run free. All dogs must be on a leash.

SMITHY GLEN FENCE COLORS SG Has Approved 2 Stain Colors

Smithy Glen Resolutions and Policies Document, #2015-2, FENCE Colors, Dated 24 March 2015, requires all residents to weatherproof fences with <u>only Olympic</u> <u>Elite Semi-Solid Sunset Canyon stain and sealant in one</u> to maintain a uniform appearance. During the Pandemic, Home Depot, the main local supplier of this product, could not maintain this stock, so the Board added an additional fence stain color for community use: <u>Sherwin</u> <u>Williams SuperDeck Oil Based Semi-Transparent</u> <u>"Riverwood"</u>.

If your fence has faded over time to a warm brown, or a cedar or reddish brown, similar to the top picture, it's time for you to restain your fence. The canyon sunset semi-solid color is the color of dark chocolate (a freshly stained fence using the Sunset Canyon semi-solid stain is shown in the bottom picture.) Please note that during the next few months, <u>inspections will include a</u> <u>review of your fence stain color to</u> <u>ensure all fences are consistent</u> <u>with either approved color.</u> Now is a good time to take advantage of the warm summer weather to bring your fence color into compliance.

WHERE CAN I BUY EXTERIOR PAINT? And Match The Approved Building Color?



If you are looking to paint the exterior of your home (shutters, doors, facia boards, garage doors) you can stop by the office to request the color swatch. Please note that all of our Coventry colors are on file with Yorktown Sherwin Williams, Home Depot, and Lowe's

to help you with your paint purchases. The base for all colors has changed so the paint sealer will have to color match the sample on file at the office.

GARBAGE TOTES

Follow the Schedule and Properly Store Your Tote

Our documents require all residents to put their garbage totes out NET 5pm on Wednesday Night and to take them back in NLT 7pm on Thursday. Totes should be kept inside a privacy fence, shed, garage or other screened area.



If you know that your neighbor is elderly and has a hard time handling the large totes, or is sick, or on vacation, please be a good neighbor and give them a hand by bringing in their trash tote for them. Doing a good deed is good for the heart!

As a reminder, GFL will not pick up garbage bags left on the ground next to your totes. However, they will pick up the extra bags and bulk items such as leaf bags, shrubs, carpet, and many types of furniture for a small fee. Call their Customer Service Department, Mon-Fri, 8am-4pm, at 757-487-2020, to coordinate this service.

SMITHY GLEN ROADS ARE PRIVATE Reserve Funds Are Used To Pave Roads and Courts

The cost of Paving Roads, Courts, and Parking spaces is managed by the SG HOA. Due to the large cost of road upkeep, roads throughout our area are paved on a rotational basis. Last summer Crescent Court, and 24 parking spaces on Wrought Iron Bend were paved.

This summer we anticipate having sufficient funds to resurface Monument Court and the remaining parking spots along Wrought Iron Bend. Residents will be notified when the paving is scheduled so that they can find alternate parking on paving days and schedule deliveries accordingly. Thanks in advance for your cooperation!

Smithy Glen HOA Dues are currently set at \$151.00 and are due on the first day of each month. A \$25 late fee will be applied to all accounts not paid on or before the 16th.

PREPARING TO SELL OR LEASE YOUR HOME? Both Actions Require Board Coordination

Spring often means the buying and selling of homes. If you are embarking on a new adventure and will be moving, remember that PODS portable storage containers require coordination and permission from the Board and can only be placed in your driveway or in your parking space. You must fill out a Community Action Form and submit to the office several weeks before delivery of the POD for approval.

Also, should you lease out your home, you must notify the Office of your forwarding address so that you will be sure to receive all SG HOA notices and Annual Reports that are mailed to the homeowners.

SMITHY GLEN ROOF REPAIRS Reserve Funds Are For Lifecycle Replacement

There have been many inquiries lately about roof repairs. The Board published a revised **Responsibility Maintenance Chart** that provides residents with the breakdown of responsibilities for repairs of the townhomes. The SG HOA programs Reserve Funds (part of your monthly assessment fee) for the Lifecyle Replacement of the roofs, however, all routine upkeep and repair of the roofs, skylights, and gutters is the responsibility of the homeowner.

SMITHY GLEN HOME REPAIRS

The Reserve funds that the Board Collects and manages covers several items, to include painting of wood railings, shutters, wood porch posts and repair of some of these items when they rot. However, if the wood rot is due to homeowner neglect like clogged gutters which rots out the wood behind, or even the front posts, the homeowner will be responsible for those repairs. Please make sure you keep gutters clear, and wet items off the front porch railings, this will prevent wood rot.

Within the next month we'll be starting the painting back up as the weather warms up. Courts are on a 3-3.5 year rotation for paint. Before your house is attended to for paint, our company will do a quick power wash, trying to eliminate and mildew from the unit. On the off years, the homeowners are responsible for ensuring the house is free of mildew – this saves the life of your siding.

THE YORK COUNTY TREX RECYCLING PROGRAM

The York County Beautification Committee collects plastic bags and wraps to participate in the Recycling Challenge, hosted by The Trex Company. Participants collect plastic



bags and film with the goal of collecting or exceeding 500 pounds of plastic in a 6-month period. If the goal is met the group is awarded an earth-friendly Trex bench, created from recycled plastic bags

and film. This is an ongoing program, and benches are donated to local schools, libraries and public county areas. To date, York County has been awarded with **9 benches**!
