Coventry Egg Hunt

The Coventry Spring Egg Hunt, a more than 30 year tradition in our neighborhood, will be held again this year on **Saturday**, **April 19th**, **2025** at the Clubhouse. The hunt is cosponsored by CHOA Social Committee and Kitty Holzbach, Keller Williams Allegiance. There will be more than 2500 filled eggs. They are filled with Easter candy and you will want to make sure the contents are appropriate for your child.

The event will begin **PROMPTLY at 10** am. Traditionally the egg hunt is over in just minutes, so if you arrive even a minute after 10 am it is likely all the eggs will be gone.

The egg hunt is for Coventry children ages birth to age 10/5th grade. There is a special area only for children 3 and under where parents may assist. Children ages 4 to 10 will hunt without parents in the large area, unless your child has special needs requiring a parent to assist.

Vandalism is Everyone's Problem


Vandalism in Coventry is significantly increasing, and your dues are paying for the repairs for the damages caused, generally by unsupervised children and teens who live in our community, and their friends.

Many families in Coventry have raised kids here, and there has always been vandalism – bikes stolen, cars driven on the grass, trash thrown in the lakes ... But recently, unsupervised children have destroyed the rip rap in the lakes, making them unsafe and expensive to repair, kicked out railings on the bridges, used fishing hooks to ensnare wildlife, thrown rocks to break the shells of turtles, used implements to break the wooden walkways on bridges, tearing up the pool fencing, and have been seen being destructive to common areas in a myriad of ways.

One way we can combat this destruction is to issue fines to the adults responsible for the offenders. The board frequently receives reports of witnessing the damage being done, and generally Coventry residents want the common areas protected and kept in good repair. When the damages involve safety concerns, it limits access and availability of the areas. The cost of repairs diverts funds from the needed projects in the budget to repairs of damaged areas.

If you see damage or vandalism, please provide any information you have to the Coventry office so we can look into it and try to identify the offenders. If you observe a crime or vandalism occurring, consider calling the York County Sheriff and making a report. Make sure you do not put yourself at any risk of harm or retaliation.

We will be installing security cameras and will make every effort to identify offenders. If it is your child or their friends know where they are and what they are doing. Don't be caught by surprise by a knock on the door from the sheriff.





In the summer it is common to see teens and children set up an old fashioned lemonade stand to make a little money. Growing up, many of us did the same thing. So what is the problem? The Virginia Department of Health states that basically, lemonade stands are actually illegal in Virginia! Really???

In fact, there are only 14 states that allow lemonade stands, and Virginia is not one of them. The Virginia Food and Drink Law requires permits and inspections and states it is unlawful to operate without them. Fines will be issued to violators. This includes any food or drink, including from your home, that you make, process, pack or sell.

The law does not just pertain to lemonade. It is any food or drink. Many of us set up our kids with selling cookies and koolaid at yard sales, but this is not permitted under the Virginia laws that govern these sales.

To apply for a temporary Food Establishment Permit, you can complete an application and fee of \$40, at least 10 calendar days in advance of the day prior to your sale. The local health department will approve or disapprove the permit. Cottage food laws offer some exemptions, and you will want to check with the VDACS Food Safety Program at foodsafety@vdacs.virginia.gov

Please let your neighbors, teens and children know that lemonade stands/food and drink sales in Coventry are not permitted to avoid any fines or bad feelings.

Pool Hours

Closure Policy

The pool will close at 3:00 PM on days when there are home swim meets. Dates of the meets will be posted at both pools.

Management may close the pools due to inclement weather, safety concerns, operational difficulties, emergencies, or other causes outside our control. Management will enforce procedures for lightning and thunder based on rules established by the American Red Cross and the National Lightning Safety Institute.

- 1. Rainfall: All swimmers may remain in the water upon rainfall.
- Lightning: The pool and deck areas will be closed upon the sight of lightning and remain closed for 30 minutes after the last sight of lightning. The Harvest Lake pool deck area includes the breezeway.
- Thunder<u>The</u> pool and deck areas will be closed upon the sound of thunder and remain closed for 30 minutes after the last thunder sound. The Harvest Lake pool deck area includes the breezeway.

Pool Rules

The following rules are for the protection and benefit of all and to ensure the safe and sanitary operation of the pool facilities. Your cooperation will afford everyone pleasant relaxation and recreation. Parents are requested to caution their children to observe rules and obey lifeguard instructions. Any failure to comply with these rules shall be considered sufficient cause for the pool manager to deprive members of using the pool.

- All persons using the pool do so at their own risk. The Association assumes NO
 responsibility for any accident or injury in connection with such use or for any
 loss or damage to personal property.
- Persons using the pool agree not to hold the Association liable for any actions occurring within the pool area. Members are also responsible for the actions of their children and guests.
- All persons shall obey the instructions of the lifeguards. No person shall use the pool unless it is officially open and a lifeguard is on duty.
- Persons must stay clear of the lifeguard stations and not loiter at the check-in desk.
- Children 12 years and under must be <u>accompanied</u> and supervised by a responsible person 18 years or older while swimming in the pool. The pool manager can certify that children between 10 and 12 are able swimmers to attend alone. The pool test must be done each year. This policy applies to members as well as guests.
- <u>Persons</u> unable to demonstrate their ability to swim are not permitted in deep water.
- 7. All persons must shower before entering the pool.
- Admission shall be refused to all <u>persons</u> with colds, coughs, inflamed eyes, infections, infectious diseases, or wearing bandages.
- Infants and <u>toddlers</u> not potty trained are prohibited in the pools unless they wear swim diapers.
- 10. Glass containers and breakable objects are not permitted in the pool area.
- All trash and refuse must be placed in the provided waste containers. All
 members are urged to assist in keeping the pool area and shower rooms clean. 13
 Chewing gum and blow pops are not allowed in the pool and restroom.

- 12. Footwear is not permitted near the pool edge or ladder for safety reasons.
- Audio players will only be used with earbuds or headsets to avoid disturbing other patrons.
- 14. No smoking or vaping inside the pool fence and entrance areas.
- 15. No pets are permitted inside the pool fence area.
- 16. No play equipment or playpens are allowed on the pool deck.
- 17. No food or beverages are allowed in the pool or near the pool's edge.
- No intoxicating beverages or intoxicated persons are permitted on the pool deck.
- No articles or toys will be thrown in or around the pool area. Dive sticks and toys of the same idea will be dropped, not thrown into the pool.
- 20. No running, pushing, dunking, rough play, or profane language will be permitted in the pool area. Standing or sitting on another's shoulders is not allowed. Spitting water and similar non-hygienic actions are not permitted. The lifeguards will determine the use of tubes, rafts, etc., based on the crowd's size and character.
- 21. The pool operation hours are noted elsewhere in this publication. Hours are subject to change based on swimmer demand and guard availability. The Pool manager, CHOA Board members, or management may close the pool at any time due to operational difficulties, inclement weather, or professional discretion in resolving situations they deem to pose a risk to patrons.
- 22. Coventry Homeowners Association is not responsible for personal property lost, damaged, or stolen in the pool facility. The pool staff will hold "found " articles for two weeks before disposing of them.

Enforcement Policy

The Master Board has instituted the following enforcement policy to be implemented by a Board Member, Pool Manager, or Lifeguard:

First Violation - Suspension of pool privileges for 2 to 7 days.

Second Violation - Suspension of pool privileges for 8 to 30 days.

Third Violation - Suspension of pool privileges for the entire season.

Guest Policy

Coventry has adopted the following policies for guests using the Association's pools. In all cases, pool members are responsible for their guests' compliance with Coventry rules.

Members' guests will be permitted to use the pool only when signed in by a member who is over 18 years of age. Each member over 18 is allowed five (5) guests. Each guest will be charged a fee of \$5.00 per day and must register with the gate guard upon arrival. Members must accompany their guest(s) at all times.

Out-of-town families visiting for one week or more will be charged a fee of \$15.00 per person per week. Passes will be available from the CHOA Office. Please notify the office of the visit dates at least 72 hours in advance. Houseguests issued passes may attend the pool without their host if they are 18 or older.

Working parents with a daycare provider may include the provider's name on the registration card, noting that they are the provider. The provider will be issued a special pass allowing them to accompany the dependents to the pool. Only one daycare provider pass is allowed per family.

Updated rules and policies***

- Members over 18 may have 5 guests per day, \$5 each guest per day
- Members with a daycare provider may have a pass for the provider to accompany member's children
- No beverages or food at pool side or in the pool
- No footwear at the pool side (do not leave your shoes near the pool)
- No smoking, vaping or alcohol on the pool premises
- No public music or speakers (use headphones or earbuds)
- No throwing of objects in the pool (balls or other objects from one person to another)



Springtime in Yorktown

Coventry is located in York County, a history filled area of the Virginia Peninsula area of Tidewater. There are many activities in and around the area you may want to enjoy or bring your visitors!

The American Revolution Museum at Yorktown is FREE for York County Residents, as is the Jamestown Settlement in Williamsburg, VA. Both are living history sites run by the Jamestown Yorktown Foundation.

Chilled Ponds, the Ice Rink located behind Kroger on Victory Blvd also has free skating for York County residents on Wednesdays and Fridays mid day sessions.

Yorktown Market Days on Saturdays include a Farmer's Market of fresh local produce, homemade goods, crafts and live music with waterfront views.


Book a sail on the Schooner *Alliance* at the Yorktown waterfront, relax at the beachfront, or dine at one of many locally owned restaurants or patronize one of many small businesses .

Visit the Yorktown National Battlefield Park, the Colonial National Historical Park or the Jamestown Island for walking or bike trails, and enjoying our natural scenery.

Visit local wineries and breweries, and attend seasonal events like Blues, Brews and BBQ Festival, the Yorktown Wine Festival, or Art at the River. Spring festivals like the Gloucester Daffodil Festival April 5th and 6th are popular during the season.

In late May to early June see (but don't pick!) the protected Yorktown Onion in the fields along Water Street and the battlefield. The Yorktown Onion is not native, but is from the 'Olde World' and is unique to our area.

SPRING HOMEOWNER INSPECTIONS

No one likes to receive a door tag to keep up with the requirements of homeownership in Coventry. Here are some common areas to address:

- Pressure wash siding / driveway
- Weed garden areas
- Keep trash receptacles hidden
- Keep front yard and porch area free of stored items (toys, tools, debris)
- Insure exterior changes from original home are ARC approved
- Paint faded and chipped areas
- Insure campers, boats, large vehicles and non operable vehicles are not visible
- Keep exterior in good repair, no broken or torn or worn elements, including mailbox
- Keep garage doors closed when not in use

Failure to correct infractions can result in fines Let the office know if you need an extension
