7th ANNUAL MEETING
November 4, 2018

The meeting was called to order by Alice Cooper, President of the UCOG Board of Trustees. After quorum was called, Donna Sue Weaver, UCOG Prayer Chaplain, opened with a prayer.

Alice Cooper introduced the current members of the Board of Trustees: Yolanda Logan, Dean Saulmon, Trish Phelps, Eugenia Koog, Brenda Ford, and herself. The minutes from the 2017 annual meeting were approved.

Dean Saulmon, Treasurer of the Board of Trustees, reported that although he needed to project the last three months (through December 2018) of income and expenses, he expected a net income of more than \$3,000. He proposed the budget (shown below) for 2019, based on the current financial status and performance of the church in 2016 through 2018. He pointed out that the church was due for an audit of the church's procedures, which will cost about \$4,000 in 2019.

Alice Cooper discussed the updating of the church's bylaws, scheduled in 2019, to bring the church into compliance with Unity Worldwide International's requirements.

Alice called for volunteers to serve on the 2019 Nominating Committee for filling positions on the Board of Trustees to be elected in the 2019 UCOG Annual Meeting next November. Yolanda Powers, Dave Jenks, and Pat Armour volunteered to serve.
