#### Old Business:

*AAUW Revote Update:* Becky Hamner was unable to get results of the possible change of the 4 negative votes cast.

*Title IX*: Becky Hamner reported that Pat Drouin met with LUSD Asst. Supt. Dawn Vetica to share the five Title IX proposals for the District passed at our last general meeting. The proposals were well received and now need to be presented to the Superintendent's Cabinet.

*Bunco Fundraiser*: Ronda Mettler thanked everyone for their support. A new pod has opened and needs a leader. Joanne Cobb reported the kitchen sub-committee has made good progress with set-up and clean-up. Just a few more food items are needed; a sign-up sheet was passed around. Dr. Bill Herrin will speak at our March  $20^{\rm th}$  meeting about "Economic Impact of Immigration on the United States". Immigration is a widely debated topic here in the United States. Bill will try to bring some perspective to the impact of immigration on our society today and in the future.

Dr. Herrin is the director of the School of International Studies (SIS) and the Alexander R Heron Professor of Economics at the University of the Pacific. Bill has been an Economics professor at UOP since 1985 and the Director of SIS since January 2013. He teaches microeconomics, econometrics, housing economics, and development economics.

Dr. Herrin was a Fulbright scholar at Makerere University in Kampala, Uganda for the 1994-95 academic year and again for the 1999-2000 year. He has published a number of academic articles on the boundary of housing economics, household migration, health economics, and development íssues.

Bill received a B.S. in Business Administration and Economics from Wilkes University in Wilkes-Barre, Pennsylvanía (1980) as well as an M.A. (1982) and Ph.D. (1986) in Economics from the State University of New York at Binghamton. He currently resides in Stockton.

### HISTORY OF WOMEN'S SKI JUMPING:



Women have been ski jumping for more than 100 years. While it's arguably the dream of every elite athlete to represent her country at the Olympic Games, that opportunity did not exist for women ski jumpers

around the world. Ski jumping and Nordic combined, which consists of cross-country skiing and jumping, were the only events in the Olympic Winter Games in which women were not allowed to compete.

In 1991, the International Olympic Committee (IOC) announced that all future Olympic sports must be opened to both genders; however, this excluded the original sports at the inaugural Olympic Winter Games in 1924, including ski jumping.

These skilled athletes ski down an in-run at 60 mph and can fly farther than the distance of a football field. But early on in the push, some considered that women's bodies couldn't handle the sport - not unlike what was said in the 1970s and 80s about women marathoners.

In 2006, the IOC executive committee turned down the International Ski Federation's (FIS) overwhelming recommendation that a women's ski jumping event be added to the 2010 Games in Vancouver.

For 10 years, female ski jumpers were continually denied inclusion in the Games despite pushing their sport through the system and greatly increasing participation.



Feeling as though they had exhausted every avenue, Americans Lindsey Van, Jessica Jerome, and retired jumper Karla Keck, risked their careers and teamed up with 12 women jumpers from five countries to sue the Vancouver Organizing Committee (VANOC) in 2008 for their right to compete in the 2010 Olympic Winter Games. The lawyers for the jumpers, Ross Clark and Jeff Horswill of Davis LLP, took on the case pro bono.

The historic human rights legal battle resulted in the British Columbia Supreme Court declaring in 2009 that the IOC exhibited gender discrimination by excluding women's ski jumping from the Vancouver Games, but stopped short of forcing VANOC and the IOC to hold an event for women.

Ironically, before the Winter Games in 2010, Lindsey Van held the K95 Vancouver hill record of 105.5 meters, for both men and women. That distance would have earned her a podium spot in the men's competition in the Vancouver Games.

On April 6, 2011, the IOC finally announced that a women's ski jumping event would be added to the 2014 Sochi Olympic Winter Games program. The women have one event — normal hill competition. The men have three events (normal hill, large hill, and team competition). WSJ-USA leaders continue to lobby to reach parity in ski jumping in the Winter Games.

### Be Informed!

Hearing Loss and Treatment Options was the topic for our February Be Informed meeting. Dr. Robert Hanyak, Associate Professor and founder of the Doctor of Audiology program at UOP's San Francisco campus and Jan de la Cruz, an Audiology Resident at the UOP Hearing & Balance Center were the presenters. A Power-Point presentation educated us on the physiology of the ear, described various types of hearing loss, discussed testing procedures, and showed the variety of choices that are now available in hearing aid devices, including recent advances in that technology. There were many questions asked and answered, and we left with gift bags. It was a very interesting and worthwhile morning.

Our next meeting is March 1<sup>st</sup> at 10 am, at the home of Élise Forbes. The speaker is Dr. Kenneth Mullen, long-time Lodi physician, who will talk to us about palliative care. # Public Policy Report:

While there are several issues affecting women, teens, and young girls today, one that goes unnoticed is the effect of student loans. It is well known that loans are making it extremely difficult for students once they graduate. They struggle economically, emotionally, and sometimes physically due to their overwhelming debt.

But AAUW has drawn attention to the fact that women have more difficulty paying back their student loans than men. Because women are paid less and take out more money, it takes longer to pay back the government.

According to Michelle St. Clair, public policy director, AAUW members can help by:

- 1. Ensuring Pell-Grants are available to all low-income students.
- 2. Pushing State and Federal legislators to increase funding for state colleges and universities and push for tuition-free education.
- 3. Writing letters to the Department of Education regarding making it easier for women to enroll in income-driven repayment plans.
- 4. Discussing the needs of non-traditional students, such as those with small children, who also have to pay for child care.
