

Camper's Agreement

(terms and conditions of stall rental, camper responsibilities)

- All bookings are to be paid in full at the time of confirmation via etransfer to wilsoncreekretreat@gmail.com
- 2. There is a minimum two-night booking requirement.
- 3. You may cancel with full refund up to 14 days prior to the reservation start date. Where there is less than 14 days to the reservation start date, a refund rate of 50% will apply. Cancellations with less than 48 hours notice are non-refundable.
- 4. Check-out time is noon. New arrivals are welcome by 1400 hrs (2pm).
- 5. A maximum of one trailer/RV/unit is allowed per stall. One additional tent may be allowed. Please inquire at the time of booking. Vehicle and trailer license plate numbers must be provided prior to arrival.
- 6. Campers are subject to all government issued fire bans. The onus is on the camper to ensure they are aware of current fire bans.
- 7. Firewood may be purchased on site. Firewood is sold at a rate of \$25 per wheelbarrow. etransfer and cash are the only forms of accepted payment.
- 8. The hamlet of Rosebery is located nearby. Quiet time is in effect at 2300hrs (11pm).
- 9. This is the wilderness. Several species of wildlife frequent the area, including bears. You must manage your garbage and belongings accordingly. Proper wilderness etiquette must be practiced at all times.
- 10. Pets must be kept secured by either a leash or in a kennel and attended at all times. Please ensure you have cleaned up all of your pet's droppings.
- 11. Wilson Creek Retreat is a cannabis free environment. When using regular tobacco and vaping products, please be courteous to your neighbours at all times. Under no circumstances are cigarette butts to be discarded on the ground. You must bring with you a receptacle to manage your cigarette butts.
- 12. All bookings must be accompanied by a signed Camper's Agreement. This will be provided to you 14 days prior to your arrival. If you are booking the entire site, the main booking contact will be responsible for ensuring all camper's have read (and agree to) the Camper's Agreement.



- 13. No garbage is to be left behind at the time of checkout. Garbage and other discarded items such as recyclables, must be properly disposed of by guests. To note, Rosebery Landfill is located minutes away and is open on Wednesdays and Saturdays from 9am-3pm.
- 14. When you enter West Wilson Creek Road from Highway 6, do not proceed past the entrance to the campground! There is no suitable turn-around farther up the road. As you enter West Wilson Creek Road, the entrance is on your immediate left. You must "reverse" into the campground and then into your designated stall. Please refer to the site map to ensure you have set up your camp in the correct location.
- 15. The area in under video surveillance at all times.
- 16. The main booking contact for your reservation must agree to and sign the legal waiver below.

This Agreement is for the benefit of and is binding upon the undersigned camper and Campground. I acknowledge that I have read the entire Agreement and understand and agree to comply with all the provisions in this Agreement, the Campground rules and conditions and that the Campground is not responsible to me, my family or associates for any injuries suffered or loss due to theft, hydro loss, fire, winds, floods or other nature acts which are beyond the Campground's control of which the Campground is not responsible, liable for or negligent.

The Campground is privately owned and the Campground and its management reserves the right to evict any resident at any time without refund for contravention of rules, non-payment of fees or any act that threatens the peace and quiet of the property of the Campground.
