

By-Law's


 A.3 "Subsequent regular annual Members meetings will be held on the first Saturday in June in July."

Covenants

- 2.1 "Members of the Board may serve on the Architectural Control Committee."
- 4.7 "No leases or rentals of any residence and/or guest house shall be permitted unless approved by the Board of the Association or a hardship of the Owner."
- 4.8 "The exterior construction of any building must be completed within one year from the date of commencement of the construction."
- 4.14 "Leaves, brush or other debris may be burned only in a safe and proper manner and in accordance with the rules and regulations promulgated from time to time by the Architectural Central Committee as governed by local city and county government officials (Fire Marshall, County Commissioners)."
- 4.16 "Domestic pets may be kept on the Property provided that the same are maintained within an approved enclosure or controlled on a leash or similar restraint."
- 4.22 "No mercury or sodium vapor, nor LED, security lights on poles shall be allowed."
- 4.25 "No antenna shall be greater than ten (10) feet above the roof, nor shall any antenna be visible from any roadway permitted."
