COMMUNITY

Our staff recently sat down and pondered the question, "What would happen if Community Partners wasn't here tomorrow? What effect would that have on the communities we serve?"

In thinking about the consequences, an estimated 10% of the Two Harbors area population would lose access to their groceries & meals, transportation to medical appointments, care coordination, and the crucial support offered even by the simple act of calling our office. We ended up concluding that Community Partners is an integral part of the community.

The good news is, we aren't going anywhere any time soon. We are excited to continue providing these services, especially as the population in Lake County continues to age. Even more exciting, in 2020, Community Partners will celebrate 20 years of service to older adults and caregivers in our area!

Even so, we still need YOUR help. Community Partners needs diverse sources of funding in order to thrive. We receive grants which help to fund special projects, provide supplemental support to current programs and our part-time staff, and keep the lights on... but in the big picture, we also need donations and program fees to keep us going. So, how can you help ensure CP is here for the next 20 years to provide these services? Here are a few ways:

1. If you receive services, please help share in the cost. Grants do not cover all our costs. Many people don't realize that Volunteers aren't free. Volunteers help lower costs substantially, but they are valued at \$26/per hour (due to training, insurance, gas cards, recognition, etc.) We never want fees to be a barrier to receiving our services, but helping to share in the cost of services helps everyone.

CAREGIVER CORNER

By Linda Kinnunen, Caregiver Consultant November is National Family Caregiver Month! Who are they and why celebrate them?

Caregivers are people who help their family, friends, or neighbors who are 60 years of age or more and need help to live safely in their own homes. For instance, 75 year old Frank (not real person) cares for his wife around the clock in their home because she has Alzheimer's Disease and cannot be alone. Down the block from this couple, Lizzy (not real person) picks up groceries for her 68 year old neighbor who returned home from knee surgery and cannot drive. According to the Minnesota Board on Aging, there were about <u>585,000</u> informal (unpaid) caregivers like Frank and Lizzy who were caregiving for older adults in 2018.

Every caregiving situation is different, but the common factor is that lives are changed...and along with that comes more responsibility. Caregivers may see themselves taking on new roles that they are not comfortable with. A father who cannot make his own decisions any longer may ask his caregiving son "when did you become my parent?" Caregivers often feel anxious or frustrated having to take on more tasks which can take them away from taking care of themselves.

Family caregivers are the most valuable resource for helping our aging population live well and thrive at home. Here's a sobering fact: one in three caregivers die before the person that they are caring for, because they are not taking care of themselves! Community Partners Caregiver Support Program is here to help caregivers along their journey. We listen to each caregiver and help them make a plan of care that fits their situation. Often we will start out with suggesting just one thing that may take a load off of the caregiver's plate. It may be as simple as setting up Meals on Wheels or offering a weekly friendly visit from a respite volunteer for the care partner at home, giving the caregiver a break.

Among our many services, Community Partners offers a Caregiver Support Group once a month. This is a great place for Caregivers to tell their story in a comfortable and confidential setting. Participants will often say that they wish they would have joined this group earlier because everybody understands what each other is going through. This group truly "takes care of the caregiver" by sharing, listening, offering compassion, and believe it or not...laughing together!

3. After you have registered, please call us at least 3 business days before you need the ride, so that we can find a driver for you. For example, if you need a ride on a Monday, we need a call no later than the Wednesday before (assuming no holidays fall on that Thursday or Friday). Really, we'd love it if you'll call us 2 weeks ahead of time! The earlier we know, the easier it is to schedule the ride. (That said, we will still wait until the week of the ride to call you with your driver's name

4. In order for our Volunteer to safely transport you, you must be able to get in and out of the

5. Do not give money to Volunteers, please. We send out "Cost Share" Letters at the beginning of the month, which include a list of services that you have received in the previous month, the "cost share" amount we ask you help cover, and any money we received from you in the prior month. Services will not be denied due to inability or unwillingness to pay. Community Partners runs on gifts, grants, cost sharing and donations; we trust that our Participants value our services, and will pay as they are able. Remember, when you share in the cost of services, it ensures that we're able to help seniors for years to come.
