- We are close to 100% for vehicle maintenance for the year, and the truck is still having issues. Autoworx is going to do a free diagnostic assessment. We may need a backup plan if there are significant expenses for this 25-year-old truck.
- Our CD will be renewed at 3.75% APY. Whitney made a motion to renew the CD. Seconded by Mary. The motion passed unanimously.
