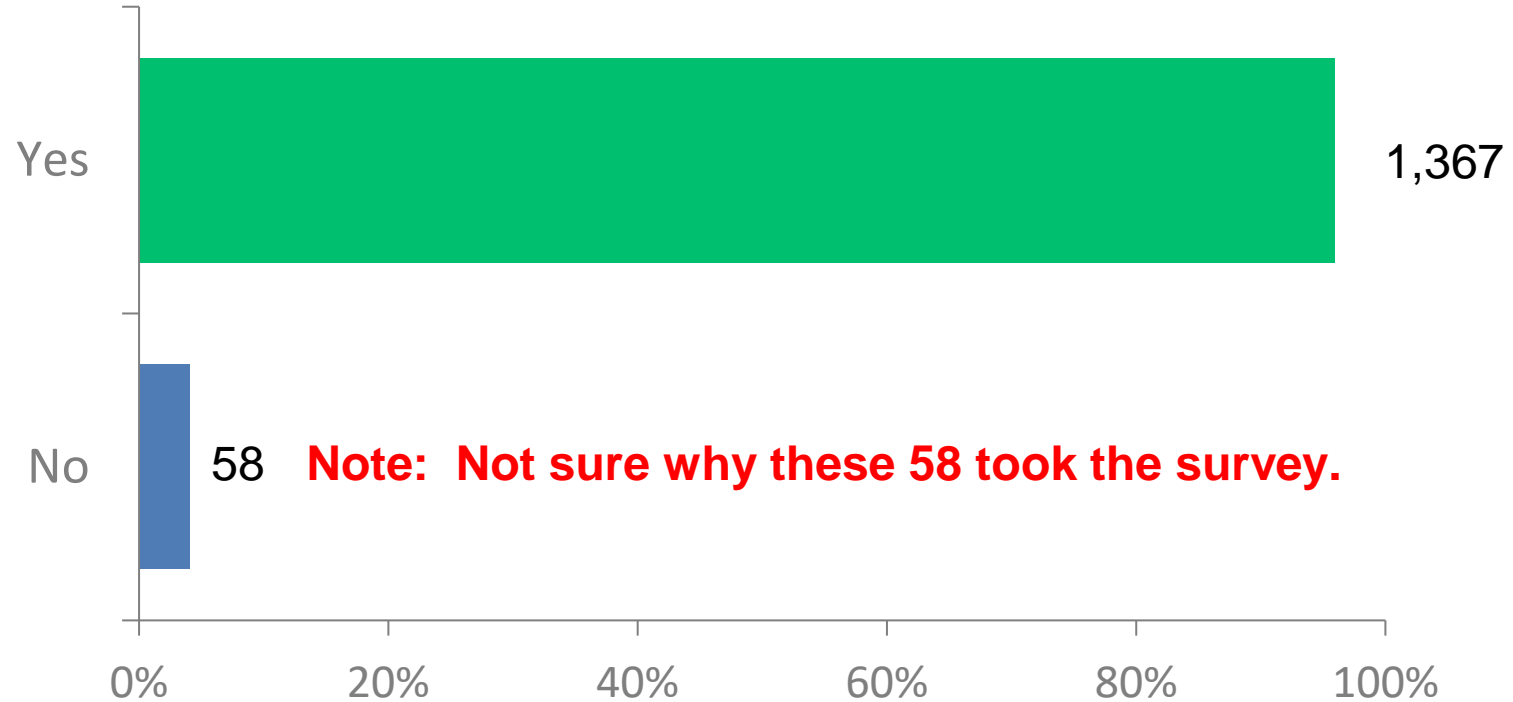

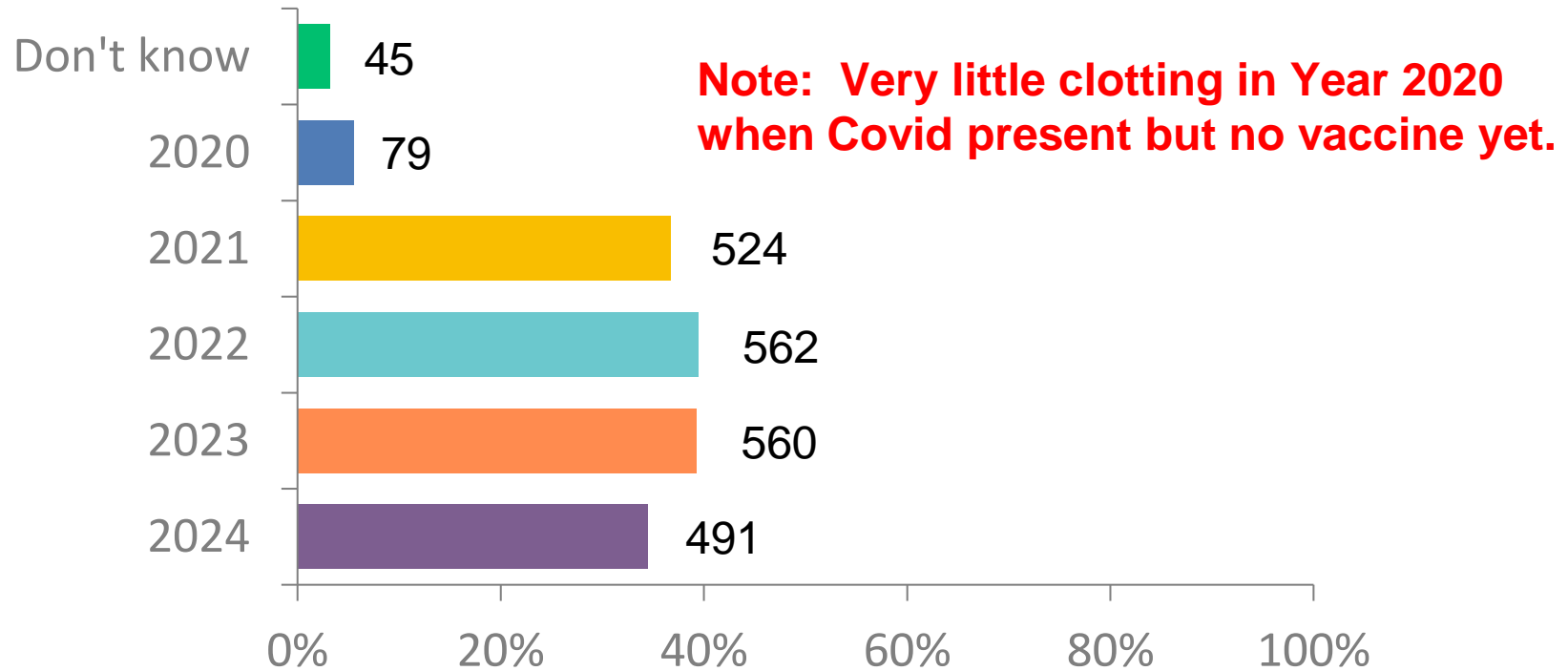

## Q2: Have you or anyone that you know had blood clotting issues that started after January 2020?

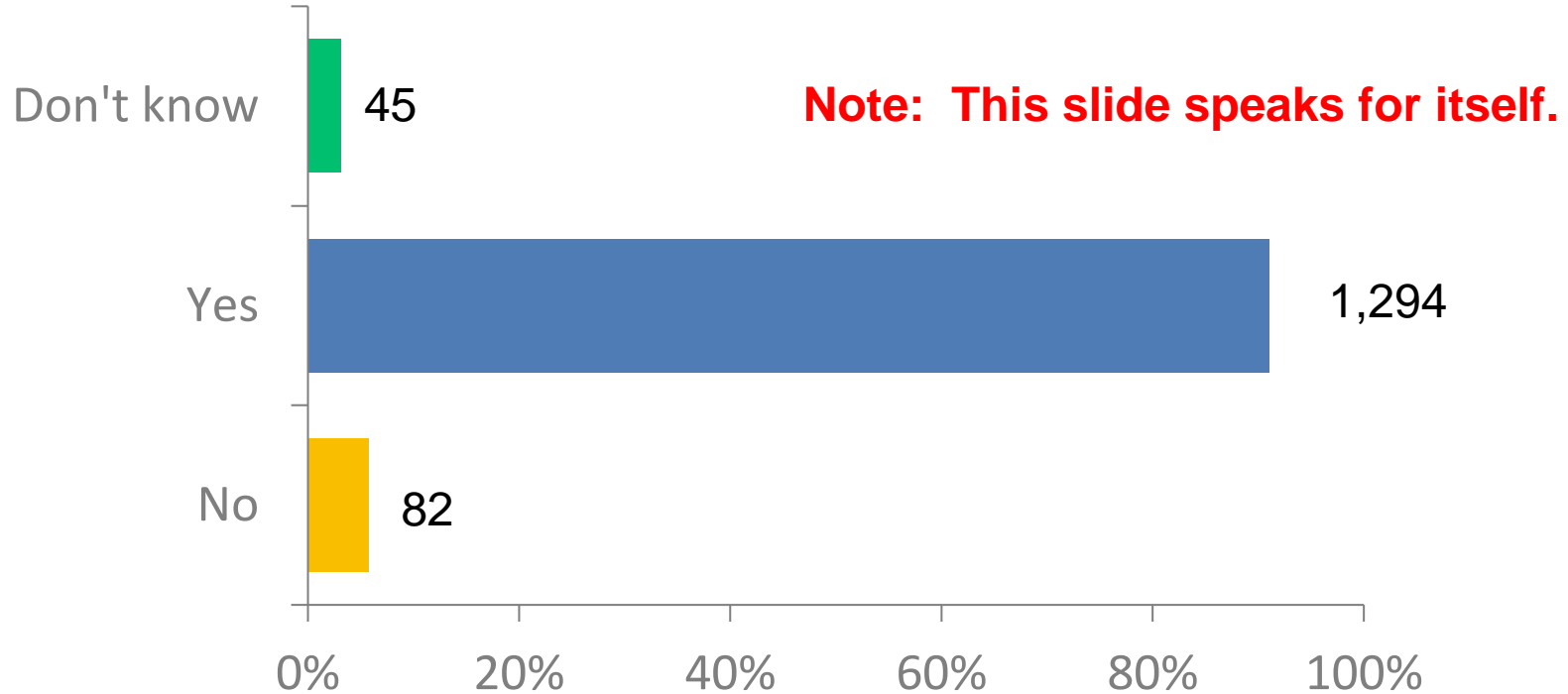

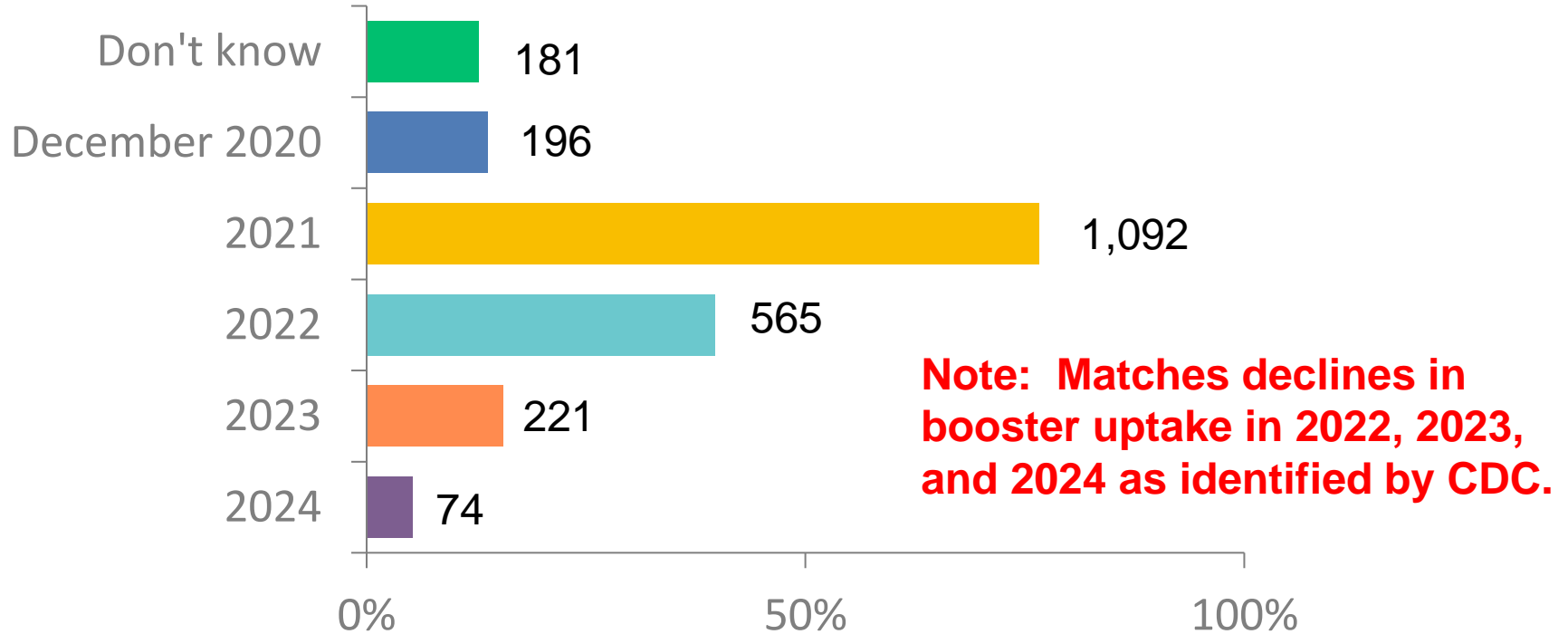
### Q3: What years (mark ALL that apply) have you or the person that you know had these blood clotting issues?



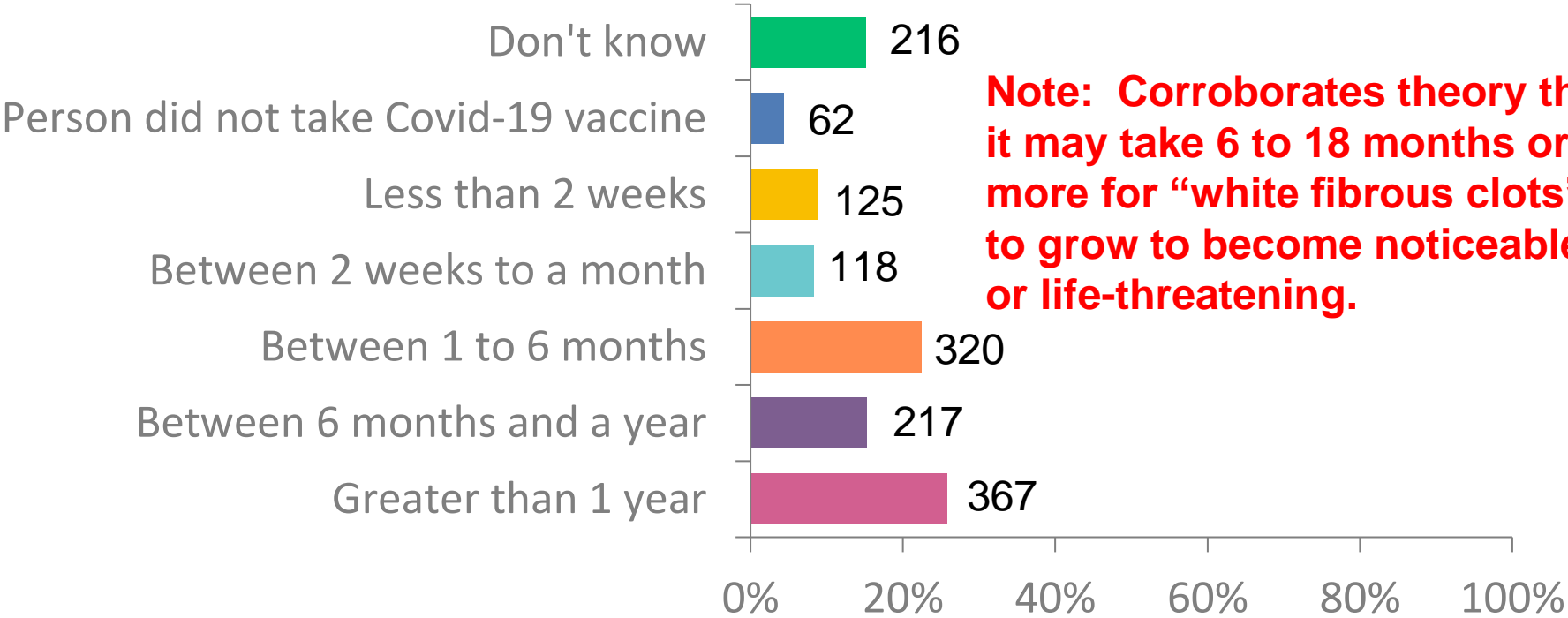
## Q4: Did the person with the clots take the Covid-19 vaccine?



## Q5: What years (mark ALL that apply) did the person with the clots take the Covid-19 vaccine?



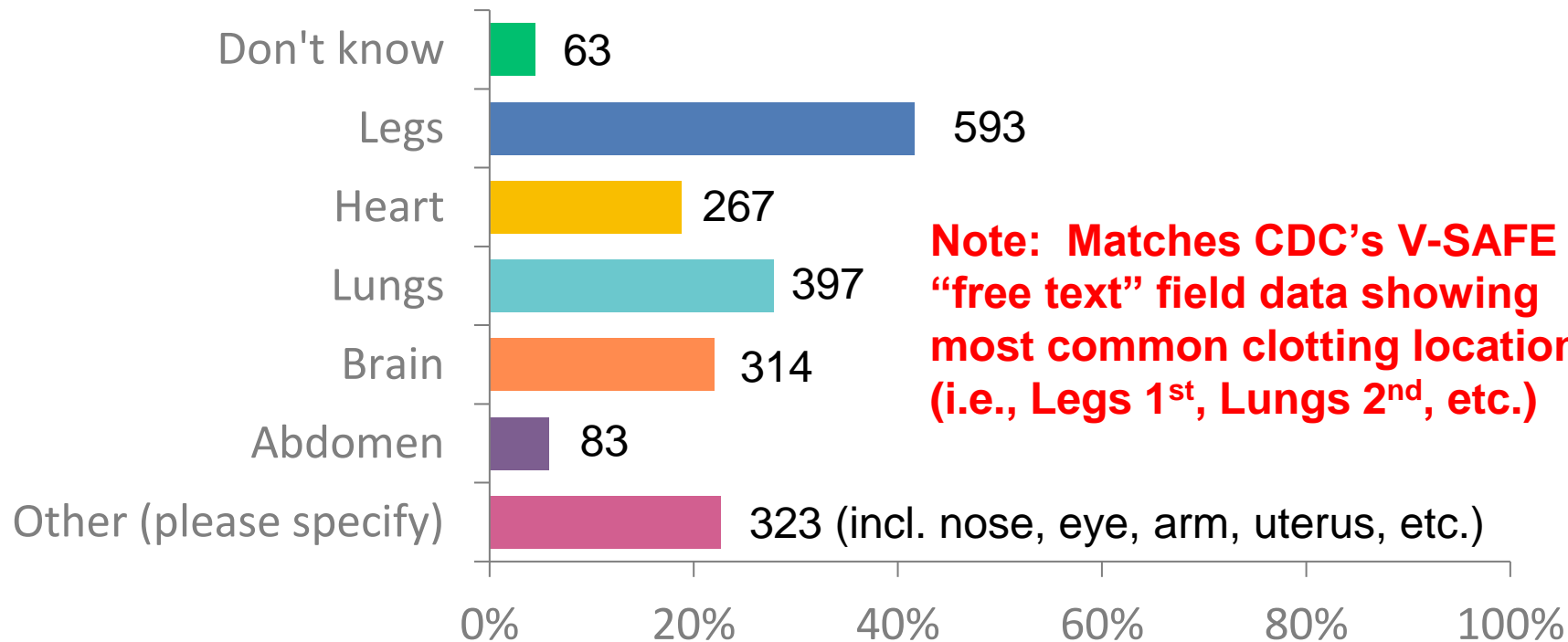
# Q6: How soon did the person develop the blood clotting issue after taking the Covid-19 vaccine?



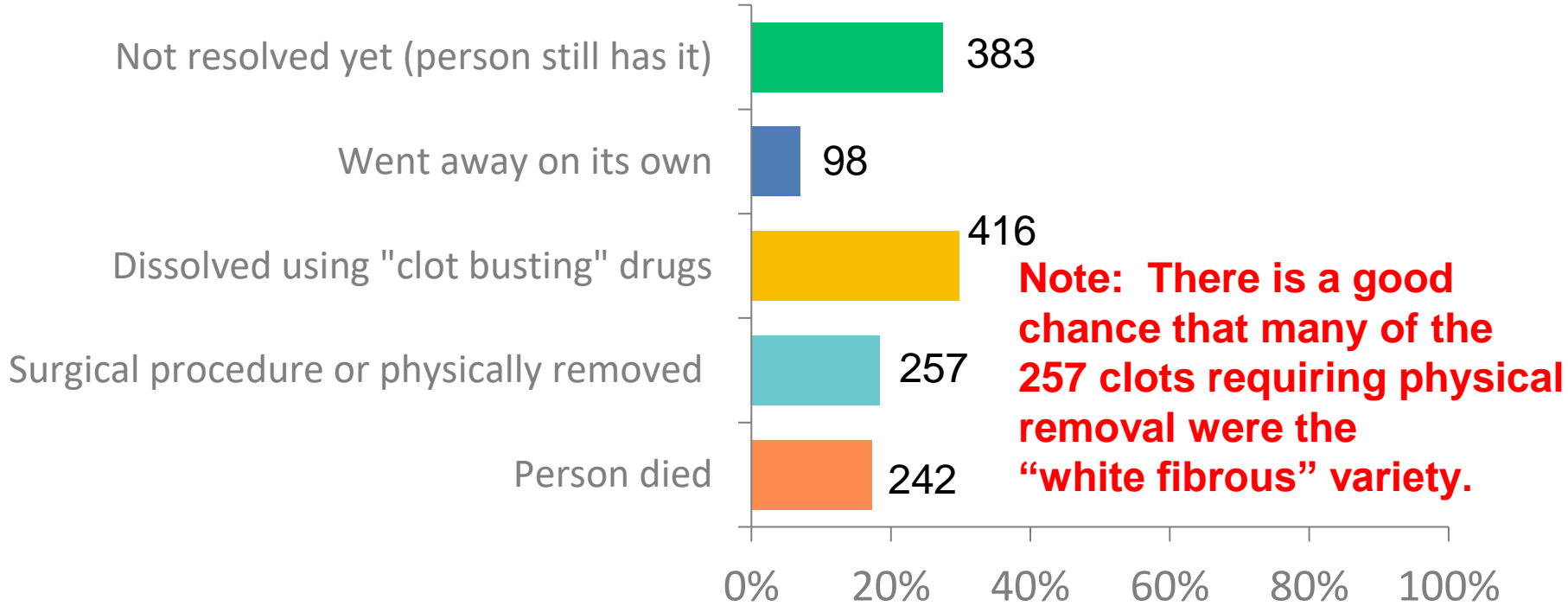
**Note: Corroborates theory that it may take 6 to 18 months or more for “white fibrous clots” to grow to become noticeable or life-threatening.**



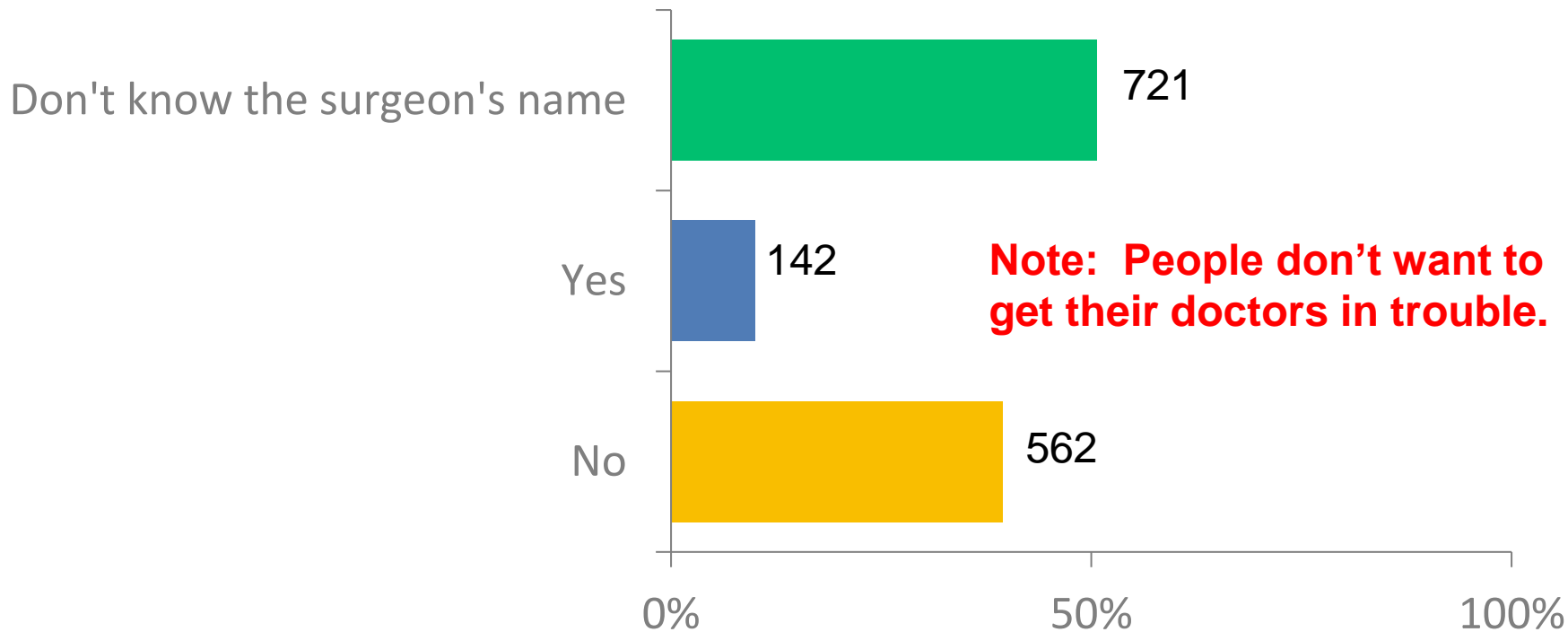
## Q7: The blood clotting issue was in what part of the body? (Mark ALL that apply)

# Survey (Comments Section)

My mother had 3 covid vaccines all Pfizer vaccines. She was healthy and had a stroke and coded in the hospital and died within 5 days. The funeral director is a good friend of the families and informed us and showed us the white fibrous clots that were throughout her body. He told us they were seeing a lot of these types of clots while embalming.

My mom never had clotting issues before this incident, then only two weeks after receiving the COVID shot she was taken to the ER for multiple clots that developed in the same arm she received the COVID shot.

Surgical nurse seeing a huge increase in clots We are doing more amputations than I've seen in my whole career I am definitely seeing the clots you are describing when I say it is probably due to the Covid shot everyone ignores me and there is silence in the operating room. I also hear the surgeons saying I've never seen this before Also, during heart surgeries, the surgeons are having difficult time suturing as the tissues are just falling apart Once again, the surgeons are saying I've never seen anything like this before A lot of the patients are dying.

I was feeling fine. Had pain left side below shoulder blade. Started sweating and feeling weak. Called the ambulance. ECG did not show heart attack. Rushed to emergency. ECG did not show heart attack. 3 different emergency Dr did ECG and Ultrasound. They were all perplexed. A cardiologist was called. I went sent to Heart institute. Arriving there I went into cardiac arrest. Was out 2 minutes. 3 sets of compressions and 4 defibrillator shocks used. They went in through artery at the wrist. They removed fibrous clot. They did not want to tell me but a nurse whispered to me: it is the vaccine. We have so many. Follow up appointment with cardiologist, I asked the question directly. Dr looked down and said, I cannot talk about it at The risk of loosing my job.

My daughter died SUDDENLY at age 45 in Sept 2022. She was an athlete & her heart stopped while working out. She was an ER RN & mandated to take the bioweapon & all boosters. While on life support they found a “blockage” just outside of her left ventricle. She suffered severe brain anoxia & was removed from LS. My Son in law thought my insistence that this was from the bioweapon was complete lunacy. An autopsy was not offered & she was cremated the next day. My family has no history of heart issues. My daughter was an active, 100% HEALTHY, clean eating mother of 5. She was murdered.



I work fitting patients for compression garments. Most clots are in the legs, but several have expressed that the clots extended into their groins, stomach, chest, and one that went into the person's neck from their foot. Most have had clots removed and are now wearing very tight compression to prevent new clots. I have fit men for medical pantyhose (this was rare before). My business has increased three times to what it was in 2023 and the number of young people are shocking. Very few people have told me their issues are old or long standing - most have never had problems before. Only one revealed their job status and they were jabbed/boosted. Many say the clots came on suddenly. There is a definite pattern.

June my wife of 43 years submitted herself to the Covid vaccine following the advice of Government/Medics and my insistence. June was an award-winning career SRN/RGN and died aged 66 years. This occurred very suddenly in front of me while June was on the phone to a friend. June collapsed at the kitchen table. I administered CPR (retired Police Officer). June began to breath again but stopped again. Paramedics arrived administered Adrenalin and defibrillator but June was pronounced deceased around 6:45 pm on Wednesday 8 December 2021. The event occurred 14 days after her latest Covid shot which was the Moderna vaccine. A PM was conducted and thrombosis, myocardial infarction and heart failure listed as cause of death. No mention of Covid vaccine.

I began experiencing seeing what looked like chevrons in my left eye beginning about a week after my booster or 3rd shot. While driving I suddenly began to lose vision in my left eye. I pulled into a parking lot and lost complete vision in my left eye. It gradually returned fully after 10 minutes or less. My Cardiologist put me on Xarelto and a 81mg baby Aspirin daily. His idea was that my Retinal Artery became occluded by what he called Micro Emboli.

Person was 68 and totally healthy. The reactions in the eye were not seen before. It hurts inside the eye. There was a bloodstream block inside the eye nerve. Any linkage to side effect were denied and was made impossible to talk about. The function of the eye was back to 60% and won't be better again. In Holland nobody dares to speak about this problem. This person got the advice to keep on having his next vaccination for covid. He was himself in denial, but is not going to have his next jab. All people in Holland have a letter with the advice to go for a jab again.

My Aunt had a stroke and was dead within a week. I also had another Aunt and good friend both got multiple shots (Aunt in nursing home) now they have Afib. Co-worker died within a year of getting shots with Glioblastoma. I have had other friends die suddenly. I work as a Medical Coder for an ER dept. and have seen a huge difference in young people with Chest pains/heart issues. Lots of people with DVT's. Many more young people with cancers. So many more things than before. I didn't take the shot-was required with my job but got an exception. I no longer have faith in doctors/hospitals etc. Thank you for all the work you are doing!

After shot I had horrible migraines, brain fog, and a TIA. My d dimer was over 1800 at that point- previously it was in the normal range. I started taking aspirin immediately after TIA symptoms. Began fasting, cold plunges, nattokinase. Several d dimer labs showed my values slowly dropping as time went on. It took three years for my d dimer to return to normal. I had only the first shot ( part one of two part shot) Pfizer batch ER8721 which was associated with extremely high Adverse Reactions. I suffered many other horrible symptoms and nearly died. By the grace of God and prayers answered I am still here. My health is much improved but my memory isn't what it used to be and my autoimmune diseases became more pronounced. I'm so grateful I was not more seriously harmed. I will never again go against my instincts or let myself be bullied into something I have serious reservations about.

2 bad batches of Moderna in summer 21. Allergic reaction after first shot, overall decline in health began soon afterwards. Went from normal 20-something female to disabled, no longer able to work, using walker or wheelchair. No diagnosis until tested by Dr. Jordan Vaughn in early 2024: Stage 4 of 4 significant and widespread amyloid fibrin micro-clotting. Iliac vein compression syndrome, POTS, numerous other muscular and neuro symptoms. Spike protein count of almost 13,000. Been under treatment with various drugs/supplements/blood thinners since early 2024, but still disabled.

I'm an RN working Interventional Radiology. Jan 7, 2022 we had emergency procedure to remove right leg blood clot from a Japanese male in his late 70's. On assessment no pedal pulses or any other pulses including femoral pulse using ultrasound. His leg was about 4 x size of left leg. We called in the vascular rep who had new Corkscrew like drill to assist with removal. It went up through his abdomen and was like nothing any of us had seen. I took pictures per my radiologist request. I'm not sure if he survived or further outcome. He went back to ER to wait for ICU bed. Also nurse friend ended up with occluded right carotid artery approximately 1 1/2 year after receiving Johnson and Johnson. Has been on eliquis but recently had left great toe amputated. Will try and send picture to your email of clot(s) removed.



I suffered a left thalamic ischemic stroke shortly after receiving the Pfizer COVID-19 vaccine. The stroke occurred on April 30, 2021, 18 days after the vaccine was administered on April 12, 2021. The stroke resulted in significant medical complications, including physical impairments. At the time, my doctors did not initially suspect any connection to the vaccine, at least not during 2021 and 2022 I have since moved onto other specialist, and many say that they have been exposed to many people complaining of vaccine related symptoms. I am a 33-year-old Navy air traffic control veteran and worked for the FAA. I'm married with three children, and unfortunately, this stroke led to the loss of my job.
