Lake Freeman Water Levels

The amount of water discharged by Oakdale Dam from Lake Freeman won't change — for now.

A U.S. Court of Appeals decision published Friday provided no clear victories for stakeholders on Lake Freeman who contend that the U.S. Fish and Wildlife Service ordered too much water being released from the lake.

Under normal conditions, John Koppelman previously said, the Tippecanoe River and its two dams operate on a run-of-the-river plan. This means that the water released from Oakdale Dam is supposed to match the water released into Lake Freeman from the Norway Dam.

Koppelman is chairman of the water level committee for the Shafer & Freeman Lakes Environmental Conservation Corp., which argued Oct. 5 in front of the U.S. Court of Appeals against the U.S. Department of the Interior, Federal Energy Regulatory Commission and Northern Indiana Public Service Co.

The court ruled against the Shafer & Freeman Lakes Environmental Conservation Corp.'s argument that the Fish and Wildlife Service's calculations about how much water to release from the dam is set too high. The corporation contends the calculation is an error. The court said it wasn't.

After endangered mussels were discovered downstream from the Oakdale Dam during the 2012 drought, the U.S. Fish and Wildlife Service ordered more water to be released from Lake Freeman.

It pressed its new calculation of how much water to be released through the Federal Energy Regulatory Commission, which has oversight over Northern Indiana Public Service Co.'s operations of the Oakdale Dam on Lake Freeman and the Norway Dam on Lake Shafer.

This summer's moderate drought, combined with the Fish and Wildlife Service's prescribed release of water from Freeman, caused the lake water levels to dramatically drop beginning in August.

By September, water levels were so low that the lake became unusable for motorized boats.

By the end of the year, Lake Freeman was more than 12 feet below normal.

The winter snows and rains replenished the deficit, and water levels are back to normal —

for now.

The upshot of the U.S. Court of Appeals decision is that the judges ruled that U.S. Fish and Wildlife Service is only allowed to make "minor" changes, Koppelman said, citing the ruling.

"(T)he court felt that both agencies, Federal Energy Regulatory Commission ... and (Fish and Wildlife Service), failed to determine if Fish and Wildlife Service's requirements were a "minor" change to the operations of the Oakdale Dam," a news release from the Shafer & Freeman Lakes Environmental Conservation Corp. states.

"And thus, is sending the case back to Federal Energy Regulatory Commission ... to determine if (the Fish and Wildlife Service's) Technical Assistance Letter makes only a 'minor' change to Federal Energy Regulatory Commission's staff alternative."

"All this damage from the water levels being down last year will show this was anything but minor," Koppelman said Wednesday morning during an interview.

"(Federal Energy Regulatory Commission) has the authority to amend the license to implement the Staff Alternative," the Shafer & Freeman Lakes Environmental Conservation Corp. new release states. "That would be a significant relief to the Monticello and Twin Lakes community."

The federal commission's "staff alternative" was more in line with Shafer & Freeman Lakes Environmental Conservation Corp.'s proposed release of water, Koppelman said. But for some reason, the commission ignored the staff alternative and approved the Fish and Wildlife Service's prescribed release from Oakdale Dam, Koppelman said.

"Despite significant expert testimony to the contrary, we are disappointed that the Court felt (Fish and Wildlife Services) acted reasonably using the linear scaling method. Moving forward, we are hopeful that what happened to Lake Freeman in 2020 will illustrate to FERC that the changes are anything but 'minor'," said Gabrielle Haygood, Shafer & Freeman Lakes Environmental Conservation Corp. executive director.

Koppelman said the court will issue a mandate for the Federal Energy Regulatory Commission to rehear the issue of how much water to release and whether it is a minor adjustment.

In the meantime, Koppelman said the local lakes' corporation is asking stakeholders to contact federal lawmakers — Rep. Jim Baird or Sens. Todd Young and Mike Braun.

Advanced Sailing Terminology

Definitions for sailors with some experience.....

Calm - Sea condition characterized by the simultaneous disappearance of the wind and the last cold beverage.

Course - The direction in which a skipper wishes to steer his boat and from which the wind is blowing.

Crew - Heavy, stationary objects used on shipboard to hold down charts, anchor cushions in place and dampen sudden movements of the boom.

Gybe/Jibe - A common way to get unruly guests off your boat.

Telling stories - A fairy-tale begins 'Once upon a time...' A sea story begins 'So there I was...'

Anchor light - A small light designed to discharge the battery by morning.

Baggywrinkle - The effect of sun and salt spray on your face.

Bitter end - The finish of a race when you are last over the line.

Chart - A type of map which shows exactly where you are aground.

Clew - An indication from the skipper as to what he might do next.

Emergency mooring lines - Old ropes too rotten to use regularly but too good to throw away.

Estimated position - A place you have marked on the chart where you are sure you are not.

Rope ladder - A ladder designed to get you into the water but not back out.

Spinnaker - A large sail used in dead calms to keep the crew busy.

Tell-tale - A crew member who lets the guests know that the skipper usually gets seasick.

Pulpit - somewhere you go to pray you are going to pick up a mooring buoy.

Tabernacle - something similar to pulpit, but a different religion.


