I have heard Julie say in other proceedings that the forum is ministerial.

Why is public notified and why is their legitimate input not considered?

Should owners (even individual) not have input on the as-builts to ensure fidelity to district rules and actual site conditions? The defects in the Sierra Ranches stormwater flowage, drainage and retention body (primary function) doubling as a wetland preserve (secondary function) requires disclosure per Florida laws and will have a significant diminutive effect in Sierra Ranches.

Chad mentioned during the bond release that he just relied on what the surveyor sent him and did not cross check in the field. Neither did the district engineer.

But I alerted the district to the 10 foot minimum depth of excavations below control water elevation in September 2023. Hans, Chad and Ashley came on site to meet me and Pillar Consultants on September 20th, 2023. Hans even mentioned in email before that date that if remediation had to be done, Chad would be responsible for it; so it was definitely on the books.

It appears that the CBWCD commissioners don't take valid, substantiated, professional resident input and make arbitrary decisions based on my observations in the three Sierra Ranches bond release hearings, and several other meetings I attended before that.

Appreciate an answer on the legal category of noticed bond release hearings. There has to be one.
