(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

Event #11070. This is a BWC incident. During patrol A/os conducted a leads inquiry of the above listed vehicle which resulted in the vehicles vin, make and model being a stolen vehicle out of Lansing Michigan on 08-jan-2025 from Coast Motors LLC. A/os activated emergency equipment and curbed the above listed vehicle at the above listed address. During investigation Above subject related that he bought the car from Detroit Michigan and drove it here, and put the vehicle in his friends name , which is the registered owner of the listed illinois plate. Oemc confirmed the vin was a match, at this point above subject was place into custody and transported to the 009th district station for further processing. at the station A/os contacted the Victim/ owner of the Coast Motors, who related that a male hispanic came and purchased the vehicle with counterfeit money and a fake ID and he made out a report with Lansing PD. He further related that he wished to have the vehicle towed and wished to proceed with charges but can not come to the station to sign today. During search of the arrestees belongings for inventory purposes A/os located another Venezuela ID card with his photo on it but with the name [REDACTED] which is the name of his friend that the registration of the illinois plate comes back to as well as a copy of a Michigan title for the vehicle. Miranda rights were read in Spanish to the arrestee by P.O. I. Madrigal #14015 on BWC at 2008 hours. Above arrestee agreed to answer questions and related to A/os that the person who the vehicle is registered to is his friend and lives in Texas but has no way in contacting him and related that he personally bought the vehicle but used his friends name. A/so asked about the ID Found in his wallet and he related that it is his picture with his friends Name on it and was used to register the vehicle and purchase the vehicle, and did not know he could not use fake Identification. interviewed ended at 2011 hours. Per the requested of the complainant A/os signed on the complainants behalf complaints for criminal trespass to vehicle. Above arrestee also has a Suspended Illinois Drivers license. Fake ID, and other documents with the vehicle information on it along with the name [REDACTED] where inventoried as evidence. prisoner personal property inventoried under #15678910, Prisoner jewelry inventoried under #15678907, and evidence inventoried under #15678913. Above arrestee also has two tattoos on his left arm one of a Lions face, and a clock, which are commonly used by the Tren De Aragua transnational Criminal Organization. A/os were unable to make contact with lanning Detective at this time. Above arrestee has \$280 USC on person. name check clear. No wants or IAS. Not on parole or probation. Vehicle toed under SS#008851. Driving on a suspended license citation number #TZ-095-845.

Event#07491, BWC activated. In summary, the above listed victim [REDACTED], [REDACTED], had been relocated to the 008th district police station earlier on today's date (27 Jan 2025) by CPD Officer Garza #8667 assigned to beat 0832 due to a domestic battery that had occurred under RD#JJ128933. In this report, [REDACTED] had related to officer Garza #8667 that Jorge had struck [REDACTED] about the face with an open palm strike. Jorge had also grabbed [REDACTED] by her hair and forcibly pulled, causing [REDACTED] pain. [REDACTED] related that Jorge was her current boyfriend. [REDACTED] remained at the station awaiting to be transported to her mother's residence to gather her belongings. While awaiting transport, [REDACTED] related to station front desk officers that the named offender in the aforementioned RD#, Jorge Luis Meza Ramos, was at the station attempting to get belongings from [REDACTED]. [REDACTED] then relocated outside the front lobby of the station where she was approached by a male subject, now known to be Jorge. Sgt. Brittain #1504, who was stationed at the 008th district lobby at the time and was aware of the circumstances of the domestic battery, observed the male speaking to [REDACTED], who appeared to be heavily distraught during the conversation. Believing this to be Jorge, Sgt. Brittain #1504 and A/Os relocated outside the station and placed the male in handcuffs, detaining him. As A/Os were approaching the two, A/Os overheard [REDACTED] relate not verbatim towards Jorge in Spanish "Let me go let me go. I want to go with my family". A/Os confirmed the male subjects identity as Jorge and placed him in custody for the domestic battery that had occurred earlier. Upon seeing A/Os enact the arrest on Jorge, [REDACTED] became highly distraught and related that she did not feel well. A/Os requested an ambulance where [REDACTED] was transported to Holy Cross via CFD AMB#75. A/Os also observed what appeared to be red markings around [REDACTED]'s neck. Due to [REDACTED]'s sudden departure from the scene due to medical reasons, A/Os signed complaints on [REDACTED]'s behalf. Upon doing a custodial search of Jorge, A/Os observed what appeared to be a clock tattooed on Jorge's left forearm. Just beside this was a tattoo of the letter "A". A/Os also observed two five pointed stars tattooed on Jorge's left hand. It should be noted that although Jorge denied gang affiliation, all of Jorge's tattoos are synonymous with members of Venezuelan gang "Tren De Aragua".

It should be noted that PO Carey #18795, who had been working at the station front desk at the time, had observed Jorge exit the drivers seat of a motor vehicle that had been in motion just prior to the altercation between Jorge and [REDACTED]. Jorge also self admitted to R/Os that he had reached the 008th district station by driving himself, despite also admitting to R/Os that he did not possess a valid drivers license. Jorge was issued citation #TZ-143-038 for operating a motor vehicle without possessing a valid driver's license. Jorge's belongings inventoried under inventory#15673171. A/Os notified evidence technicians at 1830 hours to photograph the red markings around [REDACTED] neck. A/Os attempted to notify IUU of the event however were unable to make contact at this time.
