Arresting Officers observed a white Jeep Grand Cherokee driving south on Halsted St from Garfield Blvd overtaking a sedan on the right in a single lane of traffic (citation #tz-140-212). Arresting Officers obtained a Texas License plate of [REDACTED] from the white Jeep as the vehicle pulled into a parking spot, failing to signal at 5612 S Halsted St (tz-140-213). Arresting Officers activated emergency equipment and conducted a traffic stop on the vehicle. Arresting Officers met with the driver of the vehicle, Pedro M Garcia Torres, and asked for a Driver's license or Identification card. The driver provided a Venezuelan identification card with his photo on it spelled as Garcias Torres, Pedro Miguel. Name check revealed no valid driver's license in the state of IL (citation tz-140-215). Plate inquiry of the vehicle revealed the Texas plate of [REDACTED] to be registered to a white toyota out of Texas. Arresting Officers asked the driver for proof of registration which the driver produced a photocopy of the certificate from the state of New York. VIN inquiry was performed and revealed the Jeep to have no registered owner out of NY (tz-140-214). Arresting Officers placed Pedro Garcia Torres into custody for operating a motor vehicle while Possessing Title/Registration not authorized on vehicle. Beat 725 transported the Arrestee into the 007th district station for processing. Arrestee has no valid insurance (citation tz-140-216).

Arresting Officers discovered the arrestee's name obtained an extra letter (S) on his ID card in Garcia. Name check via hot desk revealed the arrestee to have an [REDACTED] failure to appear, for driving without a Driver's license and operating an uninsured vehicle by ISP Joliet, Lea [REDACTED] Extradition notified at 0032hrs hold number issued #h06516 by McCarthy.

No gang card on file but arrestee has a known "Tren de Aragua" Venezuelan gang tattoo on his left lower arm of an AK47, no investigative alerts.

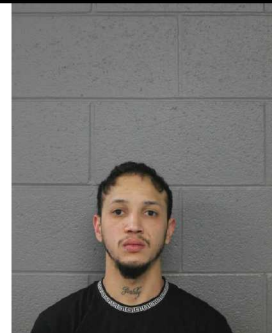
