1. Breeder guarantees the above described puppy is purebred and is able to be registered under the above listed registry. Registration is not guaranteed; sometimes the kennel clubs will not register puppies/dogs.

2. Breeder guarantees this puppy is in good health and free from any contagious diseases upon this date.

3. Breeder cannot guarantee the adult size, conformation or color. This depends, in part on how the puppy is raised and cared for; although dogs are bred to meet conformation.

4. Buyer may have the puppy/dog examined by a licensed veterinarian of his/her choice within 48 hours of final purchase/possession transfer to ensure current health status. The breeder is not responsible for any health issues detected after 48 hours unless determined to be hereditary. If the problem is hereditary, the buyer may return the puppy for an exchange of equal value. If an equal value pup is unavailable, but a higher priced pup is, buyer shall pay the difference in price. Two descended testicles is guaranteed in male **show dogs only**.

5. Buyer shall assume the full responsibility for the health, veterinarian care, temperament and appearance of the above described puppy upon possession transfer.

6. **Buyer agrees to maintain the dog in good health** with regular immunizations, de-worming, and medical care & maintain this dog in a healthy environment at all times, I.E., adequate food, exercise, kenneling, medical care, and proper living conditions to achieve full genetic potential.

7. The actions and upbringing of the dog is the responsibility of the buyer. Under no circumstances is the breeder to be held responsible for the dog's actions or temperament. The purchased puppy was bred for good temperament, but the breeder cannot be responsible for the actions of others in the upbringing of the purchased puppy.

8. Buyer agrees that the purchased puppy will never go to a rescue center, animal shelter or pound. Buyer agrees to give the breeder first right of refusal to take the puppy/dog back

or allow the breeder to assist in placing the puppy in a new home. Should the buyer sell the puppy (at any time in the puppy's life) without breeder's first right of refusal, then the puppy shall be returned to the breeder with no monies refunded. In the instance that the breeder shall find one of the breeder's puppies/dog for sale, then the buyer agrees to relinquish said puppy back into the possession of the breeder immediately. Breeder reserves the right to enforce this contract in a court of law. If it is necessary for the buyer to relinquish ownership of the puppy/dog immediately, the breeder agrees to take possession of the puppy/dog (with no monies refunded) and place the puppy/dog into a new home. Fees incurred by the breeder for replacement for the puppy/dog shall be the responsibility of the buyer to reimburse to the breeder. This may include, but not limited to, advertising, boarding, medical attention, etc. Should the above owner pass away, the family may return the dog to the breeder at any time with no monies refunded nor will the family be billed for fees incurred by the breeder for placement of the dog. 9. Buyer agrees at no time shall this puppy/dog be used for illegal purposes; the breeder retains the right of repossession immediately, with the dog's registration.

10. Buyer agrees that with the purchase of any show/breeding quality puppy, the breeder **reserves the right of co-ownership**. Co-ownership is described as the breeder shall place their name and address first on the registration before it is provided to the buyer and the buyer shall become the co-owner until agreed upon conditions are met. (Co-ownership applies to show/breeding stock puppies/dogs **ONLY**) **If the buyer has purchased a non-breeding stock puppy, "AKC Limited Registration" will be given to the buyer.** 

- 11. Buyer agrees to be added to a referral list for the breeder.
- 12. In respect to a co-owned dog:
  - A. Owner agrees to never breed without prior approval from breeder.
  - B. A bitch shall be bred to a stud that breeder agrees upon.
  - C. Owner agrees to show dog as often as possible; if show dog is purchased.
- 13. Puppies are guaranteed to not have genetic hip dysplasia and other joint problems for a period of two years. To receive this guarantee the owner agrees to promptly send digital pictures of the puppy every 3 months from the date of purchase for the first year and every 6 months for the second year. Owner further agrees to feed the puppy/dog at least premium dog food and to keep the puppy/dog in good physical condition and at the proper weight. Owner may choose to bring the puppy/dog to the breeder for inspection instead of sending pictures. (Foods like PuppyChow, Beneful, Ole Roy, lams, Pedigree, Science Diet, etc are not premium food and are in violation of this contract.)
- 14. Owner agrees to have the puppy spade or neutered by a licensed veterinarian within 9 months of purchase. Written proof of this being done by a licensed veterinarian will be required before AKC papers will be released to owner. This does not apply to show/breeding stock puppies.
