COURTS, STATE OF **ARIZONA**

Judges of the Supreme Court and the Court of Appeals are appointed to office by the Governor upon recommendation of a bi-partisan commission. The term of office of a Supreme or an Appellate Court Judge is six years. At the expiration of their terms, appointed judges wishing to remain in office have their names placed on the ballot for voters to determine whether they should be retained in office. Judges of the Superior Court in Yavapai County are elected in nonpartisan elections for a period of four years.
