August 26, otherwise known as Women's Equality Day, marks the anniversary of the certification of the 19th Amendment, which granted *some* women the right to vote in 1920.

In 2022, we declared this day to be Women's Inequality Day in the aftermath of the Supreme Court rollbacks of reproductive freedom (in *Dobbs v. Jackson Women's Health Center*) and the failure of Congress to pass voting rights legislation or add the Equal Rights Amendment to the Constitution.

One year later, we have seen the impact of the *Dobbs* decision on women and those who can become pregnant. We have seen anti-voter laws passed in states nationwide that could silence voters at the polls in the months ahead. And a century after it was first introduced, we are still calling on Congress to ratify the Equal Rights Amendment and make it part of our Constitution.

The fight for women's equality has always been grounded in the right to vote. When some women have fewer rights and access, we cannot call ourselves equal or celebrate equality.

This August, women are standing together demanding that our rights be restored, our voices be heard, and that we ourselves be seen and treated as equals in our democracy. Together, we have the power to create a more perfect and inclusive nation that celebrates our diversity and welcomes everyone to participate. We can create the change we need and want with the power of our votes.

The City of Prescott is requesting community input on updating of the General Plan and Historic Preservation Master Plan. An Open House is scheduled for Wednesday, August 30<sup>th</sup> from 3-6 pm at the Rowle P. Simmons Center on East Rosser Street requesting input on challenges and opportunities on the following topics: Circulation (movement of people, goods, and services), Economic Development, types of Housing, Land Use, and Public Facilities and Services.

The City of Prescott General Plan is a policy guide and provides a vision of what the City will become in 10 years. To guide us into these potential futures, the Prescott General Plan provides:

- A collaborative community vision;
- A collection of goals and policies to achieve that vision;
- A tool for decision makers, developers, businesses, and citizens; and
- A framework for general planning.

The current General Plan was adopted in 2015 and needs to be updated every 10 years. A reevaluation and calibration of goals and policies is necessary to ensure Prescott continues to grow in a sustainable way.

The City of Prescott Historic Preservation Master Plan was last adopted in 1998 and the goal of this project to have an up-to-date Master Plan that provides guidance for staff, Preservation Commissioners, developers, architects, and homeowners. Additionally, the end-product will be a plan formatted to allow for more frequent updates without having to undergo a major project or expense. This includes:

- Update the plan to reflect changes or additions to the Secretary of Interior's Standards and Treatments for Historic Properties
- Incorporate newer districts that have never been in the Master Plan
- Incorporate an Archaeology section
- Reformat to streamline and make more useful to property owners, staff, and Commissioners
- Public outreach and incorporation of the results of such.
- Publication of digital drafts of plan and limited printing for public outreach and review
- Launch Plan through Web-based applications and Arches data management platform.

### **League History – Candidate Debates and Forums – Part 2**

In 1987, the chairpersons of the Democratic and Republican parties announced their intention to sponsor their own debates. They encouraged the League and its nonpartisan, third-party perspective, by affiliation to stand aside. On September 28, representatives from the nominated Bush and Dukakis campaigns presented the League with an agreement that gave the campaigns the power to:

- Pack the debate hall with their own supporters and relegate press to the back two rows.
- Control the selection of the people who asked candidates questions during the debate.
- Determine the debate's format; Restrict what the television cameras could take pictures of during the debate.

In response, on October 3, 1988, the League withdrew its sponsorship of the presidential debate.

After withdrawing from the presidential debates, the League continued to sponsor debates, forums, and other opportunities for candidates on the state and local levels to speak directly to the public. In 2022, local Leagues across the nation held more than 3,075 candidate debates and forums ahead of the midterm elections. In 2022, our league held a debate between the candidates for State Legislative District 1.

We also held three forums for local elections. The League historically produced hard-copy Voter Guides. The development of the award-winning VOTE411.org website provides a digital platform where voters can find comprehensive voter guides where candidates can state where they stand on issues of importance to state and local voters.

### Report on the Indigenous Rural Action Summit in Kayenta

Loraine West, Director of Voter Services for LWVCYC, attended an Indigenous Rural Action Summit in Kayenta on July 22, 2023. The non-partisan event brought together nearly 100 people from grassroots organizations and the local community to network, learn, and share experiences related to voting rights, elections, education, and community outreach and solutions. A partial list of organizations attending the summit is provided below, if you are interested in learning more about them. Workshops focused on voter registration, voter turnout, and citizen participation as candidates for local offices. One participant spoke of the eagerness of senior citizens to participate by voting but that they faced language and literacy barriers. Her organization was translating ballots and candidate information into Navajo and then visiting senior voters in her community to orally share the information. During lunch, attendees heard from Arizona House Representative Mae Peshlakai and Arizona Senator Theresa Hatathlie, both representing District 6. It was rewarding to see so many organizations and people focused on voter participation.

### **LWVCYC Nonpartisan Policy**

The League of Women Voters of Central Yavapai County is a nonpartisan organization whose purpose is to promote political responsibility through informed and active participation of citizens in government and to act on selected governmental issues.

The League does not support or oppose any political party or candidates.

League members are encouraged to participate fully in all political activities available in our democratic process.

# Nonpartisan Policy for Members of the League of Women Voters of Central Yavapai County

### League Position:

Once a League (local, state, or national) takes a position on an issue, members may not identify themselves as League members in public expressing an opinion that is in opposition to a League position.

### Representing League:

Members representing the League in the community should be sensitive to their responsibilities. When acting in public as League representatives, members must not allow partisanship to be discernible.-

#### Serving on Commissions and Committees:

Members may serve on governmental commissions and committees at their own discretion. If the appointment is League-related, the appointee should be fully aware of the League positions as they relate to the commissions or committee's responsibilities, and regularly report to the Board.

#### League Meetings:

Members in leadership roles at general and other public meetings have the responsibility to ensure the nonpartisanship of the meeting and its environment. Only Board of Directorsapproved petitions may be circulated at League meetings.
