Thank you for your email. Our top priority continues to remain doing everything we can to keep every Angeleno safe as we navigate through what we hope is one of the final stages of this pandemic.

We are incredibly blessed to have access to vaccines that are extremely effective at preventing severe hospitalization and death -- and although it is possible for vaccinated individuals to become infected, the data is clear that the high rates of infection we are still seeing are directly correlated to low rates of vaccination.

Based on data released on October 18th, we know that COVID-19 case rates for teens are 8 times greater for those unvaccinated than those vaccinated, and for unvaccinated adults over 50, case rates are five times higher than those for their vaccinated counterparts. Among residents 12 and older, unvaccinated people are 12 to 22 times likelier to be hospitalized than vaccinated residents 12 and older. Death rates are 32 times higher among unvaccinated residents 18 to 49 years old (8 deaths per 100,000 unvaccinated people compared with 0.25 deaths per 100,000 vaccinated people), and 20 times higher among unvaccinated adults over 50 (99 deaths per 100,000 unvaccinated people compared with 5 deaths per 100,000 vaccinated people). These numbers demonstrate the true magnitude of the protection afforded by the vaccines.

Among the more than 5.7 million fully vaccinated people in L.A. County, the Department of Public Health identified 60,689 people fully vaccinated who tested positive for COVID-19 as of October 9. This means that a little over 1% of fully vaccinated people in L.A. County have tested positive. Of those who tested positive, 2,043 were hospitalized, which translates to 0.04% of all fully vaccinated people. There have been 311 deaths among fully vaccinated people, or 0.005% of fully vaccinated people.

There are over 800 vaccination locations across the County open to EVERYONE eligible, regardless of immigration status. It is free and no appointment is required at many locations. You can find a location near you using this link.

Stopping transmission is critical to prevent the development of another variant. We all witnessed the havoc wreaked by the Delta variant over the summer. This is why we are working hand in hand with our partners at the LA County Department of Public Health, to ensure that public spaces are safe for patrons and also employees. It remains imperative that we not let our guard down, and continue to do everything we can to ensure that we're stopping the spread at every opportunity -- for the health of our residents and so our businesses and City can rebound as quickly as possible. This includes masking in indoor public spaces or large events, and requiring vaccination for entry and participation in certain high-risk public spaces and events.

It is important to remember that the City's ordinance has safeguards in place to ensure that those who have a valid exemption are still able to receive services. Businesses can access more information, resources, and support on how to implement this ordinance via the LA County Department of Public Health, or the SafePassLA website.

RE: Critical Flaw in COVID mRNA Vaccine FDA Trial Research Design

Dear Mayor Garcetti and Dr. Barbara Ferrer,

You are hereby official notified of the critical fundamental flaw in the very nature of how your "neutralizing antibody" works. It is this simple. There is no path for your antibody from its starting point (antibody formed in the blood/lymph) through the lung barrier (a.k.a. the "blood lung barrier" or the "alveolar wall"), to its end point, the lung alveolar sac where lung cells are being infected by COVID.

In regards to the size of this mistake, the "lung barrier" can stop the net influx of water molecules from crossing into the lung alveolus. Water molecules are 18 Daltons in weight. COVID neutralizing IgG antibodies are 145,000 Daltons in weight. There is not a single peer reviewed paper on earth that describes an active transport mechanism which can move very large antibodies across this lung barrier. As a reference point, the blood BRAIN barrier typically only allows molecules that are less than 500 Daltons to diffuse across. The blood LUNG barrier is truly a barrier and at the size of IgG antibodies, much less than 1% will be able to cross this barrier by simple diffusion.

This information was given to the CDC months ago. Whatever immunity was granted for this COVID vaccine, it is unlikely that the exact same legal immunity will apply once you have been informed of this gargantuan mistake. As an example, thalidomide was once FDA approved. But, once the pharmaceutical company was aware of the nightmare problems (severe birth defects) then regardless of whether the drug had FDA approval, any further use of the drug was not only immoral but a potential legal quagmire.

Imagine what the public will think. The political/medical/scientific/pharmaceutical leadership were made aware that the antibody had no viable path into the lung where the infections were taking place, YET, the leadership did not STOP the COVID vaccine BUT continued to promote it, EVEN to our children. It is a PR nightmare for you if you don't do the right thing.

No truer words are more apt for this situation than "haste makes waste". Or maybe, "the emperor has no clothes on". Or maybe, "when the shit hits the fan".

There is a reason that we value free speech in this country. You as a politician should know this much better than I do. Censorship has very little place in a democracy, especially when it comes to issues of science and medicine. You aren't always correct when you think you are. Basket of deplorables? All the negative rhetoric towards the unvaccinated? In the history of modern medicine, we were NEVER so callous as we are now with how we treated pregnant women and children. Stop the madness.

Your next step is to talk to your scientists. Do you want to get to the truth? Then use my approach. Have a meeting with three of your top physicians/scientists ASAP. Ask them to define how the COVID vaccine works in a few sentences or less. They will use the words "neutralizing antibody". Then, ask them which cells are the most damaged by COVID (the lung alveolar epithelial cells is the answer). Then ask them, is the paradigm of the "neutralizing antibody" the paradigm under which we got the FDA approval in the COVID vaccine FDA clinical trial (yes, is the answer). Then ask them, how did the antibody cross the blood lung barrier? Ask them if they know the size of the neutralizing antibody. Ask them if they know the molecule size limit for the blood BRAIN barrier. And this is how you'll get to the truth.

Smart people don't want to admit they're wrong. They will start spewing jargon in a way that doesn't make rational sense. They will throw in "it's complex". They will spin. They will say "transudation" (which is code for simple diffusion). They will say, "we don't know exactly how it works, but we don't have to know, it works, our numbers are fantastic". But, then they are "giving up" the neutralizing antibody in the lung and if they don't know how their vaccine works and they don't have a theory, I can provide them one and a very good one but then the COVID vaccine is no longer a vaccine. You see? The Covid Vaccine theory shouldn't be TOP SECRET should it? You yourself thought you understood how it worked, did you not? What I have learned in my year long journey in trying to alert the world to this issue is this. Humans are very good at "group think" and very poor at critical analysis. That doesn't mean I don't care about humans. And my life is at risk by doing this, I know. But, I didn't study my brains out during medical school to just suck out cataracts. I didn't study biochemistry and memorize every molecule in the Krebs cycle just to make a 100% on the final. I studied like crazy and scored 97 percentile on my boards because the biological sciences are my religion. I gave up religion for the religion of science and just realized this past year that humans so very much love their comfort zone. Change is hard. But, guess what? In this religion that is science, this particular brand of religion happens to be progressive. So, if you want to be a good scientist, guess what? You better get used to change.

I do expect a reply ASAP. It so happens that the "anti-vaxxers" were correct on this issue and I know that's a hard pill to swallow. But, it is reality. All those city employees that lose their jobs because they didn't follow your vaccine mandate will NOW have recourse, because when they file a lawsuit against the city of LA, you will have to disclose that you received this information and yet still felt (illogically, I might add) that a COVID vaccine mandate was necessary.
