Dear Mrs. Jackie Goldbert (all my emails will be available on my website, so you can't avoid accountability),

I'm certain you will understand the grave implications of the following sentence. The COVID vaccine theory is based on production of a neutralizing antibody that binds the COVID virus before the virus can infect lung cells. Well, that means the antibody actually has to be present in the lung.
