Dear Dr. Francis Collins,

The COVID vaccine has a fatal flaw. The COVID vaccine results in a neutralizing antibody formed in the blood after a COVID vaccine intramuscular injection. The theory is that the antibody binds a COVID virus in the lung before the virus can infect lung cells. The problem. The blood lung barrier surrounding each lung alveoli can stop the net influx of water molecules from crossing into the lung alveolus. Water molecules are 18 Daltons in size. COVID antibodies formed in the blood after a COVID vaccine weigh 145,000 Daltons. There is NOT a single peer reviewed paper on earth that describes an active transport mechanism to move these gargantuan COVID antibodies across the blood lung barrier into the lung alveoli where COVID is infecting lung alveolar cells. Dear Dr. Krauss and California Medical Board Members.

Again, I'm a lasik surgeon in LA with 80,000 cases under my belt and I did my fellowship in refractive surgery under Dr. Peter McDonnell, who is currently the director of Ophtho at Wilmer. Dr. McDonnell has had a dozen discussions with me about my findings over this past year, most recently just a week or so ago. I explain that because this is such serious information, you should know the gravity of the situation and not ignore this issue.

As I explained on the phone, I have sent the California Medical Board all this information a couple of months ago because other ophthalmologists who are clearly NOT open-minded, want to accuse me of "spreading misinformation", because my questions happen to expose the fatal flaw of the COVID vaccine paradigm.

This is the single biggest mistake in the history of medicine. The COVID vaccine is thought to work because of creation of a neutralizing antibody that then binds COVID virus before the virus can infect a lung cell. The gargantuan mistake is that no one vetted HOW this very large antibody (145,000 Daltons) crosses the blood lung barrier, when this blood lung barrier is tight enough to PREVENT the net influx of water molecules (only 18 Daltons in size).

How the COVID vaccine "works" is critical. It appears that another huge mistake was made by Dr. Baden, the first COVID mRNA vaccine FDA clinical trial author, in that a proper control was not included in the original study. The COVID vaccine clearly induces a "neutralizing antibody" but ALSO muscle-aches/fevers because the vaccine also induces interferon production. The side effect of innate immune activation (well known for mRNA vaccines) was NOT properly controlled for in the study. Simply comparing the COVID vaccine with a FLU vaccine control would have been extremely

insightful. Again, all the evidence points to the COVID vaccine "working" because of interferon production, which means it will be very short-lived.

Again, it does NOT appear that my asking questions regarding the fundamental nature of how the COVID vaccine works is misinformation of any sort. My questions are shedding light on the truth of the real situation. The COVID vaccine appears to NOT be a vaccine. It appears to be a "medicine" and in the history of "medicine", when do we "mandate" a medicine when the patient doesn't have the "illness"?

At the very least, you do NOT have to agree with my conclusions. You must realize that this is a matter of utmost medical importance, when the medical and political leadership are making decisions regarding the COVID vaccine and the very nature of how the COVID vaccine works is called into serious question. But, you MUST alert the medical and political leadership of these grave concerns and it is the medical/political leadership's responsibility to ask the scientists who are making the vaccines and who are authoring the published papers on this COVID vaccine if they know of these concerns and what their scientific response is. Also, I know more about this issue than anyone I have talked to, so it would be most appropriate to set up these meetings with me present in the meeting.

Children 5-11 are being mandated to receive a COVID vaccine that has a fatal flaw in the very nature of how the COVID vaccine works. If the California Medical Board does NOT help in conveying this information to the rest of the state and federal medical/political leadership, then isn't the lack of action only assisting the "spread of misinformation"? Doesn't it currently appear that the COVID vaccine paradigm is the "misinformation"?

In January of 2020, no one in the US had a COVID antibody. 20 million or so Americans were infected with COVID last year. Each one of those patients had NO COVID antibody for at least 14 days. But, the majority healed in 7 days. The COVID antibody was NOT instrumental in helping 18 million Americans heal last year. To have helped a single patient, the antibody would have needed a time machine. When the antibody finally arrives, it needs a "teleporter" to get inside the lung. So, what is the science fiction here? The COVID vaccine is the science fiction and the MISINFORMATION.

Science does NOT flourish when questions can't be asked. This "cancel culture" is the most ridiculous thing I have ever seen.

One of your board members, David Ryu, was given all this information months ago. I cannot believe that a person with that little knowledge (medical and general), and that little interest in truth, is on a medical board that "oversees" my license. That is one of the most ridiculous things that I have ever seen in my life and I recommend that at least someone with a medical background occupy a board seat. How does this ridiculousness occur.

Again, the California Medical Board should do the right thing and move this issue up as quickly as possible, to halt the atrocities being committed against our children.

I suspect the reason why David Ryu, a democrat, did not want to keep an open mind to all my concerns is because the COVID vaccine mandate will eventually result in the loss of jobs for millions of Americans in the public and private sector AND by far the majority of those unvaccinated are Republicans. Yes, I see the thirst for blood among the Democrats, but resisting the truth will only let the Democrats look more vindictive and small-minded later, when all this comes out.

This information was sent to the NIH, many CDC directors, many FDA directors.

This is the single largest mistake in the history of modern medicine. Mr. Felderbaum (FDA Media Director) was notified and to be certain that the FDA does the correct thing, I am informing all members of the FDA legal counsel team of this issue also.

There are only two questions that expose the bizarre nature of this medical mistake. Any layman can see the bizarre nature of the poor logic.

- 1. Do you believe the COVID vaccine "works" because of a neutralizing antibody in the lung alveolus that binds Covid viruses, preventing them from infecting lung alveolar cells?
- 2. Then, how did this very large 150,000 Dalton COVID IgG antibody cross the blood lung barrier (aka the alveolar wall) into the lung alveolus? This lung alveolar wall can impede the net movement of WATER molecules that are only 18 Daltons in weight, from filling our lung alveoli.

Why would a molecule (the COVID IgG antibody) which is 8000 times larger than a water molecule be able to cross this alveolar wall? There is not a single peer reviewed paper on earth that describes an active transport mechanism that can move IgG antibodies from the capillary (we all agree that IgG antibodies are created in the blood/lymph), across the lung alveolar wall (which can impede the net influx of tiny water molecules), into the lung alveolar sac, where the infections are taking place. Iol. yes, you've heard of the "emperor's new clothes"? This is the modern version of that, except a million times worse.

It's incredible. The gargantuan size of the mistake. As an aside, the blood BRAIN barrier typically has a size limit for molecules that can passively diffuse through it of no greater than 500 Daltons. But, do you really believe that the blood LUNG barrier must allow a 150,000 Dalton IgG molecule to simply diffuse across it?

Would the FDA ever approve a medication or vaccine that doesn't have a valid hypothesis? The COVID vaccine has NO hypothesis right now. There is NOT a single peer reviewed publication on earth, that describes an active transport system which can "teleport" very large IgG covid antibodies from the blood THROUGH the blood lung barrier, into the lung alveolus where the lung alveolar epithelial cells are being infected.

Q1. Can I lose my license if my peers file a complaint with the medical Board of California?

A1. The Medical Board of California's mission is consumer protection and one of the ways it accomplishes this mission is through the enforcement of the Medical Practice Act, and other laws, that pertain to the practice of medicine in California. Publicly spreading false COVID-19 information may be considered unprofessional conduct and could be grounds for disciplinary action. The Board will review complaints it receives about its licensees on this topic, as it does with all complaints. To date, no accusation has been filed against a licensee regarding this issue. The Board is unable to provide further information regarding its complaints and investigations as they are both confidential by law.
