

LIMITED REGISTRATION (PET) CONTRACT

Charlotte & Co. Miniature Poodles, the breeder of the said puppy described below, enters into an agreement for the purchase of a puppy with _____, hereafter “buyer”, for the purpose of transferring ownership of the puppy.

REGISTRATION & UNAUTHORIZED BREEDING

The puppy is a purebred miniature poodle registerable with the American Kennel Club and is being sold solely as a companion with limited registration. Breeding is expressly prohibited and if puppies are produced, such offspring will not be eligible for AKC registration. The Breeder agrees to provide the buyer with all AKC limited registration paperwork.

Buyer agrees that the dog will be spayed/neutered no later than one year of age by a licensed veterinarian and to provide proof as such to the breeder. Spay/Neuter proof must include the dogs microchip number. If buyer does not provide proof by 13 months of age, they must pay a fee of \$5000 or return the dog with no refund.

INITIAL WELLNESS GUARANTEE

The puppy was previously examined and vaccinated by a licensed veterinarian and was found to be in good health within 48 hours of transfer to buyer. Buyer will receive the puppy’s vaccination record with the registration paperwork at time of transfer. The Buyer, at their own expense, must provide the breeder proof that the puppy was examined by a licensed veterinarian within 48 hours of receiving the puppy for any part of the health guarantee to be valid. There should be no vaccines given at this first visit. The Breeder has ensured the puppy received all required age-appropriate vaccines prior to the transfer as recorded in the supplied vaccination record. We recommend scheduling this appointment before the transfer to ensure the timeframe is met. If it is found that the puppy is unhealthy, the buyer must provide a written statement from the veterinarian deeming the puppy “unfit for purchase” within the 48-hour timeframe. The breeder shall not be responsible for any medical expenses incurred.

The Breeder has implemented preventative measures to protect the dog against parasites and infections.

ONE YEAR HEALTH GUARANTEE

Breeder provides a one-year warranty from the dog’s date of birth against any debilitating congenital conditions. These conditions include breed relevant such as GM2 Gangliosidosis (HEXB, Poodle Variant), Neonatal Encephalopathy with Seizures NEWS (ATF2), Osteochondrodysplasia (SLC13A1, Poodle Variant), Progressive Retinal Atrophy prcd (PRCD Exon 1), Progressive Rod-Cone Degeneration, Von Willebrand Disease Type I Type I vWD (VWF), Severe Patellar Luxation requiring surgical intervention, and Hip Dysplasia. or that incur injury to bones or joints from over exercise, trauma, or may have an environmental link are excluded. In the event the dog exhibits symptoms of a suspected debilitating congenital condition, the buyer must inform the breeder within seven days of diagnosis and supply any requested veterinary records. The buyer must show proof of healthy weight by having their veterinarian evaluate the dog's body condition score at all veterinary visits. Failure to follow the medical advice and/or treatment instructions of a veterinarian or the breeder will void this guarantee. The Breeder will be given the opportunity to take the dog to a licensed veterinarian of their choice for further examination. If the dog dies, and the Buyer suspects a genetic or other condition guaranteed within this Agreement, the Buyer must have a necropsy performed by a licensed veterinarian at the Buyer's expense. The Buyer must include copies of diagnosis and all treatment documentation to the Breeder. The Breeder reserves the right to request a second opinion from a veterinarian of their choice in the local area of the Buyer or via phone consult with a veterinarian in any location and grants permission to the Breeder and the Breeder's veterinarian to consult with all professionals treating the dog. Should any travel or shipping fees become necessary, those costs shall be borne by the Buyer. The Breeder is not responsible for any veterinarian bills after initial purchase/transfer unless previously agreed to in writing.

RETURNS/REFUNDS

If it is determined by a licensed veterinarian that the puppy was "unfit for purchase" or has a genetic disorder that is identified within the warranty periods described above, the buyer may return the puppy for (A) replacement puppy with one of equal value as soon as one becomes available or (B) a refund. Both of which are at the sole discretion of the breeder and will only be considered after the puppy and all papers have been returned and transferred to the breeder. Please note, the Breeder will do their best to replace the puppy with one that is as close to the original puppy's size and color as they can but cannot guarantee such. Buyer is responsible for providing all transportation with related costs to get the puppy back to the breeder. If the puppy is euthanized, a written letter from a licensed veterinarian must be provided and contain reason/diagnosis, microchip number, and date. The Buyer understands that the puppy will only be replaced, or money refunded, if health problems are life threatening and are attributed solely to a hereditary problem and are not due to accident or injury.

NO OTHER WARRANTIES

The puppy is sold, delivered, and transferred in an "as is" condition except as expressly and specifically set forth herein.

LIFELONG CARE & INABILITY TO KEEP THE DOG

The Buyer understands that a dog is a long-term commitment. Buyer agrees to provide adequate exercise, food, and shelter for the dog. They must also provide all necessary health care by a licensed veterinarian, including vaccinations. If at any time the Buyer is unable to keep the dog, it may be returned to the breeder (for no refund or replacement) to be rehomed.
