Frequently Asked Questions

How did your cemetery begin and who operates it?

My ex-wife and I were talking one night about what the other should do if something happened to one of us. After doing our research on cemeteries, we decided we wanted to be buried naturally on our family farm. The more we learned about the laws, the more we realized that people should be given the opportunity to have a simple burial. We worked to develop a green burial cemetery and officially opened on September 1, 2009. The cemetery is on my beautiful, family farm land and is paid for and double-zoned as a cemetery and nature reserve with an additional green burial deed restriction. My mom (Julia Bishop), my oldest son (Luke Bishop), my assistant (Holly Randolph), and myself (Michael Bishop), share the duties of running the business.

Where is Dust To Dust Cemetery?

We are located in Swansea, SC, approximately 20 miles south of Columbia. From Highway 321, take Highway 6 towards Pelion for 2 miles and turn left on Nulty Crossing. Look for the first gate on the left into the pasture. The cemetery is on the back side of the property. Please contact us to make an appointment to visit the site, as it is private property.

What is the cost comparison of a Dust to Dust burial vs. a traditional one?

We offer a \$1000 plot which includes opening/closing costs. Local transport is available for \$200 or less. Basic biodegradable caskets can be purchased locally, starting at \$300.

Dust to Dust:

\$1000 for an 8x10 plot

Explain the term “green burial”...

In a green burial, there is no concrete, steel or formaldehyde allowed. Because the land is “deed restricted,” it can only be used as a green burial cemetery. The land being zoned as a “nature reserve,” means it is set aside for eternity and protected. Dust to Dust is not a perpetual care cemetery. It is natural land, previously used as a farm. Biodegradable shrouds and caskets are allowed, as well as headstones of natural material.

Why choose a green burial?

It is a natural way to be laid to rest and it benefits the environment. Green burial is less expensive than a modern burial, and that keeps money in your family's pocket!

What if I want to be buried at Dust to Dust, but my family wants to hire a funeral director to run the service?

If your family chooses to use a funeral director, make sure they are aware that we do not allow embalmed bodies. Also, make sure they understand that only a biodegradable casket may be used. By law, you can purchase a casket from another source or build a casket yourself. The funeral home must allow you to do so and not charge you any type of fee associated with this. Your family will need to let the funeral director know where you plan to be buried. They can contact us and we will make burial arrangements with them. If your family hires a funeral director, the funeral director will be responsible for filing the death certificate.

What if my family chooses to handle the arrangements themselves and not use a funeral director?

1. A Burial-Removal-Transit Form (BRT), which allows the body to be transported by the person you designate, will be issued. You may want to contact your county coroner in advance if you have any questions about this process.
2. Next your family will need to contact the transporter of the body or they can transport the body themselves. The transporter and the cemetery will coordinate the burial plans along with the family.
3. Your family will need to decide whether or not to purchase a biodegradable casket or shroud.
4. Newspapers will need to be contacted to have an obituary printed, if desired. Your family will need to contact us regarding this, as deaths must be verified before obituaries can be printed. We recommend emailing us the obituary, as well as any pictures you would like to include, to be posted on our Facebook page at no cost.
5. Your family will need to submit a signed Dust to Dust Contract along with full payment, prior to the burial.
6. DHEC will need to be contacted to file a death certificate. This must be done within 5 days of the death. It costs \$12.00 for the first copy and \$3 for each additional copy. We also provide you with the "Non-Funeral Home Worksheet" form provided by DHEC. This, along with the BRT, will be taken at DHEC to file for the death certificate.
7. And finally, your family will need to decide the day and time of the burial. They will need to discuss whether to have a grave-side, family or church-led service, or simply a burial with a memorial to follow somewhere else. These are things you may want to discuss with your family ahead of time.

Can my pet be buried at Dust to Dust?

If you have already purchased a regular 8'x10' plot from us, your dog, cat or other small animal can be buried at Dust to Dust at no further cost to you. Plots (for owners who have not purchased a plot with us) can be purchased for your dog or cat for \$300 for a 5'x8' plot.

Is Financing Available?

Financing is available with us for as low as \$20.00 per month. If you would like to finance with us, you will need to include \$20.00 with your Dust to Dust Contract and then \$20.00 will be due by the same date each month for 49 additional months. Checks should be sent to Dust to Dust, PO Box 277, Swansea, SC 29160. Balance must be paid in full prior to using plot. Should account become 90 days late, contract is void and reimbursements will not be given. Dust to Dust will send quarterly statements showing your balance.

How can I get a Dust to Dust T-Shirt?

Once you have purchased a plot from us or made your first payment to us, we will send you your very own Dust to Dust T-shirt if requested. You will be able to proudly display your choice for your final resting. We will need to know your shirt size and the color of shirt you desire.

Rules and Regulations (effective January 1, 2020)

1. No vaults are allowed.
2. Purchase of headstone / marker is the responsibility of the purchaser. Cost of the headstone / marker is not included in the price listed on the contract.
3. Marker type and content must be approved by cemetery prior to installing. Marker may not exceed 2'x3' and must be installed flush with the ground. No vertical headstones are allowed. No concrete, paint, polished rock, or metal.
4. Plots may not be decorated with any materials that are plastic, concrete, ceramic, tile, painted, stained, polished, metal, cut lumber, etc. All items used must be in a natural state except for engraved marker. **Any items placed on plots which do not meet these rules will be removed and thrown away without notice.**
5. Any item placed on a plot may not exceed 12" in height, excluding living plants. Any item taller than 12" must be approved by the cemetery.
6. Only biodegradable caskets may be used. Caskets are not required.
7. Visitation is by appointment only. Please call / text (803) 920-4074 to schedule an appointment.
8. This is not a perpetual care cemetery and no guarantees are made as to the maintenance of this property.
9. No bodies will be accepted which have been embalmed with toxic chemicals, like formaldehyde.
10. Cemetery must be notified 8 hours prior to burial to ensure ample time to open plot.
11. Plots are designated by the cemetery for burial. Purchaser does not get to pick his/her plot. If purchaser has more than one plot, adjacent plots will be reserved upon burial for other deed holders.
12. Plants may be used on plots but must be approved prior to planting by the cemetery to ensure the plants are noninvasive.
13. Purchase of plot secures the right to be buried within a plot. This does not give ownership of the land.
14. Cemetery will not buy back plots. Owner has the right to resell their plot. There is a \$50 transfer fee to redo the paperwork.
15. Cemetery will not be held responsible for stolen property, vandalism, or acts of God.
16. The cemetery is part of a working farm. It is understood by the purchaser that animals, both wild and domesticated, may be present at times on the land.
17. If you choose to make monthly payments with Dust to Dust:
Balance will be paid in installments beginning with \$20 minimum included with this contract and \$20 minimum will be due by the same date until balance is paid in full. Checks will be sent to Dust to Dust, P.O. Box 277, Swansea, SC 29160. Balance must be paid in full prior to using plot. Cemetery will send quarterly statements showing balance. Should account become 90 days late, contract is void and reimbursements will not be given. Any charges upon cemetery resulting from insufficient funds will be reimbursed by purchaser.
