**Problem**: NOVA council is attempting to utilize email to notify our members of upcoming Council events, making additional funds available to help support our adopted ships and units rather than printing and mailing costs. This also will help us serve you better. Unfortunately we have encountered a problem. Out of approximately 1,300 members we have only about 900 members with email addresses listed. An email notification of a recent meeting to these 900 email addresses resulted in rejections for more than 190 members with invalid addresses. Overall, this lack of valid email addresses for 590 members translates into more than \$300 in printing, handling and postage costs each time which could be used for adopted units and ships if we could use email notification

<u>Solution</u>: We are asking for your help is solving this problem. We urge you to keep your contact information, including your U.S. Postal address, telephone numbers, and Email address updated via email to <u>service@navyleague.org</u> with a copy to <u>NOVANLUS@aol.com</u>. Please include your name and NLUS membership number. This will enable the NLUS Headquarters Membership Department to update the master membership data base. This will in turn help us get information to you more efficiently and at lower cost. The savings can be used to increase funding to support our adopted ships and units. - John Camp

## A letter from the Executive Officer of the USS VIRGINIA (SSN 774) to the Northern Virginia Council

"The VIRGINIA had an amazing year in 2005. It was a year full of accomplishments, not the least of which was completion of a 3 month deployment. On behalf of the crew, I want to thank you for the tremendous support that the Northern Virginia Council of the Navy League has shown VIRGINIA. We are presently in a period of shipyard time. In early January we completed all post-delivery shakedown operations and started a Post Shakedown Availability here in Electric Boat. The crew responded well to the operational in 2005 and we only wish we could have more time at sea instead of shipyards. However, we know that we will be coming out even stronger. Of note, I hope you had a chance to see VIRGINIA featured in the National Geographic show Mega Machines. Their film crew was onboard for a few days in port in April 2005. In fact, they got so much out of it that we had another National Geographic film crew embarked for several days underway in November 2005. We have not been told when that show will air, but I will be sure to send you a notice when we do. Thanks again for all you do in support of the Navy and particularly VIRGINIA."



## Other News from the Convention

Navy League of the United States Northern Virginia (NOVA) Council members were among more than 352 Navy League members from around the world who attended the non-profit organization's 104th annual convention in St. Thomas, U.S. Virgin Islands July 12-16. The following members of NOVA Council were listed on the roster of attendees: John Camp, Shirley Camp, Earl Hailston, William Hodges, Jane Kriser, Ron Montgomery, Becky Offutt, James Offutt and Mary Tozzi.

U.S. Virgin Islands Governor Charles W. Turnbull officially kicked-off the four-day convention when he welcomed the group for the first time to St. Thomas at the opening ceremony.

One of the highlights of the convention was the presentation of more than 20 awards to Navy, Marine Corps, Coast Guard and Merchant Marine military and civilian personnel for outstanding service, particularly while serving in Operation Iraqi Freedom in support of the global war on terror. Admiral John B. Nathman, USN, the four-star admiral who heads the U.S. Fleet Forces Command in Norfolk, Virginia and also oversees the Navy's training and operations in the Caribbean region, was guest speaker for the awards presentation. NOVA Council members and the other Navy League members also had the opportunity to meet crew members and tour the Coast Guard Reliance Class Cutter VIGILANT (WMEC- 617), home ported at Patrick Air Force Base, FL and one of the Navy's amphibious dock landing ships, USS CARTER HALL (LSD-50) home ported in Norfolk, VA. Both ships made port visits to St. Thomas during the convention. Also in attendance was the newly sworn-in Commandant of the Coast Guard Admiral Thad Allen, USCG. Admiral Allen took part in the presentation of the awards and was the keynote speaker at the convention's closing dinner. He was formerly Coast Guard's chief of staff and principal federal officer for the recovery operations in the aftermath of Hurricane Katrina.

Jim Offutt was appointed Chairman, 2006-2007 Maritime Policy Committee. Stewart Reuter was elected National Capitol Area President for 2006-2007. The following NOVA council members were elected Navy League National Directors for 2006-2007: John R. Camp, Nancy F. Gorell, James H. Offutt, and Stewart E. Reuter.

The invitation of the Palm Springs, CA Council to host the 2007 National Convention in Palm Springs was accepted. A date in October-November 2007 is to be determined.

## June 14, 2006 NOVA Council Meeting Highlights

The Navy League of the United States Northern Virginia (NOVA) Council held a general membership meeting on Wednesday, June 14, 2006 at Listrani's Restaurant, 2317 Wilson Boulevard, Arlington, VA. The following members and guests attended: RADM David Architzel, USN (Guest Speaker), John Camp, Darren Cubell, Chuck Davis, Suzie Davis, Phil Faye, David Field, Amy Gorell, Fred Gorell, Nancy Gorell, Rick Macard, Jim Offutt, Stewart Reuter, Michael Rice, John Rodgaard, John Stewart, CAPT Michael Swartz, USN (also a Guest Speaker), Duane Wills and Charles Wright.

Following a brief social time, Council President Nancy Gorell called the meeting to order at 7:00 p.m. She reported that contacts with our adopted ships and units are going well and that she has been in contact with USS Alexandria, which is deployed. Nancy announced the appointment of two new NOVA Council Directors: Duane Wills, Director (IT and Web Site) and Mary Tozzi, Director (U. S. Coast Guard Liaison).

Stewart Reuter, Treasurer, presented the Treasurer's report which reflected a balance of \$22,505.46 in the council's account. Jim Offutt, Vice President (Programs) introduced Rear Admiral David Architzel, USN Program Executive Officer, Aircraft Carriers and Captain Michael A. Swartz, USN, Program Manager, Aircraft Carriers.

RADM Architzel presented an outstanding briefing on the status and the future of the Navy's Aircraft Carrier program. Admiral Architzel pointed out that the life span of carriers is 50 years and that the final commanding officer of USS George H. W. Bush (CVN-77), which is under construction, has not yet been born. Discussion covered the new CVN-21 class and CVN-78 scheduled to join the fleet in 2015. New technology includes electric catapults. Captain Swartz participated in an extensive question and answer session.
