8. All PERSONAL tents over 10 X 10 must have a Certificate of Flame Resistance in order to obtain a tent permit. _____
9. Please furnish a copy of your insurance information if you sell food products (Naming Sarasota County Agricultural Fair Association Inc. as additional insured) and you're working permit with your signed contract. _____
10. Vendors prohibited bringing any kind of alcohol to the festival area. You could be dismissed if we find alcohol in you tent. _____
