- 2 All tables must be covered to the floor on all sides visible to the public. \_\_\_\_\_
3. Vendors are prohibited from early dismantle (no boxes/equipment brought in or out), and no preparations are allowed before the close of the festival at 8:00 PM on Sunday, Nov 9th. . \_\_\_\_\_
4. Smoking is not allowed in tents or vendor areas. \_\_\_\_\_
5. Vendors are responsible for paying Florida Sales Taxes. \_\_\_\_\_
6. Upon arrival, check in at the Information Booth. Space numbers are subject to change. You must be completely set up by 10:30 AM on Saturday, Nov 8<sup>th</sup> . . \_\_\_\_\_
7. Vendors are prohibited from displaying or selling any objectionable materials or items (i.e., sexually explicit materials or signage, etc.) \_\_\_\_\_
8. All PERSONAL tents over 10 X 10 must have a Certificate of Flame Resistance in order to obtain a tent permit. \_\_\_\_\_
9. Please furnish a copy of your insurance information if you sell food products (Naming Sarasota County Agricultural Fair Association Inc. as additional insured) and you're working permit with your signed contract. \_\_\_\_\_
10. Vendors prohibited bringing any kind of alcohol to the festival area. You could be dismissed if we find alcohol in you tent. \_\_\_\_\_
