2	All tables must be covered to the floor on all sides visible to the public.
3.	Vendors are prohibited from early dismantle (no boxes/equipment brought in or out), and no preparations are allowed before the close of the Festival at 8:00 PM on Sunday, Nov 9th.
4.	Smoking is not allowed in the tents or vendor areas.
5.	Vendors are responsible for paying Florida Sales Taxes.
6.	Upon arrival, check in at the Information Booth. Space numbers are subject to change. You must be completely set up by 10:00 AM on Saturday, Nov 8th.
7.	Vendors are prohibited from displaying or selling any objectionable materials or items (i.e., sexually explicit materials or signage, etc.)
8.	All PERSONAL tents over 10 X 10 must have a Certificate of Flame Resistance in order to obtain a tent permit.
9.	Please furnish a copy of your insurance information if you sell food products (Naming Sarasota County Agricultural Fair Association Inc. as additional insured) and you're working permit with your signed contract.
10.	Vendors prohibited bringing any kind of alcohol to the festival area. You could be dismissed if we find alcohol in you tent.
